Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Barry University 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended then ended, and the related notes to the financial statements ("2024 Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of Barry University 401(k) Plan's 2024 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the 2024 Financial Statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying 2024 Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Barry University 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the 2024 Financial Statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the 2024 Financial Statements.

In preparing the 2024 Financial Statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Barry University 401(k) Plan’s ability to continue as a going concern for at least one year following the date that the 2024 Financial Statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the 2024 Financial Statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the 2024 Financial Statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 Financial Statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the 2024 Financial Statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the 2024 Financial Statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the 2024 Financial Statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2024 Financial Statements or to the 2024 Financial Statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

The 2023 financial statements of the Plan were audited by Marcum LLP. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 4, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule related to assets held at year end, other than the information in the 2023 supplemental schedule related to assets held at year end that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held at year end held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the Barry University 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2012, and its Plan Document was restated on July 26, 2022. The Plan covers all employees of Barry University, Inc. (the "University", “Plan Sponsor”, or “Employer”), excluding i) full-time students/employees, ii) adjunct faculty members, iii) work-study students, iv) part time, temporary or seasonal employees, v) leased employees and vi) union employees whose employment is governed by a collective bargaining agreement. In order to participate in the Plan, an eligible employee must have completed 30 days of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan administrator and the Retirement Plan Committee are responsible for oversight of the Plan and collectively determine the appropriateness of the Plan's investment offerings and monitor investment performance.

The Employer has appointed two insurance companies, Teachers Insurance and Annuity Association of America and College Retirement Equity Fund (“TIAA-CREF”) and The Variable Annuity Life Insurance Company (“VALIC”) (collectively, the “Insurance Companies” or "Custodians") to hold custody of the Plan assets. VALIC and its subsidiaries are all members of Corebridge Financial, Inc. (“Corebridge Financial”), which is part of the VALIC Trust Company Inc. and Corebridge Retirement Services, which provides the certifications to the Plan.

Effective December 29, 2022, the Setting Every Community Up for Retirement Enhancement (“SECURE”) 2.0 Act of 2022 was signed into law. The Act is inclusive of approximately 90 provisions which offer many new benefits to employers and Plan participants. Certain provision changes are related to the following, but not limited to: changes to auto-enrollment and auto-escalation, age of required minimum distribution, catchup contributions, and increased dollar threshold for mandatory distributions. Depending on the specific provision, some will take effect immediately, while others begin in a future year. Subsequently, during 2024, the Plan adopted certain provisions of SECURE 2.0 and is in the process of formally amending the Plan Document.

Contributions

Each year, participants may contribute up to 100 percent of their eligible annual compensation, as defined in the Plan Document, up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions (\$7,500 in 2024). Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollovers").

The Employer will make a safe harbor matching contribution equal to 100% of a participant's eligible salary deferrals up to 3% of the participant's eligible compensation, plus an additional 50% of each participant's eligible salary deferrals between 3% and 5% of the participant's eligible compensation. Participants are eligible to receive safe harbor matching contributions immediately upon entering the Plan. The Employer may also make additional discretionary contributions (profit-sharing and matching) to the Plan, subject to eligibility requirements as defined by the Plan Document. Participants must complete one consecutive year of service with the Employer before being eligible to receive additional discretionary contributions (profit-sharing and matching) that are made by the Employer. The Plan requires a participant to be employed as of year end to be eligible to receive discretionary Employer contributions.

For the year ended December 31, 2024, the Employer made safe harbor matching contributions of approximately \$1,796,000. For the year ended December 31, 2023, the Employer did not make any additional discretionary contributions to the Plan.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participants direct the investment of their contributions into various investment options offered by the Plan. Employer contributions are invested in accordance with the respective employee's investment allocation elections. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, Rollovers into the Plan, allocation of the Employer's safe harbor matching contributions, allocation of Employer' discretionary contributions (profit-sharing and matching), if any, and the Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, Rollovers, plus actual earnings thereon. Employer safe harbor contributions are 100% vested for all participants, regardless of employment date. Vesting in the Employer's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 25 percent vested after two years of credited service and continues to vest in increments of 25 percent until 100 percent vested after 5 years of credited service.

Upon termination of employment, a participant's non-vested amounts are forfeited in accordance with the Plan Document. Upon death, total disability, or early retirement, participants become 100% vested in their Employer discretionary contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is fixed for the duration of the loan. The Plan administrator will determine a reasonable rate by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid directly to the Custodians. Terms range from 1 to 5 years or greater for the purchase of a primary residence. Upon termination of employment, participants can continue their repayment plan. If a loan is not repaid within a reasonable time following termination, it will be offset against the participant's vested balance.

As of December 31, 2024, approximately \$91,000 in outstanding notes receivable from participants have defaulted, which are included in notes receivable from participants in the accompanying Statements of Net Assets Available for Benefits. For financial statement presentation purposes, an outstanding defaulted note balance is considered a deemed distribution when a participant misses a loan payment (other than leave of absence) and fails to remit past due amounts by a specified date, or the term for repaying a loan expires without full payment.

Plan Loans

Under the terms of the Plan Document, participants may enter into a loan agreement directly with TIAA-CREF or VALIC. The Plan Document defines these types of transactions as Plan Loans or Policy Loans (collectively, "Plan Loans"). Plan Loans are issued directly from the Insurance Companies and not directly from a participant's account. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50 percent of their pre-tax and post-tax contributions, or (b) \$50,000 reduced by the participants highest outstanding loan balance in the previous twelve months. Plan Loans must have a definite repayment period not to exceed five years, or up to ten years if for the purchase of a primary residence. The Plan Loans are collateralized by a portion

of the balance in the individual participant's account and bear a rate of interest based on 1% above the prime rate (ranging from 1% to 4.65% on outstanding balances as of December 31, 2024) and are held in specific funds with each respective insurance company.

Plan Loans collateralized by the respective participant balances were approximately \$99,000 and \$131,000 for 2024 and 2023, respectively. Because the Plan Loan relationship is directly with TIAA-CREF or VALIC, and the participant, Plan Loans are not considered to be a note receivable of the Plan and are excluded from the accompanying financial statements. However, the Plan Loan collateral and non-distributable defaulted loans are considered Plan assets and therefore are included as investments in the accompanying Statements of Net Assets Available for Benefits.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan Document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The minimum distributions age from when distribution must begin is 73.

Hardship Withdrawals

Under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. During the year ended December 31, 2024, there were approximately \$63,000 in hardship distributions, which are included in benefits paid to participants in the accompanying Statement of Changes in Net Assets Available for Benefits.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,688 and \$3,968, respectively. These accounts will be used to reduce future Employer contributions or to pay Plan administrative expenses. During 2024, Employer contributions were reduced by \$3,966, from forfeited nonvested accounts, in accordance with Plan provisions.

Plan Service Credit

Certain investment options have a service credit feature and a revenue credit account ("Plan Service Credit Account"). The service credits earned by the Plan during the year ended December 31, 2024 were approximately \$32,000. The Plan utilizes these credits to reduce administrative expenses of the Plan. During the year ended December 31, 2024, service credits of approximately \$30,000 were used to reduce administrative expenses of the Plan. As of December 31, 2024 and 2023, there was approximately \$2,000 and \$800, respectively, in the Plan Service Credit Account.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee and Plan administrator determine the Plan's valuation policies utilizing information provided by the investment advisers and Plan Custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 9, 2025, the date the 2024 Financial Statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "*Fair Value Measurement*", are described as follows:

Level 1 – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued based upon the unit values of such pooled accounts held by the Plan at year end. Unit values are based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means, although are not based upon quoted market prices in an active market. The underlying investments of the pooled separate accounts consist of mutual funds, each of which follows a separate investment strategy. Due to the nature of these pooled accounts, there are no unfunded commitments or redemption restrictions.

Common-collective trusts: Valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of the collective trust fund. The underlying assets are valued based on the NAV as provided by the investment account manager. The NAV is used as a practical expedient to estimate fair value.

Non-fully benefit-responsive guaranteed investment companies contracts ("GICs"): The insurance company general account consists of the TIAA Traditional Annuity non benefit-responsive account. The value equals the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals. The TIAA Traditional Annuity non benefit-responsive account is a fixed rate annuity contract that is fully and unconditionally guaranteed. The investment provides a guarantee of principal, a guaranteed minimum rate of interest between 1% and 3% and the potential for additional interest, if declared by TIAA. This account is valued as a Level 3 asset.

Fully benefit-responsive GIC's: Fully benefit-responsive investment contracts as defined by the FASB ASC Master Glossary, are limited to direct investments between the Plan and the issuer. Plans may indirectly hold fully benefit-responsive investment contracts through beneficial ownership of CCTs (which own investment contracts). When these types of securities hold fully benefit-responsive investment contracts, the Plan's investment in the security are not considered fully benefit-responsive investment contracts, and are required be reported at fair value. The Fully Benefit-Responsive GIC's offered in the Plans investment portfolio are not held through a direct contract between the Plan and the issuer. Such investments are valued on the basis of the relative interest of each participating investor in the fair value of the underlying assets of the collective trust fund. The underlying assets are valued based on the NAV as provided by the investment account manager. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Employer contributions. Additionally, charges may be applied against the value of the Plan if the Plan is liquidated.

7. Tax Status

The Plan adopted a pre-approved plan offered by Gunster Yoakley & Stewart PA. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, stating that the Plan and related trust, as then designed, were in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.
