We have performed audits of the financial statements of Novares US Engine Components, Inc. 401k Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

General

The following description of the Novares US Engine Components, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a Safe Harbor defined-contribution plan covering all employees of Novares US Engine Components, Inc. (the Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Company is the plan sponsor. Fidelity Management Trust Company (the Trustee) serves as the trustee and third-party administrator of the Plan. All investments are self-directed by Plan participants. The Plan was established on June 1, 1989, and amended and restated effective October 27, 2021.

Eligibility

Active employees who are age 19 or older become eligible to enter the Plan on the first day of the month following their month of hire. On the date an employee becomes eligible to participate, they are automatically enrolled with a 3% wage deferral unless the employee specifically waives participation and will receive an automatic 1% increase in their deferral rate on January 4th of each plan year, up to a maximum of 10%.

Contributions

Employees may contribute through payroll deductions up to 60% of their annual compensation, but not more than the Internal Revenue Code (IRC) imposed limit established each year. Participants who have attained age 50 or older before the end of the plan year are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Company is required to make Safe Harbor matching contributions for eligible participants equal to 100% of the participant's total deferral contributions that do not exceed 4% of the participant's eligible compensation.

The Company, at its discretion, may make matching contributions for eligible participants as further defined in the plan document. For the year ended December 31, 2024 and 2023, no discretionary matching contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching and discretionary contributions and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based upon participant earnings (losses) or account balances, as defined by the plan document. The benefit to which a participant is entitled is the vested portion of the participant's account. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions and all of the Company contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or longer if the proceeds are used for the purchase of a primary residence. The loans are collateralized by the balance in the participant's account and bear interest at a rate commensurate with the local prevailing rates as determined by the Plan Administrator. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. As of December 31, 2024, the interest rates on the outstanding loans ranged from 4.25% to 9.50% per annum. Principal and interest are paid ratably through payroll deductions.

Withdrawals

In the event of retirement (as defined), death, permanent disability, termination of employment, or financial hardship (as defined), the vested balances in a participant's account may be distributed to the participant or the participant's beneficiaries in a lump sum or through payments in such other forms as may be available under the Plan.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$711 and \$31,665, respectively. The account is available to be used to pay Plan expenses and to reduce future employer contributions. During the years ended December 31, 2024 and 2023, \$17,411 and \$0 of forfeitures were used to reduce employer contributions, respectively. During the years ended December 31, 2024 and 2023, \$16,535 and \$34,839 of forfeitures were used to pay administrative expenses, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices. Investments in the common or collective trust stable value fund are valued at the net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liability. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Plan recordkeeping, administrative, and consulting fees are allocated to participant accounts based on account balances. Participant-specific fees such as loan processing fees are charged directly to the appropriate participant account. All other expenses are paid by the Company.

Note 3. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements, that was prepared by or derived from information provided by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

Note 4. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) *Topic 820 Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 Quoted prices in active markets for identical assets or liabilities

Level 2 Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Level 3 Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Recurring Measurements

Following is a description of the valuation methodologies used for assets measured at fair value:

- Shares of mutual funds are valued using quoted market prices in an active market.
- Common collective trust funds are stated at fair value, which is determined by the trustee of the common collective trust based on the underlying assets, which represent the net asset value of units held by the trust. The common collective trust fund invests primarily in fixed income securities and shares of money market funds. The common collective trusts do not have unfunded commitments relating to its investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Income Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement.

Note 7. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and common/collective trust managed or issued by Fidelity Management Trust Company (“the Trustee”). Additionally, administrative expenses are paid by the Plan to Fidelity. Therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees of \$11,170 and \$27,972, respectively, were paid by the Plan to the Trustee for the years ended December 31, 2024 and 2023. Participant loans are considered to be permitted party-in interest transactions. The Plan also paid Private Advisor Group, LLC, investment advisors, and other accounting services fees out of the plan totaling \$127,073 and \$117,670, respectively, for the years ended December 31, 2024 and 2023.

Note 8. Risks and Uncertainties

Plan invests in funds that invest in investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments securities, could occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.
