Note 1 - Plan Description

The following description of Sunrise Coal, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Sunrise Coal, LLC (the "Company"). The Plan is available to eligible employees of the Company; its parent, Hallador Energy Company; and its wholly owned subsidiary, Summit Terminal, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make before-tax or after-tax Roth contributions up to 100 percent of their annual eligible compensation subject to limitations established by the Internal Revenue Service (IRS), which are adjusted annually by the secretary of the Treasury for inflation. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also permits rollover contributions from other qualified retirement plans. Eligible employees are automatically enrolled in the Plan with a deferral rate of 4 percent of compensation unless the employee formally elects not to participate. The deferral rate automatically increases by 1 percent each subsequent year unless formally elected otherwise by the participant, not to exceed 8 percent of total annual compensation. Provided requirements are met, distributions of Roth contributions and related earnings are tax free to participants. A participant's combined before-tax and after-tax Roth 401(k) contributions cannot exceed the maximum annual amount allowed by law.

The Plan allows the Company to make discretionary matching contributions, and the Company has elected to make matching contributions of 100 percent up to 4 percent of employee compensation on a payroll basis. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59½. The Company made matching contributions of \$1,764,119 during the year ended December 31, 2024.

The Company may elect, at its sole discretion, to make an additional nonelective contribution to the Plan, which is allocated to the participants based on each participant's annual compensation compared to the compensation of all participants. To be eligible for nonelective contributions, a participant must have worked at least 1,000 hours during the year and be employed on the last day of the year. The Company made no nonelective contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

Note 1 - Plan Description (Continued)

The Company's discretionary contributions, if any, vest according to the following schedule:

An active participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or termination of the Plan.

Benefit Payments

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment payment options. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan allows in-plan Roth conversions. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account. The IRS has required minimum distributions once a participant reaches an age defined by the Internal Revenue Code.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If the participant is not 100 percent vested at the time of termination of employment, the nonvested portion (forfeitures) of the participant's account shall be placed in a separate account upon liquidation of the account or after five years. Forfeitures can be used to reduce employer contributions or pay plan expenses. The Company applied approximately \$671,000 to reduce employer contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited account balances totaled \$10,289 and \$33,459, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan, manages the Plan's assets, and maintains the Plan's records. Fidelity offers plan participants a variety of investment options through various mutual funds, a cash account, and a self-directed brokerage account at the direction of the participants; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

Cash in the self directed brokerage accounts is valued at the outstanding balance. All other investments are valued based on quoted market prices reported in active markets. See Note 3 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Additionally, some investments held by Fidelity are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 30, 2025, which is the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 3 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
