### ***Opinion***

**Note 1. Description of the Plan**

The following description of Harrison Steel Castings Company Employee Benefit Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan provides health and other benefits covering substantially all full-time employees, regularly working greater than 30 hours per week who have at least 90 days of service, of the Harrison Steel Castings Company (Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. Elevance Health (Elevance), formerly Anthem BlueCross BlueShield, serves as the third-party claims processor for medical claims. The Plan utilizes TrueRx and SHARx to process pharmacy claims.

**Self-Insured Benefits**

The Plan provides health benefits (medical, hospital, surgical, and major medical) to full-time employees and to their beneficiaries and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the *Consolidated Omnibus Budget Reconciliation Act* (COBRA). Benefits are paid on behalf of eligible participants after they have satisfactorily complied with the claims procedures specified in the Plan. The Plan includes provisions whereby claims in excess of a certain level for a participant and in the aggregate are paid by an insurance carrier. The individual participant reinsurance threshold was \$125,000 for both 2024 and 2023 and for the participants which meet this threshold on a combined basis have an aggregate reinsurance in total for an additional \$125,000. The Plan's minimum aggregate level approximated \$4,250,000 and \$4,350,000 for 2024 and 2023, respectively. The cost of this insurance coverage is paid by the Plan.

Elevance processes health claims of active participants, dependents, and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan.

**Contributions**

The Company periodically contributes amounts to the Plan that are necessary to fund claims and Plan expenses. Employees and terminated participants covered by COBRA also make contributions determined by the Plan's sponsor to fund benefits. The only retiree coverage offered by the Plan is through COBRA.

**Plan Termination**

Although it has not expressed intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, incurred but not reported (IBNR) claims, eligibility

credits, claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. The ongoing claims are estimated for recurring medical procedures based on factors including estimated claims, participant's age, life expectancy, and a discount rate of 5% in both 2024 and 2023.

***Payment of Benefits***

Claim payments are recorded when paid by the third-party claims processor. Elevance processes medical, hospital, surgical, and major medical claims of active and retired participants, dependents, and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan.

***Other Plan Benefits***

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

***Plan Tax Status***

No trust has been established for the Plan, and no request for tax-exempt status has been filed. There are no investments and, accordingly, no taxable income was generated.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees of \$231,852 and \$212,083 were paid by the Plan to Elevance and other providers for network access and medical management services for 2024 and 2023, respectively.

Administrative and medical expenses provided by the Company-sponsored WeCare Clinic amounted to \$624,383 and \$537,249 during 2024 and 2023.

Consulting fees of \$86,850 and \$85,200 were paid by the Plan to Paradigm Consulting in 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

**Note 4. Reconciliation of Financial Statements to Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan (Form 5500) filed with the Internal Revenue Service and the accompanying financial statements include reporting benefits payable in Form 5500.
