**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of The Professional Basketball Club, 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### NOTE A - DESCRIPTION OF PLAN

The following description of The Professional Basketball Club, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. A more detailed description of investment options is available in a current prospectus for each fund.

##### **General**

The Plan is a defined contribution benefit plan covering substantially all full-time employees, except for coaches, the professional athletes and trainers, of The Professional Basketball Club, LLC (the "Employer" and "Plan Sponsor") who have attained age 21 and 1,000 hours of service, subject to certain limitations as defined in the Plan document. The Plan was formed on April 1, 2001 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan Administrator is responsible for oversight of the Plan. USI Consulting Group, the Plan's recordkeeper, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's 401(k) committee.

Charles Schwab Trust Bank is the Custodian and Trustee of the Plan. The Custodian is responsible for holding the investment assets and notes receivable from participants of the Plan, making investment transactions and making distributions to participants.

##### **Participant Contributions**

Participants may contribute to the Plan elective amounts up to 80% of their eligible compensation, subject to a dollar limit set by law. Participants may change their contributions at the beginning of each month. Participant contributions are recognized when the Employer makes payroll deductions. Participant contributions are invested at the direction of each participant in any of the available investment options. The Plan allows pre-tax deferrals, Roth deferrals, after-tax contributions and transfers from other qualified retirement plans, and allows for in-Plan Roth conversions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

##### **Employer Matching Contributions**

The Employer contributes an amount equal to 100% of the employee contributions up to 4% of the employee's eligible compensation, subject to certain limits. The Employer may make additional contributions, which are discretionary and are determined each year by the Employer as defined in the Plan document. There were no discretionary contributions to the Plan for the years ended December 31, 2024 or 2023. The Employer's contributions are invested in accordance with participant elections in effect at the time of contribution.

##### **Forfeitures**

Forfeited balances in participants' Plan accounts reduce the Employer contributions required to be paid to the Plan. Additional Employer contributions are required for participants whose Plan accounts were forfeited upon termination but who are re-employed by the Employer within certain periods as described in the Plan document. There were no forfeited non-vested accounts at December 31, 2024 or 2023 available to reduce future employer contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$11,170 and \$48,475, respectively, from forfeited non-vested accounts.

##### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution and related Employer matching contribution and an allocation of related Plan

earnings, and charged with withdrawals and an allocation of Plan losses or expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions and actual earnings or losses thereon. Vesting in the Employer's contributions and actual earnings thereon is based on the number of years of continuous service to the Employer. A participant is 25% vested after completion of two years of credited service, with vesting increasing by 25%, up to 100%, for each year of credited service thereafter.

Participants fully vest in their Plan accounts, including Employer contributions, in the event of death, total disability, or retirement on or after age 65.

***Payment of Benefits***

On termination of employment, including retirement, death or disability, a distribution will be made in one lump-sum cash payment equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Expenses***

All administrative expenses of the Plan are paid by the Plan unless paid by the Employer. Certain administrative expenses were paid by the Employer and aggregated approximately \$51,000 and \$45,000 for the years ended December 31, 2024 and 2023, respectively. Expenses that are paid by the Employer are excluded from these financial statements. Participants are required to pay, from their accounts, a \$100 loan fee to USI Consulting Group, at the inception of a loan and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts. Participant loans are secured by his or her vested balance. Participants may only have one loan outstanding at any time. A participant may borrow up to the lesser of \$50,000 or 50% of his or her vested interest under the Plan, subject to certain limits. No loan in an amount less than \$1,000 will be made. The interest rates charged on such loans are commensurate with interest rates charged on similar loans under like circumstances as determined by the Plan Administrator. Rates are established at the time of the loan and are based on prime rate. The repayment period may not exceed five years, unless the loan is used to acquire the participant's principal residence, whereupon repayment may not exceed 15 years. Principal and interest are paid ratably through monthly payroll deductions.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement

date. See Note D for discussion of fair value measurement. The net appreciation in fair value of investments is based on the difference between the fair value of the investments at the beginning of the Plan year or the date of purchase if subsequent to that date and the fair value at the end of the Plan year and includes realized gains and losses on investments that were bought and sold during the period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan allows participants to direct contributions into various mutual funds. The underlying investment securities of mutual funds are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain underlying investment securities and the level of uncertainty related to changes in the value of the funds, it is reasonably possible that changes in the value of mutual funds will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

***Party-in-Interest Transactions***

Certain Plan investments are shares of mutual funds managed by an affiliate of Charles Schwab Trust Bank for the years ended December 31, 2024 and 2023; therefore, these transactions qualify as party-in-interest transactions.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures related to the certified investment information to assess whether they are in accordance with U.S. GAAP.

**NOTE D - FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market* - Interest-bearing cash valued at the closing account balances.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

**NOTE E - TERMINATION**

Although it has not expressed any intent to do so, the Board of Directors of the Employer may at any time and for any reason modify, amend or terminate the Plan.

No modification or amendment to the Plan shall be effective if it authorizes or permits any part of the Plan (other than such part as is required to pay taxes and administration expenses) to be used for or diverted to any purpose other than for the exclusive benefit of the participants or their beneficiaries or estates, causes any reduction in the amount credited to the account of any participant, or causes or permits any portion of the Plan to revert to or become property of the Employer as defined in the Plan document.

Upon any full or partial plan termination, all amounts credited to the affected participants’ accounts shall become 100% vested and shall not be subject to forfeiture thereafter, and all unallocated amounts shall be allocated to the accounts of all participants in accordance with the Plan’s provisions.

**NOTE F - TAX STATUS**

The Plan uses a prototype Plan document sponsored by Charles Schwab Trust Bank, which received an opinion letter from the Internal Revenue Service (“IRS”) dated March 19, 2015 which states the prototype Plan document satisfies the applicable provision of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income tax has been included in the Plan’s financial statements.

U.S. GAAP requires the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
