## Independent Auditor's Report

Trustees

Hy-Line International 401(k) Employee Retirement and Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hy-Line International 401(k) Employee Retirement and Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). #### Note 1. Plan Description

The following description of the Hy-Line International 401(k) Employee Retirement and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General and eligibility:** The Plan is a defined contribution plan covering all employees of Hy-Line International, Hy-Line North America, VALO BioMedia North America and H&N North America (the Companies) who have completed 60 days of service and have reached 21 years of age. The Plan Administrator is responsible for oversight of the Plan. The Fiduciary Review Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan Trustees. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions.

**Contributions and investment options:** Each year, participants may contribute a stated percentage of their compensation, as defined by the Plan and applicable statutory limitations. The Companies provide a matching contribution equal to 100% of the participant's eligible contributions that are not over 3%, plus 50% of elective deferral contributions that are over 3% but are not over 5% of eligible compensation. Participants may direct their contributions and employer contributions into a common collective trust fund or one or more of various pooled separate accounts or mutual funds. Participants may change their investment options daily. Effective January 1, 2023, the Plan allows for Roth deferral contributions as well as adding a true up provision for matching contributions. Effective July 1, 2023, the Plan was amended to include an automatic enrollment and deferral increase provision. New participants or current employees that have not completed an elective deferral agreement will be automatically enrolled at 3% of eligible compensation, unless they elect a different deferral percentage, and will increase annually 1% up to 10% of eligible compensation.

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Companies' contributions to that participant, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions, employer contributions and actual earnings thereon.

**Payment of benefits:** Upon termination of service, a participant may elect to receive a lump-sum amount equal to the vested value of the participant's account, equal installments over a period not to exceed the beneficiary's life expectancy, a guaranteed life income for a participant and/or the participant's spouse, or to purchase a different form of annuity.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the valuation policies utilizing information provided by the custodians. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit payment:** Benefit payments are recorded when paid.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

#### Note 3. Administrative Expenses

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan, such as expenses for bonding required by ERISA, expenses for auditing and recordkeeping, and fees for investment education service are paid by the Companies. Certain investment management fees are netted against investment income. Expenses that relate solely to a specific participant may be assessed against that participant's account.

#### Note 4. Information Certified and Provided by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Custodian

The custodians also certified the completeness and accuracy of \$640,183 of interest and dividends and \$4,177,074 of net appreciation in fair value of investments. All amounts include activity on investments bought, sold and held during the year ended December 31, 2024.

#### **Note 5. Related-Party Transactions**

Certain Plan investments are shares of pooled separate accounts and the common collective trust fund managed by Delaware Charter Guarantee and Trust d/b/a Principal Trust Company, the custodian as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan to the custodians totaled \$106,866 for the year ended December 31, 2024. The Companies also pay certain administrative expenses on behalf of the Plan.

#### **Note 6. Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 7. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants and requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability, are developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. The fair value hierarchy is as follows:

**Level 1:** Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

**Level 2:** Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

**Level 3:** Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at December 31, 2024 compared to December 31, 2023.

**Mutual funds:** Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

**Pooled separate accounts:** Pooled separate accounts (other than Principal U.S. Property) invest primarily in domestic and international stocks, commercial paper and mutual funds. The Principal U.S. Property Separate Account invests primarily in commercial real estate and includes mortgage loans which are backed by the associated properties. Net asset value is used as a practical expedient to determine fair value for these accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Each pooled separate account provides for redemptions by the Plan at reported net asset value per share, with little to no advance notice requirement.

**Common collective trusts:** Common collective trust funds are comprised primarily of fully benefit-responsive investment contracts or bank collective investment funds that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.

- (a) Investments in select funds in this category can be transferred once every 30 days at the current net asset value per share based on the fair value of the underlying assets. Participants are not allowed to transfer back into the fund until the 30-day period has expired. New contributions are allowed during this time period.
- (b) This category consists of a stable value fund which seeks current income by investing primarily in conventional, synthetic and separate account investment contracts (collective contracts) issued by life insurance companies, banks and other financial institutions. The fund's contracts allow it to achieve a total rate of return to match the return of the index it was set up to mirror and allow for its principal value to remain stable regardless of the volatility of the financial markets. Investments in this category can be redeemed daily at the current net asset value per share based on the fair value of the underlying assets. Contributions to the fund are maintained in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.
- (c) This category consists of bank collective investment funds that invest in high growth domestic companies. Investments in this category can be redeemed daily at the current net asset value per share based on the fair value of the underlying assets. Contributions to the fund are maintained in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

#### Note 8. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan provisions to terminate the Plan subject to the provisions set forth in ERISA.

#### Note 9. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provisions or liability for income taxes have been included in the financial statements.
