NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of The Halma Holdings Inc. Profit Sharing/Savings Retirement Plan (the "Plan") have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Related-Party Transactions

Certain Plan investments are investments in mutual funds managed by Empower Trust Company LLC ("Empower"). Empower is the asset custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

Several employees of Halma Holdings, Inc. and its subsidiaries (collectively, the "Company") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

Estimates

The preparation of financial statements in conformity with United States generally accepted accounting principles ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative expenses

Certain professional and accounting fees incurred in connection with the operation of the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

The Plan has an unallocated expenses account that it uses to cover certain expenses of the Plan. The balance was \$348 and \$6,791 at December 31, 2024 and 2023, respectively. During 2024, \$8,447 from this account was used to cover Plan expenses.

Subsequent Events

The Company has evaluated subsequent events to the balance sheet date of December 31, 2024, through October 10, 2025, which is the date these financial statements were available to be issued.

NOTE 2 DESCRIPTION OF THE PLAN

The following description of The Halma Inc. Profit Sharing Savings Retirement Plan provides only general information. Participants should refer to their agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 1988 covering all eligible employees of Halma Holdings Inc. and its participating subsidiaries. The plan was restated November 1, 2023. To be eligible to participate in the Plan, an individual must be an employee of the Company who has completed thirty days of service and is age twenty-one or older. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Service Code of 1986 ("Code"), as amended.

Contributions

Subject to certain limits, participants may contribute to the Plan, on a pre-tax or after-tax basis, 401(k) contributions and catch-up contributions up to limits set by the Plan and the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 in 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500.

The Plan allows for automatic enrollment of eligible employees at a 5% deferral rate. For participants auto enrolled who have not subsequently changed their deferral elections, the Plan includes an escalation provision resulting in automatic deferral percentage increases of 1% each July 1 until the participant's elective deferrals equal 10% of eligible compensation. Subsequent to year-end, the 10% cap was increased to 15%.

The Company matched 100% of participant contributions up to 5% of a participant's annual compensation during 2024. Additional profit-sharing amounts may be contributed at the discretion of the Company's board of directors. In 2024, no profit-sharing contribution was made.

NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

Rollover Contributions

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the contributions to the Plan behalf of the participant and adjusted for earnings and losses thereon. Any employer discretionary profit sharing contributions are allocated based upon the ratio of a participant's compensation, to total compensation, as defined. The benefit to which a participant is entitled is the vested amount that is in such participant's account at any given time.

Vesting

Participants are immediately 100% vested in their 401 (k) contributions, catch-up contributions, and rollover contributions, as an adjusted for earnings and losses thereon. Participants are vested in employer matching and discretionary contributions based on years of continuous service. As of April 1, 2022 a participant becomes 50% vested after 2 years of service and then can become 100% vested after 3 years of credited service. Previously, a participant became 100% vested after three years of service. Forfeited balances of terminated participants' non-vested accounts can be applied to offset employer contributions or administrative expenses of the Plan. The balance of unallocated forfeitures was \$138,849 and \$37,157 as of December 31, 2024 and 2023, respectively. During 2024, \$2,242,823 of unallocated forfeitures were applied to offset employer contributions.

Unclaimed Property

When checks used to pay benefits to participants are not cashed, the checks are stopped and the funds are moved to the unclaimed property account. This account is an unallocated account that is used to hold the funds until the participants can be located. The balance in this account was \$91,894 and \$49,358 at December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon a participant's retirement (including early retirement), death, disability, or termination of employment with the Company, the participant may elect to receive their benefit in a lump sum distribution equal to the value of the vested interest in their account.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of his 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

Notes Receivable from Participants

Notes receivable are available on amounts in the participant's account upon incurring a financial hardship. The minimum note amount is \$1,000 and the maximum is the lesser of one-half of the participant's vested account balance or \$50,000. Loans are secured by the balance in the participant's account and bear interest at rates determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loans are payable within five years except for those used to acquire a principal residence. A participant may only have one outstanding loan at a time.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels base on the ability to observe inputs as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued using quoted market prices of the shares of each applicable mutual fund.

Halma PLC stock fund: Values based on the NAV of units in a unitized fund, as published by the administrators the fund, and is based on the underlying assets owned by the fund. The fund invests in Halma PLC common stock (traded on the London Exchange) and an amount of short-term investments to facilitate liquidity for investors. Halma PLC is the parent company of Halma Holdings, Inc.

Variable annuities: Valued based on the NAV of units of an annuity fund as published by the trustee.

Common collective trust: Valued based on the NAV of units of a collective trust as published by the trustee.

The Plan invests in the Goldman Sachs Stable Value Collective Trust. The existence of certain conditions can limit the ability of the Plan to transact with participants at fair value. These circumstances may include Company initiated events as follows: the partial or complete termination of the Plan; the exclusions from coverage of a group of employees by the Company; the implementation of an early retirement program by the Company; a termination of employment. It is not probable an event would occur that would limit the Plan's ability to transact at contract value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 TAX STATUS
