We have performed audits of the financial statements of IEX Group, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). ## Notes to Financial Statements

---

### 1. Description of the Plan

The following brief description of the IEX Group, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document or Summary Plan Description for a complete description of the Plan.

#### *General*

The Plan is a defined contribution plan covering all eligible employees of IEX Group, Inc. (the Employer), as defined in the Plan document. The Plan was established effective as of January 1, 2014, restated effective January 1, 2018, and amended since then. For all contribution types, employees may enter the Plan immediately. There are no age or service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Reliance Trust Company (RTC) and Transamerica Financial Life Insurance Company Inc. (TFLIC) are the custodian and contract holder, respectively, of the Plan assets at December 31, 2024 and 2023, and for the year ended December 31, 2024.

#### *Contributions*

Participants may elect to contribute a percentage of their compensation, as defined in the Plan, up to the elective deferral limit allowed by law (\$23,000 in 2024). Participants who have attained or will attain 50 years of age before the end of the Plan year are eligible to make catch-up contributions up to the deferral limit allowed by law (additional \$7,500 for 2024, totaling \$30,500 in 2024). Participants are allowed to make Roth elective deferrals. Participants may also roll over amounts from tax-qualified and other types of plans, as specified in the Plan document.

The Employer makes matching contributions equal to 100% of the participant's deferral up to \$5,000 per year. The Employer, in its sole discretion, may also make profit-sharing contributions to be paid based on business units or location. There were no profit-sharing contributions made by the Employer for 2024.

#### *Investment Options*

All of the Plan's investment options are fully participant-directed. Participants may direct the investment of their account balances into any of the Plan's available investment options.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions and rollover, if any, an allocation of the Employer's contributions, and Plan's investment earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Notes Receivable from Participants*

Subject to the terms as set forth in the Plan document, participants are permitted to borrow a minimum of \$500 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the difference between the highest outstanding loan balance in their account during the past 12-month period and their current outstanding loan balance. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 2%, which is fixed for the term of the loan. The notes receivable must be repaid over a period not extending beyond five years from issuance, unless such notes receivable are used to acquire a principal residence. The maximum number of notes receivable outstanding at any one time is one. Fees from notes receivable may be charged against the account of the participant to whom the notes receivable are granted, and the Plan administrator may adopt any administrative rules or procedures that it deems necessary or appropriate with respect to the granting and administering of notes receivable.

### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer matching contribution portion of their accounts is based on years of service and follows the schedule below:

### *Payment of Benefits*

On termination of service due to death, disability, retirement, or severance from employment, or upon reaching age 59½ while actively employed, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account.

In cases of financial hardship, as defined by the Plan, participants may be eligible to receive a distribution from their pre-tax elective deferral account and/or Roth elective deferral account balance.

### *Forfeitures*

If a participant leaves the Employer before becoming fully vested, any nonvested Employer contributions and investment earnings thereon are forfeited. Forfeitures will be used to reduce any future Employer contribution and/or Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$58,281 and \$25,050, respectively. For the year ended December 31, 2024, \$33,941 in forfeitures were used to pay Plan expenses, and \$46,414 in forfeitures were used to reduce Employer contributions.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. These estimates include fair values of investments. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value with the exception of the Plan's fully benefit-responsive investment contract, which is stated at contract value (see Note 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to participants as part of their benefit payments. Loan administration and investment-related expenses are included in administrative expenses.

### *Benefit Payments*

Benefit payments to participants are recorded when paid.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### *Contributions Receivable*

Participant contributions and any related employer matching contributions are recognized in the period during which the Employer makes the respective payroll deduction from the participant's compensation. Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Expense Budget Account*

The Plan holds an expense budget account, which is invested in the TFLIC Stable Value Fund (see Note 6). Revenue is earned on amounts allocated to the Stable Value Fund in excess of the credited rate of interest and can be used to reduce Plan expenses. Revenue credits are presented in other income in the statement of changes in net assets available for benefits.

At December 31, 2024 and 2023, the expense budget account amounted to \$4,922 and \$4,260, respectively. For the year ended December 31, 2024, the Plan received revenue credits of \$51,595, and \$50,933 were used to reduce Plan expenses.

## **3. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

## **4. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, interest income on notes receivable from participants, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as completed and accurate by RTC and TFLIC, qualified institutions.

### 5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual Funds* - Mutual funds are valued at unadjusted quoted market prices, which represent the net asset value (NAV) of shares owned by the Plan at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 6. Fully Benefit-Responsive Stable Value Option

The Plan entered into a fully benefit-responsive investment contract with TFLIC. TFLIC maintains the contributions in a general account. The Transamerica Stable Value Option is backed by the general account of TFLIC. While TFLIC declares rates periodically and backs the principal and interest of this investment, any guarantees are subject to the claims-paying ability of TFLIC. The investment choice is not guaranteed by the Federal Deposit Insurance Corporation (FDIC) or any other government agency. Although Plan participants generally may withdraw assets from the Stable Value Option investment choice without restrictions, TFLIC may impose a hold period at the contract level in the event of a full-contract discontinuance or partial-contract discontinuance.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Stable Value Option, as a deposit liability of TFLIC with no underlying assets, would have no direct investments on behalf of the Plan. The assets are based on the general unallocated account of TFLIC, and the risk of investment is based on their insurance ratings. The average yield earned is equal to the average yield earned by the Plan, adjusted to reflect the actual interest rate credited to Plan participants.

Since the Stable Value Option investment choice is an obligation of TFLIC, the occurrence of an event that limits the ability of the investment to transact at contract value between TFLIC and a participant holding the investment is not probable.

In addition, certain events allow TFLIC to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) the Plan is changed so as to significantly affect the Employer's obligations under the contract; (2) the contract can no longer be treated as a pension plan contract, as that term is defined under the Internal Revenue Code (the IRC) and the Employer determines that it is not practical to continue the provision of benefits under the contract; (3) the Plan is terminated; (4) the trustee of the Plan (Contract Holder) fails to comply with the requirements under the contract, (5) the Contract Holder, except by unintentional omission, fails to give TFLIC the information TFLIC needs under the contract; (6) the Contract Holder, except by unintentional omission, fails to furnish TFLIC with a copy of any amendments to the Plan, or annual report records; or (7) the sum of the contract account values at any time equals \$20,000 or less.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue any of its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event the Plan is terminated, participants will become 100% vested in their accounts.

### 8. Tax Status

As of January 1, 2018, the Plan adopted Ascensus' Volume Submitter 401(k) Profit-Sharing Plan (Volume Submitter Plan). Accordingly, the Plan is permitted to rely on the document provider's advisory letter. The Internal Revenue Service (IRS) has determined and informed the document provider by a letter, dated February 1, 2018, that the Volume Submitter Plan is designed in accordance with the applicable sections of the IRC. The Plan sponsor is responsible for reviewing the annual Required Amendments List issued by the IRS for individually designed plans to retain qualified tax status. The Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable provisions of the IRC. Therefore, the administrator believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS examinations for any tax periods in progress.

### 9. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by TFLIC. Any purchases and sales of these funds qualify as party-in-interest transactions. Notes receivable from participants would also qualify as exempt party-in-interest transactions. Additionally, certain employees and officers of the Employer, who are also participants of the Plan, perform administrative services for the Plan at no cost. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### 10. Late Remittances

During the years ended December 31, 2022-2024, employee salary deferral and loan repayment withholdings totaling \$445,465, were not remitted within the appropriate time period by the Employer. These non-exempt party-in-interest transactions constitute a prohibited transaction, as defined by ERISA. In January 2025, the Employer self-corrected the 2022 and 2023 late remittances totaling \$76,768 and \$146,471, respectively, with a contribution of lost earnings totaling \$2,559, and in April and August 2025, the Empower self-corrected the 2024 late remittances totaling \$222,226 with a contribution of lost earnings totaling \$848. The Employer has further implemented a procedure to ensure all future remittances are done within the prescribed time period.

### 11. Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date that the financial statements were available to be issued. There were no subsequent events identified requiring disclosure or adjustment to the financial statements.
