INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **EPCOR USA, Inc. 401(k) Savings Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

(1) Description of the Plan

The following description of the *EPCOR USA, Inc. 401(k) Savings Plan* (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan is administered by a trustee and an administrator appointed by EPCOR USA, Inc. (the “Company”), the Plan’s sponsor.

- A. General** – The Plan is a defined contribution plan covering all employees of the Company who have completed at least 30 days of service and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions** – Participants may elect to contribute up to 80% of eligible compensation, or the maximum dollar amount allowed by law, whichever is less, as a pretax or Roth deferral. The Plan provides for automatic enrollment of 3% of compensation. Participants that were hired before January 1, 2006 receive matching contributions equal to 50% of the first 5% deferred. Participants hired before January 1, 2006 may also participate in the EPCOR Water (USA), Inc. Pension Plan. Participants hired on or after January 1, 2006 receive matching contributions equal to 100% of the first 3% deferred, plus 50% of elected deferrals from 3% to 5%. Participants hired on or after January 1, 2006 receive an additional contribution equal to 5.25% of eligible compensation if they are actively participating in the Plan. The Company may also make discretionary contributions to the Plan. There were no discretionary contributions for 2024. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans.
- C. Participant accounts** – Each participant’s account is credited with the participant’s contributions, Company matching and additional contributions, and allocations of the Company’s discretionary contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- D. Vesting** – Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon. Participants are fully vested in the Company’s additional and discretionary contributions after one year of service.
- E. Notes receivable from participants** – Participants may borrow against their vested account balances a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant’s vested account balance. Notes receivable are secured by the vested balance in the participant’s account and bear interest at fixed rates commensurate with local prevailing rates at the time of origination as determined by the Plan administrator.
- F. Payment of benefits** – Upon termination of service due to death, disability, or retirement, a participant becomes 100% vested in his or her account and receives a lump-sum distribution equal to the value of the participant’s account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

(1) Description of the Plan (continued)

G. Forfeitures – At December 31, 2024 and 2023, there were balances of \$0 in the forfeited non-vested accounts, respectively. During 2024, forfeitures of \$17,858 and \$8,567 were used to reduce employer contributions and administrative expenses, respectively.

H. Administrative expenses – Administrative expenses, including investment management and recordkeeping fees, are paid by the Plan, except to the extent the Company pays such expenses.

(2) Significant accounting policies

The significant accounting policies followed by the Plan are as follows:

Basis of accounting – The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (“GAAP”) on the accrual method of accounting. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

Management’s use of estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties – The Plan provides for various investment fund options which in turn invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Payment of benefits – Benefits are recorded when paid.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date.

Investments in pooled separate accounts and a common collective trust are valued at unit value, which is based on the aggregate current fair values of the underlying assets in relation to the total number of units outstanding. Unit value is the equivalent of net asset value (“NAV”), which is a practical expedient for estimating the fair value values of these investments. These investments have no unfunded commitments as of December 31, 2024 and 2023, and can be redeemed daily with no redemption notice period or other redemption restrictions. Investments in shares of mutual funds are stated at net asset value, which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.

(2) Significant accounting policies (continued)

Purchases and sales of securities are recorded on a trade-date basis. Income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants – Participant loans are measured at their unpaid principal balance plus accrued interest. Loans are deemed to be in default if principal or interest remains unpaid for 90 days after it is due.

(3) Fair value measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(6) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their portion of employer contributions.

(7) Tax status

The Prototype Plan obtained a favorable opinion letter from Internal Revenue Service dated June 30, 2020 stating that the Prototype Plan was designed in accordance with the applicable regulations of the Internal Revenue Code. The Plan administrator has not obtained an individual determination letter for the Plan. The Prototype Plan has been amended since receipt of the opinion letter consisting primarily of changes to ERISA. The Plan sponsor and the Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
