- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules of assets held for investment purposes as of December 31, 2024 and reportable transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. DESCRIPTION OF THE PLAN

The following brief description of the Kimbel Mechanical Systems, Inc. 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

The Plan was restated effective December 6, 2024 when the Plan's trustee changed from Voya Retirement Insurance and Annuity Company to Empower Advisory Group, LLC. Employee after-tax contributions and hardship distributions are now permitted. In addition, long term part time employees are eligible to participate in elective deferrals. The changes did not materially affect Plan operations.

#### **General**

The Plan is a defined contribution plan covering substantially all full-time, nonunion employees of Kimbel Mechanical Systems, Inc. (the "Company") who meet eligibility requirements. Participants are eligible to participate in the Plan if they are at least 18 years of age and met the service requirements as measured by the elapsed time method. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### **Contributions**

Participants in the Plan may elect for any calendar year to contribute pre-tax or Roth contributions, up to the lesser of the maximum amount permitted under Section 402(g) of the Internal Revenue Code of 1986 (\$23,000 for 2024) as adjusted by a cost-of-living factor each year or 100% of eligible compensation. In addition, certain participants may contribute an additional \$7,500 to the Plan for 2024 as allowed by the catch-up rules. Contributions are subject to certain limitations.

The Plan has an Eligible Automatic Contribution Arrangement with an automatic deferral rate of 3% for all participants hired after April 1, 2021. On January 1, 2024, the Plan Adoption Agreement was restated to increase the automatic deferral rate for the Eligible Automatic Contribution Arrangement from 3% to 6% for all participants hired after June 30, 2024. The changes did not materially affect Plan operations.

The Plan includes a provision for a matching contribution determined by the Company at its discretion. For the Plan year ended December 31, 2024, the employer provided matching contributions of 50 percent of the amount contributed by each participant up to their first 6 percent of deferred contributions to the Plan.

#### **Participant accounts**

Each participant's account is credited with (a) the participant's contributions, (b) the Company's contributions, and (c) Plan earnings and appreciation. Each participant's account is charged with (a) any withdrawals or distributions, (b) Plan losses and depreciation, and (c) an allocation of administrative and mutual fund expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Investment options

From January 1, 2024 to December 6, 2024, participants were able to allocate their contributions among a variety of managed funds by Voya Retirement Insurance and Annuity Company.

Effective December 6, 2024, participants were able to allocate their contributions among a variety of managed funds by Empower Advisory Group, LLC.

#### Vesting

Participants are always 100 percent vested in their deferred contribution.

Participants' vested interest in employer contributions is determined under the following schedule and is based on vesting years of service:

2	20%
3	40%
4	60%
5	80%
6 or more	100%

#### Forfeited accounts

If a participant forfeits any unvested balances in their account, the forfeited amount is used to reduce future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$102,697 and \$195,497, respectively. \$230,873 in forfeitures were used to reduce employer contributions in 2024.

#### Participant loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 3.25 to 8.50 percent, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

#### Payment of benefits

On termination of service due to death, disability, or retirement at age 65, a participant will receive a lump-sum amount equal to the value of the participant's account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Payment of administrative expenses**

It is the policy of the Plan that certain administrative expenses pertaining to the Plan be paid by the Company.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Investments valuation and recognition**

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Net appreciation or depreciation in the fair value of investments includes both realized and unrealized appreciation, including those investments bought and sold during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### *Level 2 Fair Value Measurements*

Level 2 inputs are those other than quoted prices in Level 1 that are observable and include the following: quoted prices on similar assets in active markets; quoted prices for identical or similar assets in markets that are not active; observable inputs other than quoted prices such as yield curves, volatilities, prepayment speeds, or inputs derived principally or corroborated by observable market data by correlation or other means.

#### *Level 3 Fair Value Measurements*

Level 3 inputs are unobservable inputs for the asset reflecting internal assumptions used to arrive at an estimate or exit price. Those inputs are based on the best information available in the circumstances.

### 4. TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC) Section 401. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and tax counsel believe the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

The Plan continually evaluates expiring statutes of limitations, audits, changes in tax laws and new authoritative rulings. The Plan files an annual return in the U.S. federal jurisdiction. U.S. federal returns prior to 2021 are closed.

### 5. CERTIFICATION OF INVESTMENT DATA (UNAUDITED)

During the year ended December 31, 2024, the assets of the Kimbel Mechanical Systems, Inc. 401(k) Plan were held by Voya Retirement Insurance and Annuity Company and Empower Advisory Group, LLC.

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company and Empower Advisory Group, LLC (the trustees of the Plan).

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### 8. PLAN TERMINATION

While it is the Company's intention to continue the Plan indefinitely, it has the right to terminate or amend the Plan at any time. No amendment, however, may permit any part of the assets of the Plan, other than those required to pay taxes and administrative expenses, to be used for any purpose other than for the exclusive benefit of the participants.

### 9. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.
