

Note 1 - Description of Plan

The following description of the TRI HoldCo Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a salary deferral arrangement established under Section 401(k) of the Internal Revenue Code ("IRC"). The Plan was originally established by TRI HoldCo Inc. (the Company) and became effective on January 1, 2003 to provide retirement, death, and disability benefits for eligible employees (Participants). All employees are eligible to participate in the Plan after satisfying various lengths of service requirements and will actually participate at the first entry date after satisfying these requirements. Employees are required to complete one month of service to be eligible for purposes of elective deferrals and complete one year of service to be eligible for purposes of employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and certain provisions of the Internal Revenue Code. The Board of Trustees is responsible for oversight of the Plan and in determining the appropriateness of the Plan's investment offerings.

Administration

The Plan is administered by TRI HoldCo, Inc., the Plan sponsor. A portion of the administrative and custodial activities involved with the operation of the Plan have been outsourced to Flynn, Shojinaga & Associates Inc. and Principal Life Insurance Company. Certain Plan transactions involving these entities qualify as parties-in-interest under the IRC and are exempt from prohibited transaction rules of ERISA.

Contributions

Participants may make (1) tax-deferred contributions, (2) Roth deferral contributions, (3) catch up contributions, and (4) rollover contributions from another plan. These contributions are limited by various IRC provisions. Participants may allocate their respective contributions between various investment options valued daily. All assets in the Plan are subject to participant investment direction. If the participant does not direct the investment, their account will be invested in accordance with default investment alternatives.

Each year the Company's Board of Directors may elect to make (1) a matching contribution equal to a discretionary percentage of each participant's elective deferral, and (2) a discretionary non-elective contribution, which is allocated to participant accounts. The Company has made no contributions to the Plan since its inception.

Note 1 - Description of Plan (continued)

Vesting

Participants are immediately vested in their salary deferral, Roth deferral contributions, and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Participant Accounts

Each Participant's account is credited with the Participant's contributions, the Company's matching contributions (if any), and allocations of the Company's discretionary contributions (if any). Earnings or losses are determined by each participant's selection of investments. Individual participant expenses are charged directly to the account incurring the cost based on each participant's use of a particular Plan feature. The benefit to which a participant is entitled is limited to the vested balance of their account.

Investment Options

The plan allows participants, upon enrollment to the Plan, to direct all contributions in percentage increments in any investment option provided by the Plan as listed in the supplemental schedule. Participants may change their investment options at any time.

Forfeitures

Forfeitures represent the non-vested portion of a terminated participant's account balance. Forfeitures remain in the Plan and are used for several purposes, such as payment of plan administrative expenses and as additional discretionary or matching employer contributions. Participants will always share in the allocation of forfeitures regardless of the amount of service completed during the year. There were no forfeitures of non-vested accounts for the year ended December 31, 2024.

The non-vested portion of a terminated participant's account balance is forfeited on the earlier of the date of (1) the distribution of the vested portion to the participant or (2) after the terminated participant has incurred five consecutive one-year breaks in service. If the terminated participant has no vested benefit in their account balance, the entire account balance is forfeited upon termination and may be restored if the participant returns to service before incurring five consecutive one-year breaks in service.

Note 1 - Description of Plan (concluded)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Each loan is secured by the balance in the participant's account and bears interest at commercially reasonable rates established by the Plan administrator (currently prime + 0.5%). Principal and interest are paid ratably through payroll deductions for a period of 12 months to 60 months, except for a residential loan, which can be paid back over 25-30 years. A participant is allowed to have 3 loans outstanding and may refinance an existing loan.

Payments of Benefits

When a participant leaves the Company (employer), upon retirement or for any other reason, those Participants (or their beneficiaries) may receive the full value of their salary deferrals plus their earnings thereon and the vested portion of their employer contribution account.

Participants with vested account balances greater than \$5,000 may elect to receive the value of their accumulated Plan benefits as a lump-sum, as a rollover to an Individual Retirement Account or another qualified plan, or in an alternative manner mutually agreed upon by the Participant and the Plan administrator (ad-hoc). Mandatory distributions of accounts exceeding \$1,000 up to \$5,000, not otherwise directed by the participant upon termination, will be rolled over into an Individual Retirement Account selected by the Plan Administrator. Participants with account balances less than \$1,000 will receive mandatory cash out via a lump sum distribution in cash following termination.

A Participant may request in-service distributions of their vested balance once they reach 59-1/2 years of age or qualify for financial hardship according to IRC provisions. A Participant's distribution must not occur later than April 1 following the calendar year in which the Participant reaches 70 1/2 or 72 (depending on the birth year). In the event that a Participant dies before retirement, the beneficiary will receive the value of the Participant's account in a lump-sum distribution.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported based on the fair values, net asset values or contract values of the underlying investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion and disclosure of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on their ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

Generally Accepted Accounting Principles establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs consist of estimates using the best information available when there is little or no market and have the lowest priority. An investment's level within the fair value hierarchy is based on the pricing transparency of the investment and does not necessarily correspond to the perceived risk of that investment.

The Plan is required to measure investments at fair value and uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Investment contracts held by a defined-contribution plan are required to be reported at fair value.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. The participant will receive the appropriate form required by the Internal Revenue Service for reporting distributions from pensions.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023 respectively.

Payment of Benefits

Benefits are recorded when paid. Benefit claims payable represent distributions made on or near December 31st, which have not been transferred from the investment account to the terminated participant.

At December 31, 2024, Plan assets includes approximately \$2.4 million of benefits allocated to the accounts of terminated employees who have not yet made an election to withdraw from participating in the Plan. The vested portion of these accounts will be payable when the participant elects to withdraw or the sponsor elects to distribute the participant's account balance from the Plan.

Administrative Expenses

The majority of expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses.

Note 3 - Information Certified by the Plan Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Principal Trust Company, a custodian of the plan.

Note 4 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, using the following measurements:

Level 1 Fair Value Measurements – the fair value of mutual funds is based on quoted net assets values of the shares as reported by the fund. The mutual funds held by the Plan are open end mutual funds registered with the U. S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Fair Value Measurements – Pooled Separate Accounts are valued using Net Asset Value per share (NAV) practical expedient where the NAV of units held by the plan are based on the fair value of the underlying investments. The Plan has no unfunded commitments related to the pooled separate account and redemptions and subscriptions are permitted daily. The NAV is not a publicly quoted price in an active market, but it is available to investors and is the basis for current transactions; therefore, it is considered to have a readily determined fair value. The NAV is calculated in a manner consistent with GAAP in accordance with investment company measurement principles. The Pooled Separate Accounts were previously not included in the fair value hierarchy because fair value was not considered readily available.

There have been no changes in these methodologies during the years ended December 31, 2024 and 2023. The following table sets forth, by level within the fair value hierarchy, the Plan's fair value.

Interest earned on loans to participants totaled \$32,619 and \$23,674 during the Plan years ended December 31, 2024 and 2023, respectively.

Note 6 - Party-in-Interest and Related Party Transactions

Plan investments are managed by Principal Trust Company, the Plan custodian, and therefore these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

Note 7 - Income Tax Status

The Plan originally effective January 1, 2003, adopted the Flynn, Shojinaga & Associates Pre-approved Prototype Cross-Tested/Age-Weighted 401(k) Profit Sharing Plan Document which was determined to be in accordance with applicable sections of the Internal Revenue Code (IRC) as documented in a letter from the Internal Revenue Service dated October 5, 2001. The Plan has been amended several times since the receipt of the original determination letter.

The Plan document was restated as required for EGTRRA effective January 1, 2002 under a Pre-approved Prototype Non-Standardized 401(k) Plan Document. The IRS determination letter for this document was dated March 31, 2008.

The Plan document was restated as required for PPA effective January 1, 2016 under a Pre-approved Prototype Volume Submitter 401(k)/Profit Sharing Plan Document provided by CCH Incorporated, DBA FT Williams. The IRS Determination letter for this document was dated March 31, 2014.

Note 7 - Income Tax Status (continued)

The Plan document was restated as required for POST PPA effective January 1, 2024, and adopted the CCH Incorporated 401(k)/Profit Sharing Non-Standardized Plan. The Internal Revenue Service has determined and informed CCH Incorporated by a letter dated June 30, 2023, that the Plan, related trust, and adoption agreement are designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management of the Plan believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements in order to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's open tax years for the prior three years are subject to examination by the Internal Revenue Service.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. The investments are not insured by the Federal Deposit Insurance Corporation (FDIC) or any other government agency and are not bank guaranteed. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 9 - Subsequent Events

The Plan Sponsor has evaluated subsequent events through September 15, 2025 which is the date the financial statements were available to be issued.
