**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the CrowdStrike, Inc. Retirement Trust (the “Plan”) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of plan provisions.

General: The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of CrowdStrike, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). CrowdStrike, Inc. (the “Company”) is the Plan’s sponsor and serves as plan administrator.

Effective July 23, 2024, Sequoia One 401(k) Plan, a Professional Employer Organization Plan, was merged with the Plan. The merger was limited to the participant accounts of Bionic Stork Inc. As a result of the merger, participant accounts totaling \$718,630 were transferred to the Plan.

Eligibility: Employees of the Company are eligible to participate in the Plan upon reaching age 18.

Contributions:

*Participant contributions* – Each year, participants may contribute between 1% and 70% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and will have that deferral increased annually by 1% until a deferral rate of 6% is reached.

*Employer matching contributions* – The Company may elect to make discretionary matching contributions to the Plan, equal to a uniform percentage of salary deferrals. The discretionary employer match for the 2024 and 2023 plan years was calculated at 50% of the participant’s annual contributions, limited to 1% of eligible compensation. The Company made a discretionary matching contribution of \$8,940,000 subsequent to year end, which is recorded as a receivable as of December 31, 2024. The Company made a discretionary matching contribution of \$6,906,679 during 2024 related to the 2023 plan year, which is recorded as a receivable as of December 31, 2023.

*Employer profit sharing contributions* – The company may elect to make discretionary profit sharing contributions to the Plan. Profit sharing contributions are allocated to participants in the same proportion as a participant’s compensation bears to the total of all participants’ compensation. There were no employer profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contributions is determined based on participant's hire date and years of continuous service. Participants hired prior to March 8, 2016, are vested immediately. Participants hired after March 8, 2016, are vested subject to one year of service. Participants hired after January 1, 2020, are vested based on years of continuous service with increases in increments of 25% per year starting after one year of service, fully vesting after four years.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 10 years. Under the terms of the Plan Agreement, participant loans will bear a reasonable rate of interest determined by the plan administrator. Principal and interest are paid ratably through payroll deductions on at least a quarterly basis. As of December 31, 2024, the rates of interest on outstanding loans ranged from 5.25% to 10.50%, with various maturities through June 2034.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive their account balance as a lump-sum amount or as installment payments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and will first be used to pay administrative expenses under the Plan. To the extent that forfeitures are not used to reduce administrative expenses under the Plan, forfeitures will be applied to reduce the contributions of the employer. Forfeitures in the amount of \$249,324 were used to reduce the Company's matching contributions in 2024. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$252,564.28 and \$168,986, respectively.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP), using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation: The investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income Recognition: Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes Receivables from Participants: Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative plan fees. Investment-related expenses are included in net appreciation in fair value of investments.

Excess Contributions Payable: Excess contributions payable represent amounts refunded to participants after year end to comply with regulatory contribution limitations.

Subsequent Events: The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds and money market funds)* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective trusts* – Units held in collective trusts (CT) are valued using the NAV as a practical expedient of the CT as reported by the CT managers. The NAV as a practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities. This NAV as a practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments and redemption restrictions at December 31, 2024.

*Self-directed brokerage accounts* – Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Participants invest in this self-directed brokerage account to invest in an additional selection of securities.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – TAX STATUS**

The Plan Document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Plan. The Plan Administrator has evaluated the Plan's tax positions as of December 31, 2024 and 2023, and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

**NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity Management & Research Company LLC (FMR) and Fidelity Institutional Asset Management (FIAM). Fidelity Management Trust Company is the custodian of the Plan and an affiliate of FMR and FIAM and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Notes receivable from participants also qualify as exempt party-in-interest transactions.

**NOTE 8 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.
