Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

Note 1 - Plan Description

The following description of Swiss Steel USA, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Swiss Steel USA, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary 401(k) contributions up to maximum tax-deferred limitations established by the Internal Revenue Code. Eligible participants are automatically enrolled in the Plan, and a participant's compensation will be reduced by a plan-determined pretax payroll deduction percentage of 3 percent unless the participant elects not to participate or selects an alternative deduction percentage. The Plan allows participants to contribute a portion of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan includes an automatic escalation provision for pretax deferrals. Participants who defer between 1 percent and 10 percent of compensation as a pretax deferral will see an automatic 1 percent increase to their election each January until they make an election to cancel the automatic escalation feature.

The Plan provides for quarterly employer discretionary profit-sharing contributions. During 2024, the quarterly employer discretionary profit-sharing contribution was approximately 4 percent of eligible compensation. The Plan also provides for a safe harbor contribution where all employee elective deferrals are matched by the Company at 100 percent on the first 1 percent of eligible compensation deferred by the participant and 50 percent of eligible compensation deferred by the participant from 2 to 6 percent, subject to a maximum match equal to 3.5 percent of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may also make in-service withdrawals from their 401(k) accounts and after-tax and rollover contributions upon reaching age 59½.

Hardship Withdrawals

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. The Company must approve any such hardship withdrawals.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts, if they meet the hardship withdrawal requirements, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The participant notes receivable are secured by the balance in the participant's account and bear interest at rates determined in accordance with the Plan. Principal and interest are paid ratably through monthly payroll deductions.

Vesting

Participants are immediately 100 percent vested in employee elective, rollover, after-tax, and safe harbor contributions and any income or loss thereon. Vesting in the Company's profit-sharing portion of their accounts, plus actual earnings thereon, is based on years of service, as defined by the plan document. Participants with less than two years of service are 0 percent vested, and participants with more than two years of services are 100 percent vested. Participants become 100 percent vested due to death, disability, or reaching normal retirement age.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

Party-in-interest Transactions

Certain plan expenses are paid by the Company. Certain plan assets are in investment funds managed by Matrix Trust Company or its affiliates. Matrix Trust Company is the custodian of the Plan. These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment. All other investments are valued based on quoted market prices. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 1, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Matrix Trust Company (the "Custodian") holds the Plan's investments and executes all related transactions during the periods under audit. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Note 5 - Fair Value Measurements (Continued)

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
