### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The Heat and Frost Insulators and Asbestos Workers Health and Welfare Trust Fund (the "Fund") is a multi-employer welfare benefit plan providing hospital, medical, dental and vision benefits as detailed in the summary plan description for eligible participants and their dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

For certain eligible active participants, death benefits, life insurance and/or accidental death and dismemberment benefits are also provided, with lower amounts of coverage for dependents of eligible participants.

The Fund provides a \$15,000 mortuary death benefit for eligible retirees. Retirees can make self payments to obtain dental and vision benefits.

The Fund is now, and has been at all times since its inception on August 1, 1951, established and maintained pursuant to collective bargaining agreements between International Association of Heat and Frost Insulators and Allied Workers Local No. 5 (Union) and Western Insulation Contractors Association, Southern California Chapter (Association), an employers' bargaining organization, and that such collective bargaining agreements have been and are now the subject of good faith bargaining between such Association and the Union.

The Fund documents include detailed rules for each situation. Participants should refer to the Fund agreement and any amendments regarding specific provisions of the Fund.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are maintained on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**C. Contributions**

Employer contributions as reported are contributions made by employers on behalf of employees for the hours worked during the year. Employer contributions receivable is based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

Retiree and COBRA contributions, which vary according to the levels of participation elected and dependent status, are accounted for and reported in accordance with the rules of the Fund.

**D. Employer Payroll Compliance**

Remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll audit program.

**E. Tax-Exempt Status**

No provision for federal or state income tax is made. The Fund has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**F. Investment Valuation and Income Recognition**

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are quoted prices for identical instruments in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable data.

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds and some government debt securities recorded at fair value based on quoted market prices. Level 2 investments consist of government and corporate debt securities that are valued using matrices of trades in similar securities or third party pricing vendors and money market funds are recorded at amortized cost, which approximates fair value.

Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the current (market) value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and unrealized appreciation of investments results in differences in reporting on the financial statements and Form 5500.

**G. Concentration of Employer Contributions**

The December 31, 2024 employer contributions receivable includes \$837,552 from seven significant employers. Employer contributions from seven employers totaled \$9,911,913 or 54% total employer contributions for the year ended December 31, 2024. The December 31, 2023 employer contributions receivable includes \$873,064 from six significant employers. Employer contributions from these eight employers totaled \$9,978,858 or 51% total employer contributions for the year ended December 31, 2023.

**H. Risks and Uncertainties**

Fund investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**I. Reclassification**

Certain 2023 balances have been reclassified to conform to the 2024 financial statement presentation.

**NOTE 3 - ESTIMATED BANK HOUR LIABILITY**

In general, participants must work 120 hours a month to maintain eligibility. However, subject to certain limitations provided in the Fund, active participants may accumulate excess hours in a "bank" account. These hours provide the member with eligibility where less than 120 hours are reported.

If a participant works more than 120 hours in any month, the excess hours will be credited to their hour bank, up to a maximum of 30 hours per month. In no event will a participant's hour bank exceed 240 hours for Maintenance Workers and 360 hours for Mechanics effective April 1, 2021.

The cost of providing coverage for such accumulated eligibility is an estimate based on information provided by the Fund. At December 31, 2024 and 2023, the estimated bank hour liability was 1,729 man-months totaling \$2,752,577 and 1,850 man-months totaling \$2,785,562, respectively.

**NOTE 4 - ESTIMATED FUTURE BENEFITS BASED ON PARTICIPANTS' ACCUMULATED ELIGIBILITY**

In order to properly match the eligibility earned for hours worked in the last two months of the year to the estimated benefit costs of eligibility to be incurred by the Fund in the subsequent two month period, future benefits have been estimated as follows:

**NOTE 7 - CONCENTRATION OF CREDIT RISK**

During 2024, the Plan maintained bank accounts with cash balances in excess of the federally insured limit of \$250,000 per bank. The amount in excess of the limit was subject to risk if the financial institution did not perform. The Plan has not incurred any losses on the uninsured balances.

**NOTE 8 - SUBSEQUENT EVENTS**

The board of trustees adopted Amendment #2025-1, effective January 1, 2025, which implements an Early Retiree Health Reimbursement Arrangement Benefit Account based on age and service.
