In accordance with the applicable provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974, we have performed an actuarial valuation of the Plan as of December 31, 2024, for the plan year ending December 31, 2024. The actuarial valuation was performed using employee census data and financial information as of the December 31, 2024, valuation date, furnished by Law Offices of Eric L. Nesbitt, PC. Although we have not performed a detailed audit of the data provided, we have reviewed the data for reasonableness and consistency. The results of this review along with supporting data are set forth in the following report. Included in the report is a description of the principal plan provisions upon which the valuation is based.

As part of this valuation and in accordance with the Section 436 of the Internal Revenue Code and the Pension Protection Act of 2006, I have determined that the Adjusted Funding Target Attainment Percentage (AFTAP) of the Plan for 2025 is 200.19% (see attached AFTAP Calculation Report). A Plan's AFTAP determines whether it is subject to new restrictions on plan amendments, lump-sum distributions or benefit accruals effective for plan years beginning after December 31, 2007. Based on the Plan's 2025 AFTAP exceeding 90%, there will be no restrictions on the Plan until at least October 1, 2026.

On the basis of the foregoing, we hereby certify that, to the best of our knowledge and belief, all costs, liabilities and other factors under the Plan were determined in accordance with generally accepted actuarial principles and practices which are consistent with the applicable Guides to Professional conduct, amplifying Opinions and supporting Recommendations of the American Academy of Actuaries. We further certify that, in our opinion, the actuarial assumptions, methods and techniques used (a) in the aggregate are reasonable and (b) in combination represent our best estimate of the anticipated experience under the Plan. To the best of our knowledge, the report is complete and accurate, and the information presented herein, in our opinion, fully and fairly discloses the actuarial position of the Plan.
