Note 1: Description of Plan:

The following description of BioSpectra 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of Plan provisions.

General

The Plan is a defined contribution plan covering all full-time employees of BioSpectra, Inc. (the Employer), who have three consecutive months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a specific percentage or dollar amount from annual compensation, as defined in the Plan. Participants are permitted to change their rate of elective contribution as desired. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a broad range of investment fund alternatives issued by American Funds that currently includes 31 different investment funds. The plan was amended in January of 2022 to include a ROTH option for after-tax contributions.

The Employer may make a discretionary contribution into the plan. Currently this contribution is 200% of the first 4% of base compensation that a participant contributes to the Plan. The matching contribution is invested by direction of each employee for all contributions made on his or her behalf. Contributions are subject to certain limitations. Employee and employer contributions are recognized as income based on the date deferrals are withheld from employee payroll.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and Plan earnings, and is charged with an allocated portion of the Plan's expenses, if any. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan: (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after the earlier of five years of credited service, or if death or disability (as approved by social security) ends the participant's employment, or when the participant meets the conditions for retirement. The vesting schedule is as follows:

Less than 1 years	0%
1 years	20%
2 years	40%
3 years	60%
4 years	80%
5 years or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The applicable interest rate is determined at the time of each loan. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Benefits are recorded when paid.

In service distributions of vested balances may be made to a Participant who has not separated from service provided the Participant has attained age 59 ½. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or take distributions that meet federal minimum distribution requirements. Upon termination of service due to other reasons, if the participant's vested interest is \$5,000 or less, he or she is required to take a lump-sum distribution. If the participant's vested interest is more than \$5,000, a lump-sum distribution is optional. For optional forms of benefits, refer to the Plan agreement.

Note 2: Summary of Significant Accounting Policies:

Forfeitures

Under the terms of the Plan, all forfeitures from terminating participants will be applied on the last day of the plan year in which the forfeiture becomes available to reduce future employer contributions. In 2024 employer contributions were reduced by \$49,745 from forfeited nonvested accounts.

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Mutual fund investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement dates. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation(depreciation) includes the Plan's gains and losses on investments bought and sold, as well as, held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Because these loans are secured by amounts in the employees' separate accounts, management does not believe that it is necessary to establish an allowance for doubtful accounts.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer, including fidelity bonding and the annual audit, are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation(depreciation) in fair value of investments.

Note 3: Information Prepared and Certified by the Custodian:

The following information included in the accompanying financial statements was obtained from data prepared and certified as complete and accurate by Capital Bank and Trust Company, the Custodian.

Note 4: Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). No Level 2 or 3 inputs were applicable to the Plan.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5: Plan Termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

In the event of Plan termination, participants would become 100% vested in their employer contributions. The Employer will direct the distribution of account balances as permitted by the Plan.

Note 6: Tax Status:

The Plan is based on a prototype plan of N.A. Falcone & Associates Inc, which received its determination letter from the Internal Revenue Service on June 30, 2020, and is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 8: Withdrawals Requested But Not Paid:

At December 31, 2024, there was no withdrawal request that was not paid until after year-end.
