Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The Southern California Lumber Industry Welfare Fund (the "Plan") was organized to provide medical, surgical, hospital, dental and other benefits to employees of companies that have signed appropriate collective bargaining agreements. The Plan is funded by contributions from those companies on behalf of participating employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The disbursements of the Plan are under the joint control of labor and management trustees.

The Plan adopted the Select Choice Plan effective September 1, 2008. This plan provides flexibility in the selection of benefit options at a lower cost. The Select Choice Plan does not provide a second HMO as an alternative medical plan choice.

The Plan adopted the Select Choice Plan – Modular Group effective February 1, 2015 for a new group of participating employers.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions are made by employers in accordance with the collective bargaining and participation agreements at a fixed rate per hour or per month. Employer contributions, as reported, are contributions made by employers on behalf of employees for months worked during the year. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers' payroll records. The system of internal control provides for examination of employers' records under a separate payroll compliance program.

E. Benefits

Medical, dental, vision and prescription claims are self-funded. Prepaid medical, prepaid dental, stop loss and life and disability insurance benefits are funded by monthly premium payments to Plan providers.

F. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are based on quoted prices for identical instruments in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The following tables summarize the Plan’s investments at December 31, 2024 and 2023 based on the inputs used to value them:

Level 1 investment consists of a mutual fund traded on a national exchange. Level 2 investment consists of a money market fund reported at amortized cost, which approximates fair value.

Purchases and sales of securities are recorded on the trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the current (market) value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the unrealized appreciation of investments results in differences in reporting on the financial statements and Form 5500.

G. Eligibility

If a participant works or is paid for the required hours and contributions are made on his or her behalf by a contributing employer, the participant becomes eligible the first day of the second month following the completion of the required hours.

G. Eligibility (Continued)

In addition, a participant may receive extended coverage if he or she was previously eligible and returned to work within 90 days of the loss of eligibility, made self-payments, left work because of a disability, or was disabled when eligibility terminated.

For the Select Choice Plan – Modular Group, eligibility is established on a quarterly basis for “Eligibility Quarters” based on hours worked in “Work Quarters”. To establish eligibility during an Eligibility Quarter, employees must work for a contributing employer at least 360 hours in the immediately preceding Work Quarter.

H. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risk and Uncertainties

Plan investments are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

The estimated amounts due for claims incurred but not reported or paid of \$901,600 and \$986,400 as of December 31, 2024 and 2023, respectively, represent the estimated reserves needed to fund the run-off of claims for self-funded programs and claims.

NOTE 6 - ESTIMATED BANK HOUR LIABILITY

For Select Choice Plan – Modular Group, participants are allowed to accumulate a maximum of seven hundred twenty (720) hours to provide future eligibility. Participants who have at least three hundred sixty (360) hours reported in a given quarter may use their hour banks to obtain eligibility for the quarter. The estimated future benefits based on participants' accumulated eligibility provision is a two-quarter maximum (720 hours) per participant. As of December 31, 2024 and 2023, the estimated bank hour liability was 168 participant-quarters totaling \$589,176 and 201 participant-quarters totaling \$569,835, respectively.

NOTE 8 - TERMINATION

In the event of termination, the trustees shall wind up the affairs of the Plan. Any and all expenses of the Plan shall be paid, and any remaining assets shall be allocated among participating employees and their beneficiaries in accordance with the provisions of the Internal Revenue Code and ERISA. In no event shall the remaining monies or assets of the Plan be paid to or recoverable by any employer, employer association or labor organization, nor be used in any way other than for the benefit of participants and their beneficiaries.

NOTE 9 - PLAN AMENDMENT

The Plan approved Amendment No. 1 to Select Choice Plan to continue coverage for telehealth visits after the end of the COVID-19 emergency periods, effective May 12, 2023.

The Plan approved Amendment No. 2 to Select Choice Plan to adopt OptumRx's Price Edge, Comprehensive Utilization Management and Vigilant Drug Programs and to incorporate a description of the programs under the Prescription Drug Benefits section of the Plan, effective October 1, 2024.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 4, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required recognition or additional disclosures in these financial statements.



