### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of the Woods Hole Oceanographic Institution Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by the qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## *Notes to Financial Statements*

### **Note 1 - Description of Plan**

The following description of the Woods Hole Oceanographic Institution Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. In the event that there is a conflict between information provided in this document and the Plan agreement, the terms in the Plan agreement will prevail.

#### **General**

The Plan was established by Woods Hole Oceanographic Institution (the "Employer") and restated on October 6, 2024. Empower Annuity Insurance Company of America and Empower Trust Company ("Empower") serve as the Custodians and recordkeeper for the Plan. The Woods Hole Oceanographic Institution Defined Contribution Retirement Plan Committee is the Plan's administrator. The Plan is a defined contribution plan with a cash deferred arrangement covering all employees except (1) any person who is identified as a guest, fellow, student, post-doctoral scholar or with a work-study program, (2) any person who is covered by a collective bargaining agreement, unless such agreement specifically provides for participation in the Plan, (3) any person who is categorized as an independent contractor, leased employee, or other type of worker or service provider that is not a common law employee, and (4) employees who are non-resident aliens and who receive no earned income from the Employer which constitutes income from sources within the United States ("Participants"), as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants direct the investment of all contributions into various investments offered by the Plan.

#### **Participant Contributions**

Participants may defer a percentage of their eligible compensation, as defined by the Plan, subject to dollar limits set by Federal law. The Plan provides for automatic deferrals of 6% of eligible compensation unless an alternative election is made, which are processed on the 1st day of the pay period following the date the employee meets the eligibility requirements. Beginning May 1 of the Plan year following the Plan year in which automatic deferrals first apply to a participant, there will be a 1% increase each May 1, up to a maximum of 15%, unless the participant makes an alternative election. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("Participant Rollovers").

#### **Employer Nonelective Contributions**

An Employee, as defined within the Plan agreement, may be entitled to Employer nonelective contributions (formerly "base" contributions) only if the employee has satisfied the applicable requirements to participate in the Plan and has become an "Eligible Employee," as defined in the Plan agreement.

### **Note 1 - Description of Plan (Continued)**

#### ***Employer Nonelective Contributions (Continued)***

The nonelective Employer contribution made on behalf of an eligible qualified employee for a payroll period is equal to a percentage of regular compensation, as defined within the Plan agreement, and is based on the employee's age and service "points." An Eligible Employee's points are determined by taking the sum of the Eligible Employee's whole years of retirement service (as defined by the Plan agreement), plus the employee's age as of most recent birthday, as of the end of the payroll period. The base contribution rate ranges from 8% to 12% depending on the total points of the participant, as defined.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocations of the Employer's contributions and Plan investment earnings/losses, and reduced by administrative expenses, benefit disbursement processing fees and loan fees, when applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in all voluntary contributions, including rollovers, and the earnings thereon. Participants are fully vested in all Employer contributions after three years of vesting service. A participant also becomes fully vested upon death or disability, as defined by the Plan, or upon reaching normal retirement age (65), while employed by the Employer.

#### ***Notes Receivable from Participants***

Subject to approval by the Plan administrator, participants may borrow a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A loan may be made from participant contribution accounts only. A participant may only have one loan outstanding at a time. Loan terms generally range from one to five years (up to thirty years for the purchase of a primary residence). The loans are secured by the balance in the participant's account and bear interest at a prime rate as stated in The Wall Street Journal plus 1%. Principal and interest are paid ratably through payroll deductions.

### **Note 1 - Description of Plan (Continued)**

#### ***Payment of Benefits***

In-service withdrawals from any account fully vested by the participant are permitted only upon reaching age 59½. Participants can withdraw amounts from their rollover accounts at any time. Hardship withdrawals may be taken from a participant's deferral or rollover account only. Participants are entitled to their total vested account balance upon death, disability, retirement, or termination of employment. A participant may elect to receive a lump-sum amount equal to the value of his or her accounts, a fixed period option for any number of years between five and thirty years, installment payments, or a flexible payment amount elected by the participant (or beneficiary). Upon termination, if a participant's account balance exceeds \$1,000 but does not exceed \$5,000, and the participant does not elect to take a distribution, the Plan administrator may make a lump-sum distribution to a direct rollover individual retirement account. If a participant's vested account balance is \$1,000 or less, and the participant does not elect to take the distribution, the Plan administrator may distribute the participant's vested account balance directly to the participant without consent.

#### ***Forfeitures***

Forfeited balances are retained by the Plan and may be used to restore to the accounts of re-employed participants who previously forfeited balances and return before the five consecutive one-year breaks in service expire, to reduce Employer nonelective contributions, or permitted to be used to pay eligible Plan expenses. At December 31, 2024 and 2023, there were unused forfeited balances of \$63,668 and \$151,044, respectively. During 2024, \$367,132 of forfeitures were used to offset a portion of the 2024 and 2023 Employer nonelective contributions and \$11,588 was used to offset a portion of Plan expenses. Subsequent to year end, \$91,984 of the forfeiture balance was used to offset the Employer nonelective contribution for the plan year 2024 funded in 2025.

### **Note 2 - Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

#### ***Investments, Investment Valuation and Income Recognition***

Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Note 2 - Summary of Significant Accounting Policies (Continued)**

#### ***Contributions***

Contributions from Plan participants and the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### ***Notes Receivable from Participants***

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from those estimates.

#### ***Administrative Expenses***

Expenses incurred in the administration of the Plan are paid out of the assets of the Plan unless paid by the Employer at its sole discretion. Investment related expenses are netted against net appreciation of fair value of investments. Custodian expenses are paid for by the Plan.

#### ***Subsequent Events***

The Employer and Plan management have evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued. No significant matters were identified for disclosure in the evaluation.

### **Note 3 - Information Certified by the Custodians**

Plan investments are held by Empower Annuity Insurance Company of America and Empower Trust Company ("Empower"). The fair and contract values of all investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024, including interest and dividends and net appreciation in fair value of investments, are reported to the Plan and certified as complete and accurate by Empower. Notes receivable from Participants and information included in Schedule H, Line 4i - Schedule of Assets (Held at End of Year) have also been derived from information certified by Empower. The Plan offers investment choices to allow Participants to create a diversified portfolio of assets based on the Participant's risk tolerance. Participants may invest their accounts in a combination of guaranteed investment contracts, self-directed brokerage accounts (which include various mutual fund options) and mutual funds.

### **Note 4 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level 1*      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2*      Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3*      Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***Mutual Funds***

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### ***Self-Directed Brokerage Accounts***

Self-directed brokerage accounts consist of investments in mutual funds and are valued at the daily closing price as reported by the fund. Mutual funds held in self-directed brokerage accounts are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5 - Fully Benefit-Responsive Investment Contract**

The following is a description of the investments and valuation methodologies for the fully benefit-responsive investment contract:

***New York Life Guaranteed Interest Account Class 10 Fund***

The New York Life Guaranteed Interest Account Class 10 Fund ("NYLGIAC") is a guaranteed investment account ("GIA") backed by the general account of New York Life. The GIA does not have specific underlying assets assigned. The GIA issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of Empower or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1.00%. The crediting interest rate was 3.10% as of December 31, 2024. The average yield was 3.00% in 2024.

### **Note 5 - Fully Benefit-Responsive Investment Contract (Continued)**

Because the NYLGIAC guaranteed investment account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment. The guaranteed interest account contained unallocated funds (forfeitures) which may be withdrawn or applied at contract value and therefore are presented on the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or other Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan Participants are probable of occurring.

The guaranteed investment and guaranteed interest accounts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

### **Note 6 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

### **Note 7 - Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants would become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to Participants' accounts and distributed in such a manner as the Employer may determine.

### **Note 8 - Tax Status**

The Plan adopted the Empower Retirement, LLC 403(b) Volume Submitter Plan document that received its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("Code"). The Plan administrator believes the Plan is currently being operated in compliance with the applicable provisions of the Code, and therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9 - Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Charles Schwab and Empower, the Custodian, as defined by the Plan; therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Empower and Charles Schwab of \$103,919, which were not covered by revenue sharing. The Employer pays directly any other fees related to the Plan's operations. Notes receivable from Participants also qualify as exempt party-in-interest transactions.

***Note 11 - Delinquent Participant Contributions***

Under U.S. Department of Labor Regulation Section 2510.3-102, 403(b) Plan related salary deferrals and loan repayments withheld from employees' paychecks must be deposited into the Plan as soon as reasonably possible. When this regulation is not satisfied, the Plan Sponsor has engaged in a prohibited transaction. During the years ended December 31, 2024 and 2023, \$689 and \$1,881, respectively, of participant contributions and loan repayments were not remitted to the Plan by their respective year ends. The Employer is working to make a correction, including lost earnings, for the 2024 delinquent transaction in 2025. The Employer made a correction, including lost earnings, for the 2023 delinquent transaction during the year ended December 31, 2024.

***Supplementary Information***
