Opinion

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The Santa Monica UNITE HERE Health Benefit Plan (the “Plan”) is a multiemployer health benefit plan created to provide medical, vision, dental, prescription drug, life insurance, accidental death and dismemberment (AD&D) and member assistance benefits for eligible active employees and their dependents. It is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended.

THE PLAN DOCUMENTS INCLUDE DETAILED RULES FOR EACH SITUATION. PARTICIPANTS SHOULD REFER TO THE PLAN AGREEMENT AND ANY AMENDMENTS REGARDING SPECIFIC PROVISIONS OF THE PLAN.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accounts of the Plan are maintained on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Employer Contributions

Employer contributions, as reported, are contributions made by employers on behalf of employees for months worked during the year. Employer contribution rates range from \$3.38 to \$7.93 per hour worked, with two employers paying monthly fixed rates from \$470 to \$2,014.65 per eligible participant. Employer contributions receivable is estimated based on contributions received subsequent to the end of the year. No allowance is provided for estimated uncollectible accounts.

D. Employer Payroll Compliance Program

Employer remittance reports were accepted as submitted, without examination or verification of employers’ payroll records. The system of internal control provides for examination of employers’ records under a separate payroll compliance program.

E. Investment Valuation and Income Recognition

Accounting standards establish a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market.

Level 1 – Inputs are based on quoted prices in active markets.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

E. Investment Valuation and Income Recognition (Continued)

Level 3 – Inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

E. Investment Valuation and Income Recognition (Continued)

(1) U.S. Real Estate Investment Fund LLC is a limited liability company that invests in a pool of real estate that are diversified by geography and property type, with a focus on yield-driven investments and, to a lesser extent, or value-added investments.

Realized gains and losses on sale of investments for financial statement purposes is the difference between proceeds from the sale or redemption of for financial statement purposes is the difference between proceeds from the sale or redemption of investments and the cost (normally historical cost) of the investment sold. Form 5500 requires realized gains and losses to be reported as the difference between proceeds from the sale or redemption of investments and the current (market) value of the investment at the beginning of the year, for those investments on hand at the beginning of the year, or the purchase price of investments acquired during the year. The different methods of computing realized gain or loss and the unrealized appreciation in fair value of investments results in differences in reporting on the financial statements and Form 5500.

F. Property and Equipment

Property and equipment are stated at cost. Depreciation and amortization are determined for related groups of assets under the straight-line method, based upon their estimated useful lives. Estimated useful lives of the assets range from 5 to 40 years. Minor renewals or replacements and maintenance and repairs are expensed. Major replacements and improvements are capitalized. Construction for the new medical clinic is in process and has not been placed into service yet. Accordingly, no depreciation expense has been recorded for these assets during the year ended December 31, 2024. Depreciation will commence once construction is completed, and the assets have been placed into service.

G. Tax-Exempt Status

No provision for federal or state income tax is made. The Plan has received tax-exempt status from the federal government under Internal Revenue Code Section 501(c)(9) and the state of California under Revenue and Taxation Code Section 23701i.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

Plan investments are exposed to various risks such as interest rate, market fluctuations and credit risk. Due to the level of risk associated with investments and the level of uncertainty with respect to changes in value of investments, it is at least reasonably possible that changes in risk in the near term would materially affect the amounts reported in the financial statements.

J. Eligibility

Employees and their dependents, as defined, become eligible for benefits on the first day of the third month after the employee has worked for at least 60 hours in each of three consecutive months and the employer has made the required contributions to the Plan.

After establishing eligibility, an employee remains eligible as long as he or she continues to have worked 60 or more hours each month for an employer or employees who make the required contributions. The hours worked in one month continue the employee's eligibility for the third month after the month in which the 60 hours are worked.

Employees and their dependents, as defined in the Event Center Plan, become eligible for benefits on the first day of the fifth month after the employee has worked for at least 80 hours in each of five consecutive months and the employer has made the required contributions to the Plan.

After establishing eligibility, an Event Center Plan employee remains eligible as long as he or she continues to have worked 80 or more hours each month for an employer or employees who make the required contributions. The hours worked in one month continue the employee's eligibility for the fifth month after the month in which the 80 hours are worked.

NOTE 3 - FUNDING POLICY

The Board of Trustees has established a funding policy and method in order to promote the purpose of the Plan and to ensure compliance with ERISA. Each employer contributes to the Plan such amounts and at such times as are required by the applicable provisions of the collective bargaining agreement. Contributions are made on a monthly basis throughout the year.

In some situations participants who would otherwise lose eligibility may continue their benefits for a limited period by making self-payments.

NOTE 4 - ESTIMATED OBLIGATION FOR CLAIMS INCURRED BUT NOT REPORTED

The \$785,042 and \$824,853 obligations for claims incurred but not reported or paid as of December 31, 2024 and 2023, respectively, represent the estimated amounts needed to fund the run-off of self-funded prescription drug claims.

NOTE 5 - ESTIMATED FUTURE BENEFITS BASED ON PARTICIPANTS' ACCUMULATED ELIGIBILITY

In order to properly match the eligibility earned for hours worked in the last three months of the year to the estimated benefit cost of eligibility to be incurred by the Plan in the subsequent three month period, the Plan recorded accumulated eligibility credits of \$34,648,684 and \$30,680,621 as of December 31, 2024 and 2023, respectively.

NOTE 7 - TERMINATION

In the event of Plan termination, the trustees shall account for any and all assets. After payment of all Plan liabilities, any remaining funds shall be used to continue benefits of the purpose and type originally intended to eligible participants until such funds are exhausted.

NOTE 8 - RELATED PARTY TRANSACTIONS

On February 2022, the Board of Trustees established the UNITE HERE Local 11 Benefits Administrative Office (the "Benefits Administrative Office") to provide additional administrative services necessary for the operation of the Plan's group health plan. During the years ended December 31, 2024 and 2023, the Plan paid \$1,190,000 and \$540,000 in reimbursements to the Benefits Administrative Office and \$166,554 and \$91,937 in related expenses.

NOTE 9 - BUILDING LEASE

In July 2023, the Plan entered into an agreement to lease office space for a new medical clinic for MLK Community Healthcare Plan participants. The office space is currently under construction and no rent payments were made in 2024 and 2023, respectively.

NOTE 10 - SUBSEQUENT EVENTS

The Plan will end services with Benefit Programs Administration on July 31, 2025 and will transition to a self-administered plan as soon as administratively feasible.

Management has evaluated subsequent events through August 18, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
