### Note 1 - Plan Description

The following description of PHM Brands, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of PHM Brands, LLC (the "Company") who have completed one month of service. The Plan is not available to nonresident alien employees or leased employees. The entry date for eligible participants is the first day of the month coinciding with or following the satisfaction of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may make contributions of their annual eligible compensation, designated as pretax or after-tax Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant's pretax and Roth 401(k) contributions cannot exceed the maximum amounts allowed by law. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through regular payroll deductions. Eligible participants are automatically enrolled to participate in the Plan at a deferral rate equal to 6 percent of eligible annual compensation, as specified in the plan document, unless they elect not to participate or have specified a different deferral percentage.

Certain participant contributions in 2023 and 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and 2024 and remitted related lost earnings to the Plan in 2024 and 2025.

The Company is required to make matching contributions of 100 percent of the first 1 percent and 50 percent of the next 5 percent of compensation deferred by the participant. For the year ended December 31, 2024, required matching contributions totaled \$192,077, net of forfeitures applied.

The Plan provides for the Company to make a discretionary contribution to participants based on a prevailing wage formula. Participants must be employed on the last day of the plan year and must have completed 500 hours of service. No discretionary contribution was accrued or paid.

The Plan provides for employer matching contributions, not to exceed 4 percent of the employee's deferred compensation. No employer matching contribution was accrued or paid.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, plan earnings, and forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

**Note 1 - Plan Description (Continued)**

***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Required matching contributions are subject to a cliff vesting schedule under which participants are 0 percent vested prior to completing two years of service and become 100 percent vested upon reaching two or more years of service. A participant is 100 percent vested in the Company's discretionary contributions after three years of credited service. A participant is 100 percent vested in the employer match portion of their account after five years of credited service, with 20 percent of the account vesting per year.

Upon reaching the normal retirement age of 65, participants become 100 percent vested in all account balances without regard to the Plan's vesting schedules.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participants' highest outstanding loan balances during the prior 12-month period or 50 percent of their account balances. Participants may have a maximum of one note outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 10.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator, and mature at various dates through August 2029. Principal and interest are paid ratably through monthly payroll deductions.

***Benefit Payments***

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, payment in the form of a lump sum, partial lump sum, or installment in the amount equal to the participant's vested account balance.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. The Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account. The Internal Revenue Service (IRS) requires minimum distributions once a participant reaches age 73 and is no longer employed by the Company.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, there were no balances in forfeited accounts.

The Plan used \$77,962 of forfeitures for the year ended December 31, 2024 to reduce employer contributions.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Dubuque Bank and Trust or its affiliates. Dubuque Bank and Trust is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**December 31, 2024 and 2023**

**Note 1 - Plan Description (Continued)**

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value.

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid. There were benefit payments requested but not paid totaling \$50,229 for the year ended December 31, 2024.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 9, 2025, which is the date the financial statements were available to be issued.

In September 2025, assets of the Company were sold. As a result, employees of the Company will be transferred to the acquiring company and the plan will be assumed by the new company. As of the date the financial statements were available to be issued, there have been no formal amendments to the Plan or operational changes.

**December 31, 2024 and 2023**

**Note 3 - Certified Information**

Mid Atlantic Trust Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Money Market Fund**

The money market fund is valued at the outstanding balance, which is the best estimate of fair value.
