## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Gads Hill Center 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. DESCRIPTION OF PLAN

The following description of the Gads Hill Center 403(b) Plan (the "Plan") is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan document.

General - The Plan is a defined contribution plan established under the provisions of Section 403(b) of the Internal Revenue Code ("IRC"), which includes a qualified cash or deferred arrangement for employees of entities tax-exempt under Section 501(c)(3) of the IRC. The Plan operates for the benefit of eligible employees of Gads Hill Center (the "Organization"), a qualified 501(c)(3) organization. All employees expected to work over 20 hours per week are eligible to contribute elective deferrals into the Plan immediately upon being hired. There is no minimum age requirement. Employees become eligible for discretionary matching and qualified nonelective contributions from the Organization upon completion of two years of service following their hire date. A year of service is defined as 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Organization has appointed an Investment Committee that determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Organization's Board of Directors.

Contributions - Each participant may contribute a specified percentage of pre-tax or after-tax (Roth) compensation, subject to certain IRC limits (\$23,000 and \$22,500 for 2024 and 2023, respectively). Participants who are age 50 or older are eligible to make additional catch-up contributions (\$7,500 for each of the years ended December 31, 2024 and 2023). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization's discretionary matching and qualified nonelective contributions are determined by the Organization on an annual basis. For the year ended December 31, 2024, the Organization matched 100% of participant contributions up to 5% of the employee's salary. No qualified nonelective contributions were made.

Payment of Benefits - On retirement, death, disability, or termination of service, a participant (or, in the event of death, the participant's beneficiary) may elect to receive a lump sum amount equal to the value of the participant's vested account balance. In addition, in-service distributions at age 59½ and hardship distributions are permitted if certain criteria are met. Benefits are recorded when paid.

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of the Organization's contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings

or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants - Participants may borrow from their accounts up to a maximum equal to 50% of their vested account balance or \$50,000. The minimum loan amount is \$1,000 and participants may have no more than two outstanding loans at a time. The loans are secured by the balance in the participant's account and bear interest at rates at 2% above the published prime rate at the date of origination. Loans are to be repaid over a five-year period. Principal and interest are paid ratably through payroll deductions. As of January 1, 2023, the loan policy was modified to allow for loans greater than five years if used for the purchase of a participant's principal residence but cannot exceed 30 years.

Vesting - Participants are immediately vested in their salary reduction, rollover contributions, and the Organization's matching contributions, plus earnings thereon.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principal generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the custodian of the Plan's assets. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan payments and the plan administrator deems the participant loan is in default, the participant loan balance is reduced and a deemed distribution is recorded.

Plan Expenses – Certain expenses of maintaining the Plan are paid directly by the Organization and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants and distributions, and investment

advisory and third-party administrative services, are charged directly to the participant's account and are included in the administrative expenses.

Estimates - The preparation of financial statements in conformity with GAAP requires the plan administrator and record keeper to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events - The Plan has evaluated subsequent events occurring through October 7, 2025, the date that the financial statements were available to be issued, for events requiring recording or disclosure in the Plan's financial statements.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform, and they did not perform, auditing procedures with respect to the information certified by Mid Atlantic Trust Company, the custodian of the Plan, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, except for comparing the information certified by the custodian to information included in the Plan's financial statements and supplemental schedule.

Accordingly, the custodian has certified that the following included in the financial statements and supplemental schedule is complete and accurate:

- Noninterest-bearing cash, investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

4. PARTIES-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the DOL's regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Organization, certain participants, and others. Fees paid by the Plan for the investment management services and administrative expenses qualify as party-in-interest transactions. The Plan allows participants to take loans from their accounts in the Plan, which qualify as party-in-interest transactions.

5. FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820 (“ASC 820”) defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities they are required to be recorded at their fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy which requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

A financial instrument’s categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The standard establishes three levels of inputs that may be used to measure fair value:

Level 1: quoted prices in active markets for identical assets or liabilities;

Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Shares held by the plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. EXCESS CONTRIBUTIONS PAYABLE

The Plan is required to perform certain non-discrimination testing each year. Testing failures may result in refunds of contributions to certain participants. Any amounts owed to participants at year end are included as a liability, with an offset to employee contributions. The Plan had \$2,447 of excess contributions to be refunded as of December 31, 2023. Excess contributions were refunded timely during the subsequent plan year.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become fully vested in their accounts.

8. TAX STATUS

The Internal Revenue Service ("IRS") ruled on March 31, 2017 that the Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the IRS in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for Plan participants under Section 403(b). The plan administrator believes that the Plan is currently designed and operating in accordance with the applicable requirements of Section 403(b) of the IRC and, therefore, believes that the Plan is qualified, and the related custodial accounts are tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require Plan trustees to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS or Department of Labor. The Plan trustees have analyzed the tax positions taken by the Plan and have concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a tax liability or disclosure in the financial statements as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions, generally for three years after returns are filed; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
