- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Plan Description**

The following description of the Foundation 2, Inc. (the “Sponsor”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan with 401(k) features, available to all employees of Foundation 2, Inc. with no minimum age requirement and have one month of service. Employees can enter the Plan the first day of the month after they meet the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and amendments. The Plan was established on January 1, 2002 with the last amendment on March 1, 2024.

*Contributions* - Participants may contribute up to 100% of their eligible compensation, not to exceed the maximum amount allowable under the Internal Revenue Code, to the Plan in the form of a salary deferral. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Sponsor makes safe harbor matching contributions to the Plan. To be eligible for matching contributions, employees will have reached 20 years old and have one year of service. In accordance with the plan document, the Sponsor made safe harbor matching contributions of 100% of participants’ elective deferrals up to 4% of eligible compensation, for the years ended December 31, 2024 and 2023. The plan also allows for discretionary contributions, which are included in employer contributions.

*Participant Accounts* - Each participant’s account is credited with the participant’s contributions and an allocation of (a) the Sponsor’s contributions and (b) plan earnings (expenses). Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may direct the investment of their account balances into any combination of the investment options offered by the Plan.

*Vesting* - Participants are immediately vested in their contributions and employer safe harbor matching contributions.

*Administrative Expenses* - Certain administrative expenses are paid directly by the Sponsor, while other expenses are paid by the Plan.

*Payment of Benefits* - Upon retirement, death, disability or termination of employment, participants may elect to receive a lump-sum distribution equal to the value of the vested portion of their account balance. Vested balances of less than \$5,000 can be distributed in a lump sum without participant election. In-service distributions are allowed for hardship and attainment of age 59 ½ as explained in the plan document. Hardship distributions are only allowed in relation to employee deferral accounts during the participant’s time of employment with the Sponsor.

*Notes Receivable from Participants* - Participants may borrow from their fund account a minimum of \$1,000 up to a maximum of \$10,000 or 50% of their vested account balance, whichever is less. The maximum term of any loan is 5 years. Participants may only have two loans outstanding at any time. The loans are secured by the balance in the participant’s account and bear interest at 2% above the current Wall Street Journal published prime rate which will be monitored and reviewed on a regular basis (notes bear interest at rates ranging from 10-10.5%). Principal and interest are paid ratably through payroll deductions.

*Forfeitures* - Forfeitures of nonvested participant accounts are used to reduce administrative expenses or used to offset employer matching contributions. Forfeitures used during the year to offset employer contributions totaled \$7,627 for the year ended December 31, 2024. There was no balance of non-vested forfeitures as of December 31, 2024 and 2023.

**Note 2 - Summary of Significant Accounting Policies**

*Basis of Accounting* – The financial statements of the Plan are prepared under the accrual basis of accounting.

*Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported changes in net assets during the reporting period. Actual results may differ from those estimates.

*Notes Receivable from Participants* - Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

*Investment Valuation and Income Recognition* - The investment value of each fund represents contributions made, plus the proportionate share of the increase or decrease in the assets of the fund from investment earnings (interest and dividends) realized and unrealized appreciation or depreciation in the fair value of its investments and less amounts used to pay investments and administrative expenses charged by the custodian. Investments are stated at fair value as reported by the custodian. Shares of registered investment companies are valued by the change in market value that represents the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded as of the trade date. Dividends are recorded on the ex-dividend date. The investment income shown on the statement of changes in net assets available for benefits includes the Plan's gains and losses on investments bought and sold, and also those held during the year.

*Payment of Benefits* - Benefit payments to participants are recorded upon distribution.

*Date of Management Review* - Management has evaluated subsequent events through October 8, 2025, the date which the financial statements were available to be issued.

**Note 3 - Information Certified by Plan Custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the years ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid-Atlantic Trust Company (the trustee of the Plan).

**Note 4 - Fair Value Measurement**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies as of December 31, 2024 and 2023.

*Interest-bearing cash:* Consists of deposits in interest-bearing demand and money market deposit accounts held at financial institutions. Valued at the amount on deposit (plus accrued interest), which approximates fair value because the balances are short-term and withdrawable on demand at par.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables present by level, within the fair value hierarchy, the plan investment assets at fair value, as of December 31, 2024 and 2023. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**Note 5 - Plan Termination**

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

**Note 6 - Income Tax Status**

The Plan has adopted a standardized form of a prototype plan. The prototype plan obtained an opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The prototype plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

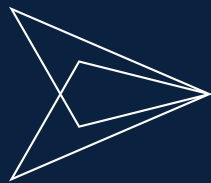
