NOTE 1 - DESCRIPTION OF THE PLAN

General

The following description of Gastroenterology Consultants and Nevada Endoscopy Management 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was established on September 1, 1982 to provide benefits for employees of Gastroenterology Consultants, Ltd & Nevada Endoscopy Management, Inc. (the “Plan Sponsor”) and the employees’ beneficiaries. The Plan is a qualified defined contribution plan covering all employees of the Plan Sponsor, other than certain union employees, leased employees, per diem employees and nonresident aliens, upon completion of six months of service with a minimum age requirement of twenty-one (21). The Plan allows for quarterly entry on January 1, April 1, July 1, or October 1. Employees may enter the Plan on the date coinciding with or next following satisfaction of the minimum age and service requirements. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the “Code”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). A group of shareholders of the Plan Sponsor act as the Plan Trustees. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

The Plan year begins January 1 and ends December 31.

Contributions

The Plan allows for the following types of contributions:

- *Employee Salary Deferral Contributions*
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees may voluntarily contribute a portion of their compensation, subject to various limitations prescribed by the Code.
- *Employee Roth Elective Salary Deferral Contributions*
Participant may make after-tax Roth elective salary deferral contributions to the Plan.
- *Non-Elective Safe Harbor Matching Contributions*
The Plan Sponsor will contribute safe harbor matching contributions equal to 100% of participant salary deferrals up to 3% of compensation, plus 50% of the excess over 3% up to 5% of compensation. The Plan Sponsor made safe harbor matching contributions (less any applicable forfeitures) of \$224,709 and \$227,539 for the Plan years ending December 31, 2024 and 2023, respectively.
- *Discretionary Employer Profit Sharing Contributions*
The Plan Sponsor may make a profit-sharing contribution to the Plan. Such contribution shall be determined by the Plan Sponsor and allocated amongst employee classes at the Plan Sponsor’s discretion. Participants must have at least 1,000 hours of service during the Plan year to be eligible for the contribution. Discretionary employer profit sharing contributions (less any applicable forfeitures) of \$172,034 and \$308,040 were made for the Plan years ending December 31, 2024 and 2023, respectively.

- *Discretionary Employer Matching Contributions*
The Plan Sponsor may make a matching contribution not to exceed 4% of eligible compensation. Participants must have at least 1,000 hours of service during the Plan year to be eligible for the contribution. The Plan Sponsor made no discretionary employer matching contributions for the Plan years ending December 31, 2024 and 2023.

- *Rollover Contributions*
Employees may make rollover contributions from another qualified plan.

Participant Accounts and Allocations

An account is maintained for each participant that consists of contributions, the participant's share of investment gains/losses, interest and dividends, less any distributions to the participant. Investment earnings and losses are allocated to each participant's account based on actual earnings or losses of their selected investments. The Plan allows each participant the ability to self-direct their contributions and investments among various investment options. The Plan allows for certain participants to segregate their investments under a self-directed brokerage account option. All other Plan investments are held in trust by Matrix Trust Company. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their salary deferral contributions, matching contributions, and the non-elective safe harbor employer contributions. Participants vest in discretionary employer profit sharing contributions and gains/losses credited thereon over a six-year period as follows:

Less than 2 years credited service	0%
After 2 years credited service	20%
After 3 years credited service	40%
After 4 years credited service	60%
After 5 years credited service	80%
After 6 years credited service	100%

For vesting purposes, a year of service is equivalent to 1,000 hours of service during the Plan year.

Forfeitures

Forfeited non-vested accounts may be used to pay administrative expenses or to reduce employer contributions at the discretion of the trustees. The forfeitures are used, when and if applicable, when the employer contributions are funded subsequent to year-end.

Retirement

Normal retirement under the Plan is age sixty-five (65).

Payment of Benefits

Payment of benefits may be made at the following times under the Plan: 1) normal retirement, 2) termination of employment of the participant, 3) termination of the Plan, 4) in-service distribution upon attaining age 55, 5) upon demonstration of financial hardship, or 6) death of the participant. The form of benefit payments may be in a single lump sum or periodic installments. The Plan allows for the automatic lump sum distributions of participant account balances that do not exceed \$1,000.

Notes Receivable from Participants

The Plan allows participants to borrow up to the lesser of \$50,000 or 50% of their vested account balance, but no less than \$1,000. Borrowings bear interest at the prime rate plus 2% and are due within five years. If the purpose of the loan is for the acquisition of the Participant's primary residence the period of repayment may exceed five years. Loans are secured by the balance in the participants' account.

Administrative Expenses

The Plan pays certain investment manager, administrator and professional fees. All other expenses incurred for the administration of the Plan are paid by the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earning on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 and 2022. If a participant ceases to make loan payments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Concentration of Credit Risk

The Plan maintains cash in financial institutions which, at times, exceed federally insured limits. The Plan has not experienced any losses in such accounts and the Plan Sponsor believes that the Plan is not exposed to any significant credit risk on cash.

NOTE 3 - SUMMARY OF INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan Administrator has obtained a certification from the Matrix Trust Company, the Custodian, that the information provided to the Plan Administrator by the Custodian is complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset’s or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Level 1 -Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1)

Exchange Traded Funds – Valued at the closing price reported by the fund. Exchange traded funds (ETF) held by the Plan are open-ended management investment companies that are registered with the Securities and Exchange Commission. The shares are traded through-out the day at the market price (Level 1).

Self-Directed Brokerage: Valued based on the underlying investments (self-directed brokerage) traded on the active market or inactive markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INSURANCE COMPANY CONTRACT

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract (GIC) with CMFG Life Insurance Company (CMFG). CMFG maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 2.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Because the GIC is fully benefit-responsive, contract value is the relevant measure for the GIC, as this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value is reported to the Plan by CMFG represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. The GIC allows the insurer to terminate the contract by providing written notice ninety days prior for reasonable cause which includes the Plan's failure to perform as required under the contract, failure to make a contribution as required, the contract value is less than the required minimum contract value, evidence of the Plan failing to remain qualified, the Plan is terminated, the terms of the Plan may have an adverse effect on the obligations of the insurer, or there is evidence that a competing allocation option is included in the Plan.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - INCOME TAX STATUS

The Plan adopted a prototype plan, which obtained a favorable opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has determined that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine examinations by taxing authorities; however, there are currently no examinations for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks.
