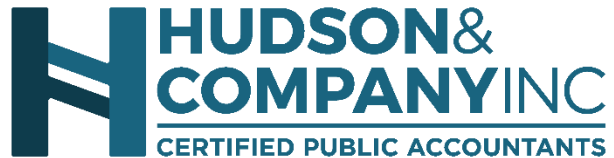

In planning and performing our audit of the financial statements of Shiralian Enterprises, Inc. (the Plan), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be material weaknesses and other deficiencies that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in the Plan's internal control that we consider to be material weaknesses, as defined in the attached schedule.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider deficiencies 2024-001 through 2024-008, as listed in the attached schedule, in the Plan's internal control to be significant deficiencies.

I. CURRENT YEAR OBSERVATIONS AND RECOMMENDATIONS

1. 2024-001: ADP Total Pay Services — Noncompliance with Password History Setting for SMS Access

Per testing procedures performed by Ernst & Young, LLP, it was determined that the password history setting governing access to SMS did not comply with ADP’s security policies and standards, indicating a control deficiency in password policy enforcement.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management Response from ADP: Management inspected the password settings and confirmed that the password history was not in compliance with ADP’s security policies and standards. A root cause analysis determined that ADP is transitioning to a new governing platform that hosts the password configurations for SMS, and this new platform was not configured to enforce the password history setting appropriately. Upon identification of the issue, Management submitted an emergency ticket on October 21, 2024, requesting an update to the password history to comply with ADP’s security policies and standards. Additionally, Management confirmed that settings for minimum password length, password complexity, and number of failed login attempts met policy requirements, while the password expiration setting exceeded the policy requirement.

2. 2024-002: ADP Work Force Now Services — Noncompliance with Password History Setting for SMS Access

Per testing procedures performed by Ernst & Young, LLP, it was determined that the password history setting governing access to SMS did not comply with ADP’s security policies and standards, indicating a control deficiency in password policy enforcement.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management Response from ADP: Management inspected the password settings and confirmed that the password history was not in compliance with ADP’s security policies and standards. A root cause analysis determined that ADP is transitioning to a new governing platform that hosts the password configurations for SMS, and the new platform was not configured to enforce the password history setting appropriately. Management confirmed that the settings for minimum length, password complexity, and number of failed login attempts met policy requirements, while the password expiration setting exceeded the policy requirement. Upon identification of the issue, Management submitted an emergency ticket on October 21, 2024, requesting an update to the password history setting to comply with ADP’s security policies and standards. On December 3, 2024, the authentication settings were updated so that the password history setting was in compliance with ADP’s security policies and standards.

3. 2024-003: ADP Work Force Now Services — Gap in Automated User Termination Script for SMS Access

Per testing procedures performed by Ernst & Young, LLP, it was determined that a gap existed in the automated script designed to remove terminated user accounts from SMS. Specifically, certain user accounts that existed in SMS but not in ADAPT were not identified and removed by the automated termination script.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management Response from ADP: Management identified a gap in the automated script used to remove terminated ADAPT users from SMS and performed a root cause analysis. It was determined that user accounts existing in SMS but not in ADAPT were not being identified by the automated script. Management performed an analysis of 100% of the accounts with profiles allowing access to Workforce Now and identified thirteen (13) terminated user accounts. One (1) account was identified as a shared account that had activity after the termination date. Management obtained the activity log for this account and determined there were two instances of post-termination activity, neither of which changed client data. Management reviewed and deemed this activity appropriate. For the remaining twelve (12) terminated user accounts, Management obtained activity logs and determined that these accounts were not used after their termination dates. Management has since removed or suspended all thirteen (13) accounts. Additionally, during Q3 FY24 (January 1, 2024 to March 31, 2024), Management implemented a quarterly termination review to identify terminated users with an active SMS account to serve as a compensating control.

4. 2024-004: ADP Work Force Now Services — Failure to Perform Quarterly Terminated Associate Access Review

Per testing procedures performed by Ernst & Young, LLP, it was determined that the quarterly terminated associate access review was not performed during Q4 FY24 (April 1, 2024 to June 30, 2024), indicating a lapse in periodic monitoring of terminated user access.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management Response from ADP: Management agrees that the quarterly terminated associate access review was not performed during Q4 FY24 (April 1, 2024 to June 30, 2024). The review was completed in the subsequent quarter, Q1 FY25 (July 1, 2024 to September 30, 2024), and covered terminated associates from April 1, 2024 to September 30, 2024, operating effectively. Additionally, a semi-annual user access review covering the period April 1, 2024 to September 30, 2024, served as a compensating control for the quarter in which the terminated associate review was not performed (Control 10.08).

5. 2024-005: ADP Autopay Services — Failure to Perform Quarterly Terminated Associate Access Review

Per testing procedures performed by Ernst & Young, LLP, it was determined that the password history setting governing access to SMS did not comply with ADP's security policies and standards, indicating a control deficiency in password policy configuration.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management inspected the password settings and confirmed that the password history was not in compliance with ADP's security policies and standards. A root cause analysis determined that ADP is transitioning to a new governing platform that hosts the password configurations for SMS, and this new platform was not configured to enforce the password history setting appropriately. Management confirmed that the settings for minimum length, password complexity, and number of failed login attempts met policy requirements, while the password expiration setting exceeded the policy requirement. Upon identification of the issue, Management submitted an emergency ticket on October 21, 2024, requesting an update to the password history to comply with ADP's security policies and standards. On December 3, 2024, the authentication settings were updated so that the password history setting was in compliance with ADP's security policies and standards.

6. 2024-006: ADP Autopay Services — Incorrect Portal Access Provisioned for Input Systems

Per testing procedures performed by Ernst & Young, LLP, it was determined that for one (1) out of a sample of twenty-five (25) user access additions and modifications, access was provisioned incorrectly to the Self-Service Portal instead of the intended Input Systems, indicating a lapse in access provisioning controls.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management agrees with the one (1) deviation noted. The user was provisioned the wrong portal access (Self-Service Portal), and this was not detected until testing. Management removed the incorrect portal access and reviewed the user's last logon date, validating that the user did not access the Self-Service Portal during the period they possessed the access. Additionally, Management increased the scope of the semi-annual user access review control during the period covering April 1, 2024 to September 30, 2024, to review and recertify all user access to the Input Systems, serving as a compensating control that was tested without exception (Control 7.09). Further, Management performed an analysis to identify and review users granted access to the Input Systems after the expanded scope semi-annual user access review was performed through September 30, 2024, and validated with each user's manager that access granted during this period was authorized.

7. 2024-007: ADP Autopay Services — Gap in Automated User Termination Script for SMS Access

Per testing procedures performed by Ernst & Young, LLP, it was determined that a gap existed in the automated script designed to remove terminated user accounts from SMS. Specifically, certain user accounts that existed in SMS but did not exist in ADAPT were not being identified and removed by the automated termination script.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management identified a gap in the automated script to remove terminated ADAPT users from SMS and performed a root cause analysis. It was determined that user accounts existing in SMS but not in ADAPT were not being identified by the automated termination script. Management performed an analysis of 100% of the accounts with profiles allowing access to the Input Systems potentially impacted and identified three (3) terminated user accounts. Management obtained the activity logs for these user accounts and determined that the accounts were not used after the termination date. During Q3 FY24 (January 1, 2024 to March 31, 2024), Management implemented a quarterly termination review to identify terminated users with an active SMS account to serve as a compensating control (Control 7.10).

8. 2024-008: ADP Autopay Services — Failure to Perform Quarterly Terminated Associate Access Review

Per testing procedures performed by Ernst & Young, LLP, it was determined that the quarterly terminated associate access review was not performed during Q4 FY24 (April 1, 2024 to June 30, 2024), indicating a lapse in periodic monitoring of terminated user access.

Recommendation

We recommend reviewing these procedures performed by ADP to ensure it does not impact on the outcome of your retirement plan and that the controls of ADP can still be relied upon.

Management Response

Management agrees that the quarterly terminated associate review was not performed during Q4 FY24 (April 1, 2024 to June 30, 2024). The review was completed in the subsequent quarter, Q1 FY25 (July 1, 2024 to September 30, 2024), covering terminated associates from April 1, 2024 to September 30, 2024, and operated effectively. Additionally, the semi-annual user access review covering the period April 1, 2024 to September 30, 2024, served as a compensating control for the quarter during which the terminated associate review was not performed (Control 7.09).
