Notes to Financial Statements

NOTE 1 DESCRIPTION OF THE PLAN

The following description of Modern Aviation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established on June 15, 2019, is a defined contribution plan covering all employees of Modern Aviation, Inc., Gateway USA, LLC d/b/a Modern Aviation Seattle, and Modern Aviation Denver, LLC (the “Company”). The Plan covers all employees who are 21 years of age and have completed three months of service. They are then enrolled on the first day of the month following their election to contribute. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may voluntarily make salary deferral contributions up to 100% of their pre-tax or post-tax compensation, as defined in the Plan. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500 for employees aged 50 and over. The Company has elected to make Safe Harbor matching contributions to all eligible Participants in an amount equal to 100% of the first three percent of their eligible compensation, and 50% of the next two percent of their eligible compensation on a Plan year basis.

The participants designate the percentage or dollar amount of their total contribution to be invested in any of the Plan's investment funds on a pre-tax or Roth after-tax basis. Participants may change the percentage or dollar amount of contributions invested in each account and may make transfers between accounts anytime during the year. A participant may change the amount of his or her elective deferred contributions at any time.

Rollover Contributions

Participants may roll over the taxable portion of funds previously held for their account in another employee benefit plan to the Plan on a tax-free basis.

Participant Accounts

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings. The pro-rata allocation is based upon the proportion of individual account balances to total participants' account balances in the respective investment funds. Each participant's account is reduced by participant withdrawals, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may designate investment of the amount held in their account and earnings thereon in various funds. Participants may change their investment options daily.

Notes to Financial Statements (Continued)

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are always 100% vested in their rollover contributions, qualified matching contributions, qualified nonelective contributions, deferral contributions, Safe Harbor matching employer contributions, and any earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and may not exceed the lesser of \$50,000 or half of the participant's vested account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.75% to 8.50%, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. Generally, notes receivable range in term from one to five years, except in the case of a note for the purpose of acquiring a primary residence.

Payment of Benefits

Upon a participant's retirement, death, total and permanent disability, other termination of employment, or termination of the Plan, the participant's benefits are distributed either in the form of a single lump-sum amount equal to the value of the participant's vested interest in his or her account or rolled over into an IRA or another qualifying plan to avoid current taxation.

In conditions of "financial hardship," a participant may apply to the Plan administrator for approval to withdraw that portion of his or her 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

Administrative Expenses

Certain plan expenses are paid by the Company and accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

Related Party Transactions

Certain Plan investments are shares in mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the custodian, as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Modern Aviation ("Plan Sponsor") provides administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by Modern Aviation for the services to the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements of the Modern Aviation 401(k) Plan (the "Plan") have been prepared under the accrual basis of accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets during the reporting period. Actual results may differ from those estimates.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

In preparing its financial statements, Plan management has evaluated events subsequent to the balance sheet date through September 30, 2025, which is the date the financial statements were available to be issued.

NOTE 3 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan's investment in the Lincoln Stable Value Fund is a benefit-responsive investment with The Lincoln National Life Insurance Company ("Lincoln"). Lincoln maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment is included in the financial statements at contract value as reported to the Plan by Lincoln. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the plan to transact at contract value with Lincoln. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawals or transfer rules. As of December 31, 2024, the occurrence of any such event is not considered probable.

Lincoln may terminate the contract if any of the following conditions are met after the five year installment period: Any charges billed to the contract owner haven't been paid to Lincoln for 30 days. The plan ceases to meet the requirements of the Internal Revenue Code for purchasers of the contract. Any time following the end of the third contract year, the contract owner's account balance is less than \$15,000. At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000.

NOTE 4 FAIR VALUE MEASUREMENTS

Applicable generally accepted accounting principles' accounting for Fair Value Measurements and Disclosures establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation approaches used for assets measured at fair value.

Mutual funds: Value at the net asset value (“NAV”) of shares held by the Plan at year end.

Money market fund: Value at the net asset value (“NAV”) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 TAX STATUS

The Plan sponsor has adopted a volume submitter specimen plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, which states that the provider's prototype, as designed, is in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself had not received a determination letter from the IRS. The Plan has been amended since receiving the determination letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, therefore, no provision for income tax has been included in the Plan's financial statements.
