## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Moeller Trucking, Inc. 401(k) Retirement Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedules Required by ERISA**

The supplemental schedules for the year ended December 31, 2024, on pages 12 through 14, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulation for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agree to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements  
Years Ended December 31, 2024 and 2023

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Moeller Trucking, Inc. 401(k) Retirement Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan established by Moeller Trucking, Inc. (the “Company”) covering all employees at least eighteen years of age who have completed 500 hours of service during a six-month period, beginning on the employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and up to allowed federal limits. Participants may make contributions as pre-tax or after-tax (Roth). Participants who have attained age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants. The Company may make a discretionary matching contribution equal to a uniform percentage of each tier of participant deferrals, which will be determined each year. Additional discretionary profit-sharing contributions may be contributed at the option of the Company. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Notes Receivable from Participants**

Participants may borrow from their account up to \$50,000 minus the difference between the highest outstanding balance of loans in the twelve months and the outstanding balance of loans from the Plan on the date the loan is made. Total loans may not exceed \$50,000 or one-half the present value of the vested account balance. No loan in an amount less than \$1,000 will be made. Loan terms generally may not exceed five years; however, if the loan is for the purchase of a principal residence, the administrator may permit a longer repayment term. Principal and interest is paid ratably through payroll deductions.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer discretionary and matching contributions and the earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service.

## **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance or partial payments (payments of a portion of the participant's account that are not regularly scheduled). In addition, hardship distributions are permitted if certain criteria are met.

The Plan adopted the automatic rollover provisions as contained in Internal Revenue Service 2005-5. In accordance with the SECURE 2.0 Act of 2022, the Plan has administratively implemented an increase in the involuntary cash-out threshold from \$5,000 to \$7,000, effective for distributions made on or after January 1, 2024. Although the formal plan amendment reflecting this change has not yet been executed, the Company intends to adopt a conforming amendment within the remedial amendment period.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,626 and \$14,325, respectively. These forfeitures will be used to reduce administrative expenses and fees.

### **Plan Amendment**

Effective January 1, 2024, the Plan was amended and restated such that (1) the service requirement for eligibility is the completion of 500 hours of service during a six-month period, (2) the entry date for newly-eligible employees is the first day of the next month, and (3) installment payments and annuities have been removed as available forms of distributions.

## **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

## NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

### Excess Contributions

Amounts payable to participants for contributions in excess of allowed limits, totaling \$4,013 and \$4,802, for the years ending December 31, 2024 and 2023, were paid by March 15, 2025 and 2024, respectively.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company, and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and loans from participants' accounts are charged directly to the participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.

## NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable for the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or by other means.</li></ul> If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE C – FAIR VALUE MEASUREMENTS (CONTINUED)**

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investment in Pooled Separate Accounts:* Consist of various accounts valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The net asset value is used as a practical expedient to estimate fair value.

**NOTE D – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica totaling \$220,714 at December 31, 2024. As discussed in Note E, in March 2024, the Plan’s investments moved from Voya Retirement Insurance and Annuity Company to Reliance Trust Company and Transamerica. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Insurance Company, totaling \$436,727 at December 31, 2023.

## **NOTE D – GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)**

The crediting rate is based on a formula established by the contract issuer. The credit rates are reviewed for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica and Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA, and (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

## **NOTE E – PARTY-IN-INTEREST TRANSACTIONS**

In March 2024, the Plan's investments moved from Voya Retirement Insurance and Annuity Company to Transamerica and Reliance Trust Company.

Certain Plan investments are managed by Reliance Trust Company and Transamerica. At December 31, 2024, Reliance Trust Company is the directed trustee as defined by the Plan, and Transamerica is the recordkeeper and custodian as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

At December 31, 2023, Certain Plan investments are pooled separate accounts managed by Voya Retirement Insurance and Annuity Company. At December 31, 2023, Voya Retirement Insurance and Annuity Company is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

## **NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

## **NOTE G - TAX STATUS**

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

## NOTE G - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## NOTE I – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of accrual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the Trustee beginning in March 2024, and Voya Retirement Insurance and Annuity Company, the Trustee through March 2024, have certified that the investment information included in the accompanying financial statements and supplemental schedules is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.
