### ***Opinion***

We have audited the financial statements of New York Oil Heating Insurance Fund (the Plan), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding the Plan's net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America (US GAAP).

### ***Basis for Opinion***

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the New York Oil Heating Insurance Fund (the Plan) is provided for the general information of plan participants. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a multi-employer benefit plan, established in 1975 under the provisions of an Agreement and Declaration of Trust between the New York Oil Heating Association, Inc. (NYOHA) and the Trustees and the Administrator of the New York Oil Heating Insurance Fund and various employers having collective bargaining agreements with the NYOHA.

During 2020, NYOHA merged with the Oil Institute of Long Island, which resulted in the New York State Energy Coalition, Inc. (NYSEC) being created.

The Plan provides benefits for eligible participants and their dependents and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Coverage for all non-union members under the Plan begins on the first day of the following month after the hire date and for Union members, they are automatically enrolled.

#### **Contributions**

During the year ended December 31, 2010, the parties to the collective bargaining agreement agreed to provide coverage of certain health benefits to members of Teamsters Local 553 through another benefit fund. Employers will be required to make monthly contributions to that benefit fund.

The Plan is noncontributory for employees and is funded mainly from contributions received from employers.

#### **Benefits**

Currently, the Plan provides drug testing, life insurance, accidental death and dismemberment, disability income and paid family leave benefits for eligible members of Teamsters Local 553, their dependents and non-union employees of the employers. Insurance premiums are paid to certain insurance carriers for these benefits.

#### **Insured Benefits**

The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), and long-term disability benefits. The Plan purchases annual insurance contracts for these insured benefits.

#### **Insurance Premiums**

The Plan pays insurance premiums to certain insurance carriers for the Plan's fully insured arrangements under the Plan.

## Notes to Financial Statements

### **Note 2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies, utilizing information provided by the investment adviser. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Employers' Contributions and Related Receivables**

Contributions receivables are reported at their outstanding balances net of an estimated reserve for doubtful accounts and are primarily composed of balances due from employers. The Plan estimates doubtful accounts based on historical bad debts, factors related to specific employers' or groups of participants' ability to pay, and current economic trends and conditions. As of December 31, 2024 and 2023, the allowance for doubtful accounts was \$0.

#### **Payment of Benefits**

Premiums not yet paid by the Plan related to coverage at or before year-end are included in premiums due to insurers in the statement of benefit obligations.

#### **Reclassifications**

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 financial statement presentation. These reclassifications had no effect on changes in net assets available for benefits.

#### **Management's Review of Subsequent Events**

Management has evaluated subsequent events for the Plan through October 10, 2025, the date the financial statements were available to be issued.

### **Note 3. Benefit Obligations**

Premiums payable represent those premiums incurred prior to December 31, but unpaid at that date. Such estimated amounts are reported in the accompanying statements of net assets available for benefits and plan benefit obligations.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies include mutual funds and exchange-traded funds.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange traded funds are valued at the closing price on the active market on which the individual securities are traded.

Interest bearing cash: Interest bearing cash includes cash in checking, savings and money market accounts, which are valued at cost plus interest, if applicable.

### Note 5. Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid for professional fees, insurance, and other expenses. These expenses are reported on the statements of changes in net assets available for benefits as administrative expenses.

### Note 6. Tax Status

The Plan received an exemption letter from the Internal Revenue Service (IRS) stating that the trust was in compliance with applicable requirements of the provisions of Section 501(c)(9) of the IRC. However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 and 2023 for unrelated business taxable income. The Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust was tax-exempt as of the financial statement date.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7. Plan Termination

In the event of plan termination, the trustees shall pay or provide for the payment of any and all obligations of the Plan, and shall distribute and apply any remaining surplus in such a manner as will, in their opinion, best effectuate the purpose of the Plan. No assets of the Plan may revert to the employers or be used for purposes other than for the exclusive benefit of the Plan's participants.

### Note 8. Related Party Transactions and Party in Interest Transactions

The Plan shares administrative costs with NYSEC, subject to an allocation of such expenses, with the goal of effectuating cost-savings and minimizing the duplication of efforts.

Direct expenses are charged to the Plan and common administrative expenses are allocated based on percentages reflecting actual utilization.

The amounts charged and/or allocated to the Plan totaled approximately \$27,000 and \$22,000 for the year ended December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by officers and employees of NYSEC. No officer receives compensation from the Plan.

As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect the amounts reported in the statements of net assets available for benefits.

Financial instruments that subject the Plan to concentrations of credit risk include cash, money market accounts and employers' contributions receivable. The Plan maintains accounts at a high quality financial institution. Its deposit balances may, at times, exceed federally insured limits. The Plan has not experienced any losses on such accounts. Receivables consist of contributions due primarily from employers in the oil heat industry located in the New York metropolitan area.

Contributions from four employers represent approximately 48% of the total contributions for the years ended December 31, 2024 and 2023, and two employers represents 35% of the total contributions receivable as of December 31, 2023.

### **Note 10. Reconciliation of Financial Statements to Form 5500**
