Summary of Actuarial Methods

The ultimate cost of a pension plan is the excess of actual benefits and administrative expenses paid over actual net investment return on plan assets during the plan's existence until the last payment has been made to the last participant. The plan's "actuarial cost method" determines the expected incidence of actuarial costs by allocating portions of the ultimate cost to each plan year. The cost method is thus a budgeting tool to help ensure that the plan will be adequately and systematically funded and accounted for. Annual contributions and accounting expense are also affected by the "asset valuation method" (as well as the plan provisions, actuarial assumptions, and actual plan demographic and investment experience each year).

Actuarial Cost Method

The actuarial cost method used for determining the Plan's ERISA funding requirements and the FASB ASC Topic 960 values is the Unit Credit method. Under this method, an accrued benefit is determined at each active participant's assumed retirement age based on compensation and service at both the beginning and the end of the current year. The Plan's Normal Cost is the sum of the present value of the excess of each active participant's accrued benefit at the end of the current year over that at the beginning of the current year. The Plan's accrued liability is the sum of (a) the present value of each active participant's accrued benefit at the beginning of the current year plus (b) the present value of each inactive participant's benefits. This method is prescribed for ERISA funding requirements by the Pension Protection Act of 2006.

Asset Valuation Method

The Actuarial Value of Assets used for determining the Plan's ERISA funding requirements is based on the permitted three-year asset smoothing as defined under IRS Notice 2009-22. Under this method, the Actuarial Value of Assets equals the Market Value of Assets minus one-third and two-thirds, respectively, of the investment gain or loss for each of the two immediately preceding plan years, but it must be within 90% to 110% of the Market Value of Assets.

PBGC Variable-Rate Premium Method

The alternative method is used for the PBGC variable-rate premium calculation (adopted January 1, 2010).

Amortization Method

For the Plan's ERISA funding requirements, incremental Funding Shortfall amounts are amortized over a fifteen-year period, and the related shortfall amortization payment is determined on the first valuation date following the plan year in which it arises based on the segment rates used for ERISA minimum funding purposes on that date, as prescribed under IRC Section 430.

Summary of Principal Plan Provisions

This summary of plan provisions is intended to only describe the essential features of the Plan. All eligibility requirements and benefit amounts shall be determined in strict accordance with the plan document itself.

Plan Year

The 12-month period from January 1 through December 31.

Effective Date

The plan was established effective January 1, 1976. The plan was amended and restated effective January 1, 2012. The first amendment was adopted effective July 1, 2012. The second amendment was adopted by the Board on October 14, 2016 and signed on January 30, 2017.

Participation

Each salaried, non-contract employee who has attained the age of 21 shall become a participant.

Vesting Service

Vesting service is the number of years in the period beginning on an employee's employment commencement date and ending on the employee's severance date. Prior service with other railroads is considered.

Benefit Service

Benefit Service is the number of years of non-contract related service in the period beginning on an employee's employment commencement date and ending on the employee's severance date. Contract related service prior to participation and prior service with other railroads is also considered.

Compensation

Generally, all taxable and non-taxable (e.g., deductible contributions to the 401(k) plan) compensation is included.

Average Monthly Compensation

A participant's Average Monthly Compensation is equal to the greater of (a) the total compensation received during the 60 months preceding the retirement or termination date divided by 60, or (b) the greatest average annual compensation for any 5 consecutive plan years within the last ten years preceding retirement or termination divided by 12.

Railroad Retirement Benefit

The monthly Railroad Retirement Benefit shall mean the monthly annuity determined by the Railroad Retirement Board on the later of the date benefits commence or the date of attainment of age 60.

Accrued Benefit

The participant's Accrued Benefit as of any computation date is the monthly benefit in the Normal Form of Benefit commencing on the later of his Normal Retirement Date or such date of computation, based on his years of Benefit Service, Average Monthly Compensation, and the Railroad Retirement Benefit.

The amount of such Accrued Benefit shall be equal to 1.40% of Average Monthly Compensation times Benefit Service less 60% of the Tier I and Tier II Railroad Retirement Benefits. The 60% of the Tier I and Tier II Railroad Retirement Benefits can be no greater than the IRS maximum allowable offset individually determined for Tier I and Tier II.

The above benefits are offset by pension paid from prior railroad employers.

Normal Retirement

A participant's Normal Retirement Date is the last day of the month in which he attains age 65. The monthly amount of benefit is equal to the Accrued Benefit.

Early Retirement

A participant may retire any time after he attains age 60, provided he has at least 10 years of Vesting Service at such time. The Early Retirement Benefit is equal to the Accrued Benefit, reduced by 1/180th for each month his early retirement age precedes age 65. If a participant has 30 years of Vesting Service, the reduction to the Accrued Benefit will be applied only from age 62. If a participant has age plus years of Vesting Service equal to or greater than 85 points, the Accrued Benefit is unreduced and immediately payable.

Disability Benefit

If a participant becomes totally and permanently disabled after completing 10 years of Vesting Service, he will be entitled to receive his Accrued Benefit. The benefit will commence on his disability retirement date and continue as long as he is disabled.

Vested Deferred Benefits

If a participant terminates employment prior to normal retirement but after completing at least 5 years of Vesting Service, he will be entitled to a vested deferred benefit payable at his Normal Retirement Age equal to the Accrued Benefit. If the participant has completed 10 years of Vesting Service, he may elect to receive a reduced benefit determined in the same manner as Early Retirement after attaining age 60.

Cost of Living Adjustment

Once benefit commences, the plan provides for cost of living increases as determined by the Railroad Retirement Board. The maximum adjustment is 2.50% on an annual basis.

Normal Form of Annuity and Options

If the participant does not have an eligible spouse on the date his pension is to commence, payments under the plan are made monthly commencing on the participant's retirement date and ending with the payment on the first day of the month in which his death occurs. If the participant does have an eligible spouse on the date his pension is to commence, the pension shall be paid in the form of an actuarially equivalent Joint and 100% Survivor Pension unless an optional form is elected.

A participant may elect, in lieu of the normal form of payment described above, (a) a benefit payable during his lifetime only, or (b) an actuarially equivalent benefit payable during his lifetime with $\frac{1}{2}$ or $\frac{3}{4}$ of the amount payable after his death for the remaining lifetime, if any, of his eligible spouse or beneficiary.

Death Benefit Prior to Commencement

If a participant who has at least 5 years of Vesting Service dies and was married to his surviving spouse for at least one year, the surviving spouse shall receive a Survivor Annuity calculated as follow. The commencement date is the first of the month coincident with or next following the later of the date the participant dies or the earliest date the participant could have commenced benefits. The amount of the benefit is equal to the amount of reduced annuity payable to the participant in the form of a 100% Joint and Survivor Annuity as if the annuity starting date was the Survivor Annuity commencement date and based on the Accrued Benefit at death or separation from service.

If a participant dies while in active employment with at least 10 years of Vesting Service and he has been married for at least one year at his death, his surviving spouse is entitled to a monthly benefit equal to half of the accrued benefit. However if the Actuarial Equivalent of this benefit is less than the Actuarial Equivalent of the Survivor Annuity, then the surviving spouse will receive the Survivor Annuity.
