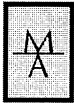

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of  
HopePHL 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of HopePHL 401(k) Plan, (Plan) an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### ***Basis for Opinion***

**1. Description of plan**

The following description of the HopePHL 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering employees of HopePHL (Sponsor). The Plan covers substantially all employees who have three consecutive months of eligible continuous service and are age 21 or older. An employee with three months of service and age 21 or older is eligible to make deferrals into the Plan. Participants that are age 21 or older are eligible for discretionary non-elective contributions upon the completion of one year of eligible service, described below, with an entry date on the first day of the plan year in which the eligibility requirements are met. The Plan Sponsor may elect to provide safe harbor non-elective contributions on behalf of employees that have one year of service and are age 21 or older. An employee is eligible to share in the safe harbor non-elective contribution upon satisfaction of the eligibility requirements. Employees that met the Plan's eligibility requirements prior to July 1, 2015 remain eligible to participate in the Plan. Prior service with Youth Services, Inc., is considered for purposes of eligibility and vesting.

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's trustee is responsible for oversight of the Plan. The plan administrator is the Sponsor and is responsible for the day-to-day operations of the Plan. The Plan's trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is in operational compliance with the requirements of current laws and regulations. Formal amendments will be adopted by the prescribed deadlines.

**Contributions**

Each year, participants may contribute up to the maximum limit established under the Internal Revenue Code (IRC). Participants may choose between two types of deferral options: pre-tax deferrals and Roth deferrals. Participants that are fifty years of age or older may make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans and individual retirement accounts as rollover contributions.

The Sponsor may make discretionary non-elective contributions, which are allocated as of the last day of the plan year. To be eligible for these contributions, participants must complete at least 1,000 actual hours of service during the twelve consecutive month period beginning on the employee's date of hire. The subsequent eligibility computation period is the plan year. No discretionary non-elective contributions were made or declared for the year ended December 31, 2024.

For the year ended December 31, 2024, the Sponsor elected to make a safe harbor non-elective contribution for all eligible participants equal to 3% of compensation, as defined, totaling \$187,036.

**Contributions (Continued)**

The Sponsor remits employee deferral contributions to the Plan on a payroll by payroll basis. The Sponsor remits discretionary non-elective contributions after the close of the Plan year. Safe harbor non-elective contributions are remitted within one year of the end of the Plan year.

Participants direct the investment of contributions into various investment options offered by the Plan and may change their investment options at any time.

**Participant accounts**

Each participant's account is credited with the participant's elective and rollover contributions, as well as allocations of the Sponsor's discretionary non-elective contributions and safe harbor non-elective contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions, as well as in safe-harbor non-elective contributions made by the employer. Participants become fully vested in other employer contributions, and earnings thereon, using a graded vesting schedule, after completing six years of service. Participants become 100% vested if separated from service due to death or disability or upon the attainment of normal retirement age of 65 years.

**Notes receivable from participants**

The Plan does not permit participants to borrow from their fund accounts.

**Payment of benefits**

Benefits are paid in the form of a lump sum.

Participants may withdraw all or a portion of the vested balance of their accounts if they:

- terminate employment before attaining normal retirement age
- become disabled
- retire
- die
- attain normal retirement age but continue to work, or
- qualify for in-service distributions upon attaining age 59 ½

**Payment of benefits (Continued)**

In addition, participants may withdraw from their fully vested elective deferral and qualified employer contribution accounts, including safe harbor contributions, if they incur a financial hardship. Participants may receive a distribution from their rollover account at any time.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,946 and \$622, respectively. This amount will be used to restore previously forfeited account balances of participants, reduce future employer contributions, and pay administrative expenses.

**2. Summary of significant accounting policies**

**Basis of accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Sponsor's discretionary non-elective contributions and safe harbor non-elective contributions are recorded when the related participant compensation is paid.

**Investment valuation and income recognition**

Investments (except for fully benefit responsive investment contracts, which are reported at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies using information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses, which represent the internal expenses of each respective fund.

**Payment of benefits**

Benefits are recorded when paid.

**Income Taxes**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 740, *Income Taxes*, requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if they have taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's policy is to recognize interest and penalties related to unrecognized tax benefits in income tax expense.

**Administrative expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from the financial statements. Administrative expenses include participant maintenance fees and fees related to the administration of benefit payments charged directly to the affected participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

**3. Investments and fair value of financial instruments**

FASB ASC Topic 820 (ASC 820), *Fair Value Measurement*, provides a framework for measuring, reporting and disclosing fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in an active market for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* - Valued based on the NAV of units in each account held by the Plan at year end. The NAV, as provided by the insurance company, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The underlying investments of the pooled separate accounts, which generally consist of mutual funds, each follow a separate investment strategy as described in the following paragraphs:

*Bond Funds* - Assets are invested in fixed income securities that seek income or growth of income, with less emphasis on capital appreciation. Funds in this class vary greatly in their risk profiles. The issuer, credit quality of the underlying investments, and average duration of the portfolio play important roles in determining the risk profile of the fund.

*Asset Allocation Funds* - These funds invest in a combination of assets such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets. The allocation percentage to each asset type may be fixed, bounded by a range, or determined at the discretion of the manager. Managers of these funds review market conditions regularly and refine the asset allocation mixture they believe will achieve the best risk adjusted performance based on the stated objectives and "target" allocations of the particular fund.

*Balanced Funds* - These funds seek to balance growth of principal and current income by investing in a combination of stocks and bonds, generally holding 60-70% equity and 30-40% fixed income. The investment style used is either moderate allocation or conservative allocation. Some funds have fixed asset allocations and others allow managers discretion to allocate between equities and bonds, depending on their view of return and risk.

*Large Cap Value Funds* - These funds seek long-term growth of capital or a combination of growth and income by investing primarily in stocks of larger, mature companies. Stocks are selected for price appreciation and for the value of the current income provided through dividends. These funds generally exhibit a lower level of price volatility due to the types of companies they favor, such as those able to pay dividends along with older, mature companies.

*Large Cap Growth Funds* - These funds invest primarily in stocks of larger U.S. companies employing an investment style of growth. A growth fund invests in the stocks of companies that are growing rapidly. Growth companies tend to reinvest all or most of their profits for research and development rather than pay dividends. Growth funds are focused on generating capital gains rather than income. Funds emphasizing growth stocks will typically have higher price/earnings ratios and make little or no dividend payments. Large capitalization companies tend to be more established, with lower relative volatility, than more aggressive small and mid-cap stock funds.

*Small/Mid/Specialty Funds* - These funds employ investment styles of growth, value, or a blend of growth and value. These funds seek capital appreciation by investing primarily in stocks of small-and medium-sized companies. Generally, the companies are striving to develop new products or markets and have above-average earnings growth potential. Because of their smaller size, these companies may face greater business risk and investments in these funds generally carry much higher risk than other domestic equity funds. "Specialty" or "Sector" funds invest in stocks of companies in a particular industry, which can significantly increase risk and volatility.

*Global/International Funds* - There are three main types of funds in this category. International funds invest in stocks of companies outside of the United States. Global funds invest in stocks of companies in the United States and developed countries outside of the United States. Emerging Market funds invest in securities of developing countries and demonstrate the greatest volatility of performance due to the unstable nature of their economies, political structures and currencies.

The insurance company general account consisting of the Voya Fixed Account is fully benefit-responsive and is excluded from the fair value hierarchy table as described in Note 4.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels**

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers in or out of Levels 1, 2, or 3 for the years ended December 31, 2024 and 2023.

**4. Investment in insurance contract**

As of December 31, 2024, the Plan maintained a benefit-responsive investment contract, the Voya Fixed Account issued by Voya Retirement Insurance and Annuity Company (VRIAC) (a party-in-interest). The contract underlying this investment option is considered to be fully benefit responsive in accordance with ASC Topic 962, *Plan Accounting - Defined Contribution Pension Plans*. As of December 31, 2024 and 2023, the contract value of the investment in the Voya Fixed Account was \$26,285 and \$16,710, respectively.

The crediting interest rate to participants for the Voya Fixed Account as of December 31, 2024 was 1.0%. The guaranteed minimum crediting interest rate for the contract for the year ended December 31, 2024 was 1.0%. VRIAC makes this guarantee, and although VRIAC may credit a higher interest rate, the credited rate will not fall below the lifetime guaranteed minimum of 1.0%.

VRIAC's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (i) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (ii) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

VRIAC has the option to pay out 100% of the current value of the contract after completion of five contract years.

**5. Investment information certified by a qualified institution**

The plan administrator, having determined that it is permissible in the circumstances, elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, certain information summarized below related to the accompanying financial statements and ERISA-required supplemental information was obtained by plan management and agreed to or derived from information certified as complete and accurate by VRIAC, a qualified institution and the custodian of the Plan, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- a. The investments, at fair value and contract value, at December 31, 2024 and 2023.
- b. Net appreciation in fair value of investments for the year ended December 31, 2024.
- c. Interest income for the year ended December 31, 2024.
- d. Schedule H, Line 4i-Schedule of Assets (Held at End of Year).

**6. Related party and party-in-interest transactions**

Certain plan investments were units of pooled separate accounts and an insurance contract managed by VRIAC and its affiliates. VRIAC is the custodian as defined by the Plan.

These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules under ERISA.

Certain administrative functions of the Plan are performed by employees of the Sponsor. No such employee receives compensation from the Plan.

**7. Plan termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be entitled to the full amount in their accounts.

**8. Tax Status**

The Plan adopted a Non-Standardized Defined Contribution Pre-Approved Plan developed by N.A. Falcone & Associates, Inc. (Falcone). The IRS determined and informed Falcone by its IRS opinion letter dated June 30, 2020 that the pre-approved defined contribution plan document was designed in accordance with applicable IRC provisions as of that date. The Plan has been amended since receiving the opinion letter. However, management of the Plan believes that the Plan is currently designed and being operated in accordance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for the benefits.

**10. Subsequent events**

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. Plan management is evaluating these provisions and will update the Plan's governance and operations accordingly.

In connection with the preparation of the financial statements, the Plan has evaluated subsequent events from December 31, 2024 through August 25, 2025, which is the date the financial statements were available for issuance and concluded that no additional disclosures are required.



