Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE A - DESCRIPTION OF THE PLAN

The following description of the Peri & Sons Farms, Inc. 401(k) PS Plan 002 (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan was established January 1, 2016 and covers all eligible employees at Peri & Sons Farms, Inc., David Peri Family Farms, LLC, Peri & Sons Farms of California, LLC, and Prime West Construction, LLC (collectively, the “Employer”). The plan is a contributory plan under Sections 401(a) and 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Eligibility

An employee is eligible to participate in the Plan following the completion of one year of service (in which at least 1,000 hours are worked) and attainment of age 21, subject to entry dates of January 1 and July 1. Employees who are members of a collective bargaining unit and non-resident aliens for federal tax purposes are not eligible to participate in the Plan. In addition, effective January 1, 2024, part-time employees with three consecutive years of service after December 31, 2020 during which at least 500 hours of service were worked in each computation period (plan years 2021 to 2023) are also eligible to participate in the Plan, subject to the Plan’s age and entry date requirements; however they are not eligible to receive Employer contributions.

3. Contributions

Participants may elect to contribute, on a tax-deferred or after-tax Roth basis, up to the maximum annual deferral limit per Section 402(g)(1) of the IRC. Additional “catch-up” contributions can be made beginning in the plan year in which a participant will be at least age 50 by the end of the Plan year. In addition, the Plan allows rollover contributions from other qualified plans, as defined in the plan document.

The Employer makes safe harbor matching contributions equal to 100% of deferrals up to the first 3% of compensation and 50% of deferrals up to the next 2% of compensation. Safe harbor matching contributions totaled \$653,972 (net of applied forfeitures of \$62,739) during 2024.

In addition, the Employer may make an additional discretionary matching contribution up to 4% of a participant’s annual compensation, or a discretionary non-elective contribution as defined in the Plan. For the year ended December 31, 2024, the Employer made discretionary matching contributions totaling \$722,962. No discretionary non-elective contributions were made during the year ended December 31, 2024.

4. Investment Options

Upon enrollment in the Plan, participants may direct employee and Employer contributions, as desired, in any of a variety of options held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower"), the custodians, as provided by the Plan. Participants may change their investment options daily.

5. Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer safe harbor matching and discretionary matching contributions, and allocations of the Employer non-elective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Employer non-elective contributions (if any) are allocated based on the same ratio each participant's compensation bears to the compensation for all participants, with priority allocations to participants who earn more than 100% of the Social Security wage base (as determined under Section 230 of the Social Security Act), as specified in the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

6. Vesting

Participant contributions, rollovers, Employer safe harbor contributions, and actual earnings on all such contributions are fully vested at all times. However, vesting of the Employer discretionary matching and non-elective contribution portions of participant accounts plus actual earnings thereon is based upon the participant's continuous service with the Employer as follows:

7. Benefit Payments

Upon termination of service, a participant is entitled to an amount equal to the value of his or her vested account balance. In the event of normal retirement age, or death or disability while working for the Employer, a participant or a participant's beneficiary is entitled to receive the total value of the participant's account balance. Additionally, participants may request distributions upon attaining age 59 1/2.

8. Forfeitures

Forfeitures of terminated participants' nonvested accounts may be used to first offset administrative expenses (if not paid by the Employer) and then applied against discretionary matching, safe harbor matching and discretionary non-elective contributions. Forfeitures available as of December 31, 2024 and 2023 were \$4,059 and \$7,220, respectively.

9. Plan Termination

Although it has not expressed such intent, the Employer reserves the right, at any time, to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, further contributions to the Plan would cease and the assets of the Plan would be distributed to the participants based on each individual participant's interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

3. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation of fair value of assets.

3. Administrative Expenses (Continued)

The plan administrator has an agreement with Empower which provides for a plan expense account (PEA). The PEA is funded by Empower's shared revenues from certain investments. At the direction of the Employer, these funds may be used to pay reasonable plan related expenses or can be allocated to plan participants at the end of the year. Shared revenues totaled \$139,362 and expenses paid from the PEA totaled \$107,393 for the year ended December 31, 2024 and are netted and reflected in administrative expenses in the accompanying Statement of Changes Net Assets Available for Benefits. Amounts available in the Plan Expense Account totaled \$32,103 and \$0 as of December 31, 2024 and 2023, respectively.

4. Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment adviser and custodian. See Note D for further discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Payment of Benefits

Benefits are recorded when paid.

6. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

7. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower (the custodians of the Plan).

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus credited interest, less participant withdrawals, and administrative expenses. The following represents the traditional investment contract held by the Plan:

The Empower Investments Fixed Account – Series Class V (EIFA Account) is backed by Empower Annuity Insurance Company of America's general account. Interest earned on the amounts invested in the EIFA Account is compounded daily at the declared credited interest rate, which is established by Empower at the end of each quarter and credited during the next calendar quarter. The crediting interest rate may not be less than 0% and is reset quarterly. Although plan participants generally may withdraw assets from the EIFA Account without restrictions, the custodian may impose a hold period up to 36 months or a market value adjustment on payments due to certain plan-level events.

As of December 31, 2024, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the custodian and that also would limit the ability of the Plan to transact at contract value with the participants.

The Employer is not allowed to offer competing funds unless mutually agreed upon by Empower and the Employer, in which case amounts withdrawn from the EIFA Account must be transferred to a noncompeting fund and remain there for at least 90 days before transferring to a competing fund.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Investments are held with Empower, the custodians of the Plan. Empower Retirement is the recordkeeper of the Plan. Therefore, transactions with these entities qualify as party-in-interest transactions.

NOTE G - TAX STATUS

The Employer adopted a non-standardized pre-approved profit sharing plan ("pre-approved plan") which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the pre-approved plan is in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction programs. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.
