Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Saint Luke's Retirement Balance and Matching Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matters

Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, (referred to as the “supplemental schedule”), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of Saint Luke's Retirement Balance and Matching Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a discretionary defined contribution plan established for the benefit of the employees of certain participating employers (collectively, the Employers) of Saint Luke's Health System (SLHS) and its affiliates. On January 1, 2024, SLHS became a member of BJC HealthCare (the System). The purpose of this Plan is to allow participating employers to make discretionary matching contributions on behalf of eligible employees who voluntarily elect to make salary deferral contributions to a tax-sheltered annuity or an employer-sponsored qualified retirement plan (separate plans) and to make employer retirement balance contributions. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state laws. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was restated effective January 1, 2023. The most significant effect of the restatement was to allow for the merger described below.

Effective February 28, 2023, the Heart Surgeons of Kansas City, Inc. Retirement Plan, an employee benefit plan subject to ERISA, was merged with the Plan and assets of \$8,545,211 were transferred into the Plan. The merger was executed to streamline administrative processes and improve investment offerings for participants of the Heart Surgeons of Kansas City, Inc. Retirement Plan.

Eligibility

An eligible employee is defined as each employee of the Employers.

Entrance Into the Plan

Entrance for the employer match is defined as each business day of each plan year. Each participant who makes an elective deferral into the Saint Luke's 403(b) Plan is entitled to receive an employer matching contribution. Entrance for retirement balance contributions is defined as January 1 and

July 1 of each plan year. Eligible employees can enter the retirement balance portion of the Plan after one year of service. A year of service for eligibility is defined as an employee completing 12 months of consecutive service commencing on the employment commencement date.

Contributions

The Employers currently make discretionary matching contributions on behalf of each participant equal to 50% of the participant's salary deferral contribution (which is made to a tax-deferred annuity or an employer-sponsored qualified retirement plan), to the extent such deferral contributions do not exceed 4% of the participant's covered compensation.

The Employers make an additional annual contribution, referred to as the Retirement Balance Contribution, on behalf of each participant in an amount equal to a specified percentage of such participant's covered compensation for the plan year. The specified percentage ranges from 2% to 4% based on the participant's years of benefit service, which is defined as any year in which a participant receives a year of continued benefit service.

The Employers also make an annual transition retirement balance contribution on behalf of each participant who was a member of the Saint Luke's Health System, Inc. Retirement Plan as of December 31, 2010, and were actively employed on January 1, 2011, equal to a specified percentage of such participant's covered compensation for the plan year, which ranges from 0.5% to 2.0% based on Saint Luke's Health System, Inc. Retirement Plan years of benefit service as of December 31, 2010.

In order to receive an employer retirement balance contribution or transition retirement balance contribution for any plan year, a participant must be employed on December 31.

For the years ended December 31, 2024 and 2023, the discretionary matching contribution totaled \$19,274,481 and \$18,258,017, respectively. The retirement balance contributions totaled \$22,778,089 and \$21,927,845 and the transition retirement balance contributions totaled \$1,039,618 and \$1,039,619, respectively.

1. Description of the Plan (continued)

Vesting

Participants vest in their accounts based on years of credited service. A participant is fully vested after three years of credited service. A participant with less than three years of service will have no vested interest in the account.

Participants' Investment Options

Participants direct the Employers' contributions to selected investments as made available and determined by the plan administrator. Participants may change their investment options at any time throughout the year.

Participant Accounts

Each participant's account is credited with the Employers' matching contribution, retirement balance contribution, the transition retirement balance contribution, and allocations of the Plan's earnings and administrative fees. Plan earnings are allocated based on the participant's share net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's accounts balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump-sum amount equal to the value of a participant's vested interest in his or her account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes to Financial Statements (continued)

2. Summary of Significant Accounting Policies (continued)

Valuation of Investments and Income Recognition

Investments held by the plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The Plan's Retirement Committee determines the Plan's valuation policy utilizing information provided by the investment custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses (realized and unrealized) on investments bought and sold, as well as held, during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Forfeitures

Amounts of participants' forfeited nonvested accounts are used to reduce employer contributions and to pay expenses of the Plan. Unallocated forfeited balances as of December 31, 2024 and 2023, were \$1,300,377 and \$1,352,156. Forfeitures used to reduce employer contributions were approximately \$1,491,162 and \$1,535,834, for the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Investment related expenses are included in the change of fair value of investments.

3. Investments

Certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividends, and interest income from notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company and Brighthouse Life Insurance Company, the trustees.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The Plan's financial assets are measured at fair value on a recurring basis. The three levels of the fair value hierarchy and a description of the valuation techniques and inputs used for instruments measured at fair value are as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Pricing inputs other than quoted prices included in Level 1 that are either directly observable or that can be derived or supported from observable data as of the reporting date.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The Plan currently holds no Level 3 investments.

4. Fair Value Measurements (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts

Self-directed brokerage accounts are composed almost exclusively of mutual funds and are valued at the NAV of the funds.

Group Annuity Contracts

Group annuity contracts invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives and are valued based on accumulation of units held by the Plan on each contract at year-end.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

5. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated November 29, 2022, stating that the Plan is qualified under Section 401(a) of the IRC, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax-exempt.

Notes to Financial Statements (continued)

5. Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

7. Related-Party Transactions and Parties-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by an affiliate of Fidelity Workplace Services, LLC, the Plan's recordkeeper, and therefore, these transactions qualify as party in interest transactions allowable under ERISA.

Certain plan investments are group annuity contracts managed by Brighthouse Life Insurance Company, a custodian as defined by the Plan; therefore, these transactions qualify as party in interest transactions allowable under ERISA.

8. Subsequent Events

On December 31, 2025, the Plan will be merged into the BJC 401(k) Plan, another defined contribution plan sponsored by the System. The BJC 401(k) Plan will be the surviving plan. To the extent necessary for ongoing Plan administration of benefits, the Plan will continue to maintain separate accounts to reflect merged balances. In addition, all benefits, rights, and features that are required to be preserved pursuant to Code Section 411(d)(6) and regulations thereunder shall be retained by the Plan.

Management evaluated subsequent events for the Plan through October 10, 2025, the date the accompanying financial statements were available to be issued.
