We have performed audits of the accompanying financial statements of the Grimshaw Architects 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

1. Description of Plan

The following description of the Grimshaw Architects 401(k) Retirement Plan (the “Plan”) provides general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain eligible employees of Grimshaw Services (USA) Inc., Grimshaw Architects PC and Grimshaw, Inc. (the “Employer” or the “Company”) that are at least twenty-one years of age and have been credited with at least two months of service. Excluded employees include union employees, leased employees, residents of Puerto Rico, interns and part-time employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their annual compensation not to exceed the annual Internal Revenue Code (“IRC”) dollar limit on a pre or after tax (Roth) basis, as defined in the Plan. Additionally, eligible employees making elective deferrals that have reached the age of 50 before the close of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2025 the Plan includes an automatic enrollment feature under which eligible employees are automatically enrolled at a 3% deferral rate of compensation unless they elect otherwise. The Plan also provides for automatic annual increases of 1%, up to a maximum of 10%. Participants may change or opt out of these provisions at any time.

Participants who have completed at least two months of service and are age twenty-one or older are eligible to receive an Employer safe harbor contribution in an amount equal to up to 3% of their eligible compensation. For the 2024 plan year, Employer safe harbor contributions amounted to \$379,823. Participants who have completed at least one year of service and are age twenty-one or older may receive an Employer non-elective contribution, subject to the Employer’s discretion. The Employer non-elective contribution is determined using the grouping method whereby an employee will be assigned to a group which will share in the contribution that the Employer makes to that group. An eligible employee must be employed on the last day of the Plan year to receive the Employer non-elective contribution. For the 2024 Plan year, Employer non-elective contributions made to the Plan amounted to \$70,671.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer’s contribution, and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments are participant directed. Participants are entitled to the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested in their account at all times.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered withdrawals, are subject to restrictions as to use of the proceeds. In-service distributions are available to participant who have reached age 59 ½.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate equal to prime rate plus 1%. Loans must be repaid within a period not to exceed 5 years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence. A participant may not have more than one loan outstanding at any time. Repayment of principal and interest is made by payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy. At December 31, 2024 and 2023, the mutual funds and money market fund were valued using level 1 inputs. At December 31, 2024 the collective investment trust was valued at NAV.

2. Summary of Significant Accounting Policies (*continued*)

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the guaranteed investment contract held at December 31, 2023, which is stated at contract value. The guaranteed investment contract is valued at contract value, which equals deposits made, plus interest credited, less any withdrawals and expenses. Mutual funds and the Money Market fund are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These mutual funds are deemed to be actively traded. The collective investment trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee of the trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases making loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded, when a distributable even occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of administering the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments on the statement of changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date the financial statements were available to be issued, which date is October 10, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments held at December 31, 2024 and 2023, notes receivable from participants held at 2023 December 31, 2023, and net appreciation in value of investments and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company and Nationwide Life Insurance Company as of December 31, 2023 and for the period from January 1, 2024 through July 17, 2024, and Charles Schwab Trust Bank as of December 31, 2024 for the period from July 18, 2024 through December 31, 2024, qualified institutions.

4. Collective Investment Trust

The Reliance Trust Company Stable Value Fund (the “Fund”) is a collective investment trust that was formed for the purpose of allowing plan sponsors of defined contribution plans qualified under Sections 401(a) and 501(a) of the Internal Revenue Code to invest in the MetLife Group Annuity Contract 25053. The contract was issued by Metropolitan Life Insurance Company to Reliance Trust Company, who is the trustee of the Fund. Units of the Fund are value daily. Unit purchases and redemptions are transacted at the NAV determined as of the close of business each day. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values. There were no unfunded commitments for the Fund.

5. Tax Status

On November 30, 2020, the Internal Revenue Service (“IRS”) issued an opinion letter to the prototype document preparer indicating that the Plan, as then designed, qualifies under Section 401(a) of the IRC. Although the Plan has been amended, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their account.

7. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

8. Non-exempt Party-in-Interest Transactions

For the 2024 plan year, the Company failed to transmit to the Plan contributions and loan repayments for participants totaling \$63,765 within the period prescribed by Department of Labor regulations. The Company is in the process of making the necessary corrections.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
