Opinion

We have audited the financial statements of National Association of Specialty Trade Unions Benefit Fund Local 741 formerly known as Local 124 Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and the plan benefit obligation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligation for the years then ended, and related notes to the financial statements.

1. Summary of Significant Accounting Policies

a. Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

b. Accounting Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingencies, if any, at the date of the financial statements and additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

c. Contributions Receivable

Employer contributions received during the month following year end applicable to the current year are recorded as contributions receivable. This is the amount management expects to collect on unpaid balances. Management internally reviews delinquencies and records delinquent contributions when collected.

d. Fixed Assets

Fixed assets are recorded at cost. Depreciation is computed using the straight-line method over their useful lives.

e. Benefit Payments

Benefits are provided by insurance contracts and are recorded when paid.

f. Concentration of Credit Risk

Concentrations of credit risk with respect to contributions receivable are limited due to the large number of participants. The Plan routinely assesses the financial strength of its participants and, as a consequence, believes that their contributions receivable credit risk exposure is limited. Management does not believe significant risk exists in connection with the Plan's concentrations of credit at December 31, 2024 and 2023. Loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest.

2. Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan booklet for a more complete description of the Plan's provisions.

2. Description of the Plan (continued)

- a. General. The Plan is a multiemployer welfare benefit fund and was established under the provisions of an Agreement and Declaration of Trust, amended effective July 15, 2015, between Specialty Trade Union Local 741 of the National Association Specialty Trade Unions (the Union) and the various employers who are signatories. The plan was established to provide medical and other benefits to qualified participants. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.
- b. Contributions. The Plan is financed entirely by employer contributions as specified in the bargaining agreements.
- c. Benefits. The Plan provides hospital, surgical, major medical, prescription drug and dental benefits in accordance with the provisions of the rules and regulations of the Plan. The Plan offers several health maintenance organization plans (HMO) that participating employers can choose from.
- d. Eligibility. Members become eligible when they work in full-time employment and meet the waiting period requirements stated in their bargaining agreements.
- e. Termination of Benefit Coverage. All benefit coverage for both employees and covered dependents terminates as of the last day of the month the employer ceases to make contributions on behalf of the employee. All benefits coverage ends immediately if the Plan is terminated or if the employer ceases to be a contributing employer to the Plan. Upon the termination of an employee all benefits will cease for that particular employee.
- f. Plan Amendment. On July 15, 2015, the Trustees approved an amendment to change the name of the Plan to "National Association of Specialty Trade Unions Benefit Fund - Local 741".
- g. Union Name Change. The Union sponsoring the Plan changed its name from Local 124 Recycling, Airport, Industrial and Services Employees Union to Specialty Trade Union Local 741 of the National Association of Specialty Trade Unions.

3. Priorities Upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect. However, in the unlikely event of termination and in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining plan assets will be distributed in such manner as will in the opinion of the Trustees bring about the purpose of the plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

4. Tax Status

The Internal Revenue Service has advised that the Plan qualifies under Section 501(c)(9) of the Internal Revenue Code and is, therefore, not subject to tax under present income tax laws. The Plan is not aware of any action that has occurred that might affect its status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to tax examinations for years prior to 2019.

5. Related Party Transactions

The Plan has common trustees and shares office staff with the Union. Direct expenses are charged to the appropriate trust fund or union and common administrative expenses are allocated to the applicable entity based on percentages reflecting actual utilization in accordance with an allocation study.

The above transactions qualify as party-in-interest transactions and as such Plan Management has evaluated and determine that they meet the criteria for exemption as prohibited transactions under ERISA and Department of Labor Regulations.

6. Fixed Assets

Fixed assets are initially recognized at cost and subsequently carried at cost less accumulated depreciation. There were no additions to fixed assets during the 2024 or 2023 plan years.

Depreciation and amortization are calculated using the straight-line method over the estimated useful lives of the fixed assets as follows:

The Plan recognizes operating lease expense on a straight-line basis over the lease term.

The risk is mitigated by maintaining all deposits in high quality financial institutions. These deposits are stated at cost, which approximates market. These deposits are secured from risk by \$250,000 of federal deposit insurance. The Plan has not experienced any losses and does not believe it is exposed to any significant credit risk on cash balances.
