Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Family Support Center 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN AND SUMMARY OF ACCOUNTING POLICIES

The following description of Family Support Center 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of the Family Support Center of Colorado LLC (the “Company” or “Plan Sponsor”). Employees of the Company who have completed 90 consecutive days of service are eligible to participate in the Plan. If an employee does not complete 90 consecutive days of service, the employee is subject to a one year service requirement. The following employees are not eligible to participate in the Plan: Collective Bargaining Employees, Non-Resident Aliens and leased employees.

The Plan was adopted effective January 1, 2022, is intended to qualify under Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the provisions of ERISA.

Administration - The Company is the Plan Sponsor, and an officer of the Company serves as the Plan Trustee. The Company has contracted with Empower Retirement LLC, a division of Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively “Empower”) to act as the custodian of the Plan’s participant-directed investments and to provide recordkeeping services. Ascensus Holdings, Inc. serves as the Plan’s contract administrator and processes compliance testing and related administrative functions.

Basis of accounting – The Plan’s financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

Plan termination and modification - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Employee contributions - Eligible participants may elect to have the Company contribute a percentage or a fixed dollar amount of their pre-tax compensation to the Plan, up to the amount allowable under current income tax regulations. Participants may also contribute amounts representing distributions from other qualified plans or elect to have the Company contribute a portion of their compensation in the form of a Roth deferral. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions.

Employer contributions - The Plan permits discretionary employer matching and profit-sharing contributions. During the year ended December 31, 2024, the Company did not make any discretionary employer matching or profit-sharing contributions.

Participant accounts - A separate account is maintained for each participant. Each participant's account is credited with the participant's voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions, and administrative expenses, if any. Participants direct the investment of their contributions into the various investment options offered by the Plan. Investment income allocations are made daily based on participant account balances. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant's vested account balance.

Investment income - Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net appreciation or depreciation consists of both realized and unrealized gains and losses and is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contributions, if any, plus actual earnings thereon, is based on years of service. Participants do not become vested in the Company's matching or profit-sharing contributions until they have completed at least one year of service. Participants become fully vested in the Company's matching and profit-sharing contributions ratably over a five-year period. Participants also become fully vested in all accounts upon retirement, death, disability, or Plan termination.

Forfeited accounts - Forfeited non-vested accounts may be used to pay administrative expenses of the Plan or reduce employer contributions, if any. During the year ended December 31, 2024, no forfeitures were used to pay administrative expenses of the Plan or reduce employer contributions. As of December 31, 2024 and 2023, the Plan had no unallocated forfeitures.

Payment of benefits – The Plan generally allows withdrawal or distribution of participant account balances only upon: (1) termination of employment, (2) financial hardship or (3) attaining the age of 59 ½, upon request, in either a lump-sum payment or a direct rollover into a qualified plan. Withdrawals prior to attaining the age of 59 ½ are not permitted except in the event of a disability, death or as a hardship distribution. Benefits are recorded when paid.

Terminated participants having account balances in excess of \$5,000 may defer the receipt of distributions. Account balances less than \$5,000 will be distributed in a lump-sum payment unless otherwise directed by the participant.

The normal retirement age under the Plan is age 65. Participants who have reached age 59 ½ may take an in-service distribution subject to the Plan's provisions.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the Plan's financial statements. Administrative expenses paid by the Plan during the year ended December 31, 2024, consisted primarily of recordkeeping fees paid to Empower.

Subsequent events – The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, October 9, 2025, have been evaluated in the preparation of the accompanying financial statements.

2. FAIR VALUE MEASUREMENTS

Investments of the Plan are held by the Plan's custodian and are invested based solely upon instructions from participants.

The Plan's mutual fund investments are stated at fair value, as reported by the Plan's custodian and determined by quoted market prices on an established exchange, which represent the net asset value of shares held by the Plan at year-end.

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

4. INCOME TAX STATUS

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and believes that the Plan was qualified as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of mutual funds offered by the Plan. As the portfolio is well diversified and issuers of the underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower, the Plan's custodian. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

7. NONEXEMPT TRANSACTIONS

During 2024 and 2023, employee salary deferral contributions totaling \$19,034 were not remitted to the Plan in a timely manner, which includes a failure to remit salary deferrals withheld from employee paychecks during 2024 and 2023 totaling \$6,586 and \$5,099, respectively. The Plan Sponsor intends to correct this situation by remitting \$11,685 of undeposited employee salary deferrals to the Plan, which are included in employee contributions receivable on the accompanying statements of net assets available for benefits as of December 31, 2024, and lost earnings to the accounts of the affected participants during 2025.
