Note 1. Description of the Plan

The following description of Barnes & Thornburg LLP Employee Benefit Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan provides health, dental and vision covering all employees working greater than 20 hours per week of Barnes & Thornburg LLP (Partnership) and to all partners and eligible retirees. Certain life, accident and disability insurance is available to all full-time employees immediately upon hire. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. Elevance Health (fka Anthem Blue Cross Blue Shield) (Elevance) serves as the third-party claims processor for self-insured medical, dental and vision. Old National Bank (dba Old National Wealth Management) (Old National) serves as the trustee. Unum Life Insurance Company (Unum), Mass Mutual Life Insurance Company (Mass Mutual), Pacific Life Insurance Company (Pacific Life) and Petersen International Underwriters (Petersen International) administer the fully insured life, accident and disability insurance benefits. WEX, Inc. (f/k/a Nyhart) is the administrator of the flexible spending account (FSA) for certain eligible employees. During 2024, WEX, Inc. acquired Ascensus Health & Benefits line of business, which included BPC and Nyhart Health and Benefits which impacts the COBRA and FSA administration components of the Plan, respectively.

Investment assets of the Plan are held in a Voluntary Employees Beneficiary Association Trust (VEBA). The VEBA's assets are not part of the general assets of the Partnership, and as such, are not subject to the claims of its creditors.

Benefits

The Plan provides health, dental and vision benefits including medical, hospital, prescription, surgical and major medical, to eligible employees and to their covered dependents. Partners are immediately eligible upon hire. Retired partners and certain retired employees, who have greater than 25 years of service, are covered for health, dental and vision. There is no minimum age requirement for retiree coverage, however, effective January 1, 2022, participants terminated after January 1, 2022 greater than age 65 are not covered by the Plan. The Plan also offers healthcare and dependent care flexible spending accounts to eligible employees.

Elevance processes health, dental and vision claims of active participants and dependents, but the responsibility for payments to participants and providers is retained by the Plan.

The Plan is responsible for providing the funds to pay health benefits up to certain stipulated amounts. The Plan has insurance contracts with Symetra Life Insurance Company (Symetra), which provide for stop-loss coverage, but it is under no obligation to continue the stop-loss insurance contract in subsequent years. For the Plan years ended December 31, 2024 and 2023, Symetra was responsible for claims over \$300,000 per participant and aggregate claims in excess of \$29,592,908 and \$28,305,066, respectively.

The Plan utilizes a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

Insured Benefits

The Plan fully insures the life insurance benefits (basic, supplemental and dependent), accidental death and disability benefits (basic, supplemental and spousal) and long-term disability benefits. The Partnership purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the general assets of the Partnership. Certain premiums are paid 100% by the participant.

Contributions

The Partnership's policy is to fully fund the estimated claims and administrative costs expected to be paid during the year. The Partnership normally will not fund more than the maximum amounts allowed as a tax deduction by the Internal Revenue Code.

In addition to deductibles and copayments, participants and retirees contribute amounts as determined periodically by the Partnership taking into account Partnership recommendations based upon their actuarial assumptions. The Partnership's contributions are determined by the amount needed to fully fund the anticipated benefits and administrative costs projected to be paid during the Plan year in excess of participant and retiree contributions.

Retiree Contributions

The costs of the postretirement benefits under the Plan are shared by the Partnership and retirees. Retirees pay the same premium, deductibles and co-payments for health coverage as partners selecting the same plan coverage option. The premium is reduced for retirees eligible for Medicare.

Plan Termination

Although it has not expressed any intention to do so, the Partnership has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Partnership or be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, benefit obligations and changes therein, claims incurred but not reported (IBNR), claims payable and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits. The third-party claims processor processes health, disability and death claims of active and retired participants, dependents and beneficiaries, but the responsibility for payments to participants and providers is retained by the Plan. Disability payments are processed through the Partnership's payroll system and paid from the general assets of the Partnership. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

Premiums paid by either the Partnership or the VEBA trust are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Amounts contributed by participants to the FSA totaled approximately \$400,000 and \$372,000 in 2024 and 2023, respectively. The Employer has established notional accounts for each participant and allows participants to submit and be reimbursed for claims through March 31st of the following year. The notional accounts totaled approximately \$141,000 and \$182,000 at December 31, 2024 and 2023, respectively. Amounts not used by participants through March 31st of the following year are forfeited.

Stop-Loss

Premiums for stop-loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling approximately \$1,117,000 and \$1,125,000 for the years ended December 31, 2024 and 2023, respectively, have been netted with claims paid in the accompanying statements of changes in net assets available for benefits.

Refunds

Refunds due from the Plan's PBM are recorded when earned. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling approximately \$2,621,000 and \$2,177,000 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices, if available, are used to value investments. The Plan's investments consists of a money market fund and mutual funds. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Postretirement Benefits

A postretirement benefit obligation has been recognized for retiree medical benefits for eligible participants and their dependents upon retirement. The postretirement benefit obligation represents the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The obligations represent the amounts that are expected to be funded by contributions from the Partnership and from existing assets of the Plan. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the Partnership. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by Risk Strategies Consulting and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 6.75% and 7.25% weighted-average annual rate of increase in the average per capita cost of covered health care benefits was assumed for 2024 and 2023; the rate was assumed to decrease gradually to 4.75% for 2033 and to remain at that level thereafter.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement.

Other Plan Benefits

Plan obligations for health claims incurred but not reported are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year end and the Plan is obligated to pay for the care regardless of continued participation in the Plan. Health claims incurred by retired participants but not reported at year end are included in the postretirement benefit obligation.

Plan Tax Status

The Plan and trust have not submitted for a determination letter with the Internal Revenue Service.

The Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Administrative Expenses

Administrative expenses may be paid by the Partnership or the Plan, at the Partnership's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Old National, the trustee of the Plan and a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and interest and dividends receivable as shown in the statement of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024 and the accompanying schedule of reportable transactions for the year ended December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Note 8. Risks and Uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of postretirement benefit obligations are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
