## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the  
Plainview Healthcare 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Plainview Healthcare 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Plainview Healthcare 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5-6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Plainview Healthcare 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

Plainview Healthcare 401(k) Plan (the “Plan”) was effective July 1, 2019, amended and restated most recently effective June 1, 2022, and is a defined contribution plan established to encourage and assist employees in saving and investing payroll withholdings for purposes of receiving retirement benefits. Everview Group (formally known as Plainview Group TN LLC) (the “Company” or “Employer”) is the Plan sponsor and administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective June 1, 2022, the Plan’s trustee and custodian changed to John Hancock Trust Company LLC. The Plan’s Special Trustee is Administrative Fiduciary c/o Everview Group in which they are solely responsible for the collection of the employee contributions owed to the Plan.

Effective April 2, 2023, the Plan was amended and restated to conform the Plan to recent tax laws and to update employer matching contribution to be annual that is equal up to 1% of the participant salary.

Eligibility:

New Employees hired after the effective date is subject to become eligible to participate upon the next month subsequent to completing 60 days of service.

Contributions:

Each year, participants may contribute the maximum amount allowed by the Internal Revenue Service, plus Roth IRA contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Contributions (continued):

The Plan Sponsor may elect to make a discretionary matching contribution. The Plan updated its discretionary matching and profit-sharing contributions that will be up to 1% of the participants compensation. The contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. The total amount contributed to the Plan was in the amount \$0 and \$96,346 for the plan year ending December 31, 2024 and 2023.

**NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)**

Participant accounts:

Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of the Sponsor's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is based on the participant's vested account.

Vesting:

Participants will be vested in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon based on the following schedule:

Investment options:

Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan currently offers a variety of registered mutual funds as investment options for participants.

Loans to participants:

Loans are not permitted under the Plan.

Payment of benefits:

Upon termination of service due to death, disability, retirement, or other reasons, a participant or the participant's estate or beneficiary will receive a lump-sum amount equal to the value of the participant's vested interest in the participant's account. Hardship withdrawals are permitted by the Plan. Participants' benefits are charged to participants' equity during the period when participants are entitled to receive payment, which generally is the period during which the benefits are paid.

Disposition of forfeitures:

Forfeitures arising during the Plan year will first be used to pay administrative expenses. Any remaining amounts will be used to reduce the Company's future employer contributions payable under the Plan. Forfeiture accounts will be used to reduce future administrative expenses, reinstate previously forfeited account balances of former participants who have been reemployed by the Company, and to reduce the Company's matching contributions. At December 31, 2024 and 2023, the account balance for forfeitures to be used totaled \$120,194 and \$177,985, respectively.

Subsequent events:

In the preparation of the financial statements, the Plan was reviewed and evaluated by management and determined there were no subsequent events or transactions for disclosure through October 9, 2025 the date the financial statements were available to be issued.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting:*

The accompanying financial statements are prepared on the accrual basis in accordance with accounting policies generally accepted in the United States of America, except for benefit payments, which are recorded when paid.

*Valuation of investments and income recognition:*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex- dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Contribution receivables:*

Contributions receivables from participants and employers are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

*Payment of benefits:*

Benefits are recorded when paid.

*Administrative expenses:*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

*Use of estimates:*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of Plan income and expenses during the reporting period. Actual results could differ from those estimates.

*Reclassifications:*

Reclassifications were added to the prior year's financial statements for comparative purposes to conform with the presentation of the current financial statements.

**NOTE 3 – TAX STATUS**

The Plan is a non-standardized pre-approved profit sharing and money purchase plan with CODA sponsored by John Hancock Retirement Plan Services LLC in which has received an opinion letter from the Internal Revenue Service dated June 30, 2020. The IRS has determined and informed the Company that the Plan and the related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

**NOTE 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

**NOTE 5 – CERTIFICATION OF CONTRACT HELD BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by John Hancock Trust Company LLC (the Custodian).

The Plan's investments appreciated in value in the amount of \$122,750 (in which includes gains and/or losses on investments purchased, sold, and held during the year) for the year ended, December 31, 2024.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024:

*Money market funds* are valued at the closing price reported by the fund sponsor from an actively traded exchange. These are included within investments as Level 1 measurements.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts* are valued by the determination of the trustee of the common collective trust based on the underlying assets, which represents the net asset value. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Net gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024, are reported in net depreciation in fair value of investments.

**NOTE 7 – RISKS AND UNCERTAINTIES**

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 – PARTY-IN-INTEREST TRANASCTIONS**

The Company administers the Plan from its office. Certain Plan investments are managed by John Hancock Trust Company LLC. John Hancock Trust Company LLC is a trustee as defined by the Plan and GGM Associates Inc is the Plan's auditor, therefore, these transactions qualify as party-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments, on the Statement of Changes in Net Assets Available for Benefits.

**NOTE 9 – EXCESS CONTRIBUTIONS PAYABLE**

Amounts payable to participants totaling \$24,567 and \$26,183 for contributions in excess of amounts allowed by the IRS are recorded as a liability and subtracted from employee contributions for the year end December 31, 2024 and 2023.
