### **NOTE A - DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following brief description of the Teamsters Local 355 Legal Services Fund (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

#### **General**

The Plan was adopted on June 1, 1996, by the Joint Board of Trustees of the Plan (the “Plan Sponsor”). This Plan is designed to provide specific legal services to plan participants and their dependents as listed in the Plan.

#### **Eligibility**

An employee and his or her dependents initially become eligible for benefits on the first day of the month following three consecutive months in which the required payments were made to the Plan by an employer on behalf of the participant or in the form of self-payments by the participant in amounts established by the Board of Trustees.

#### **Benefits**

The benefits provided are specific legal services as listed in the Plan Document, as well as any limitation and surcharges for these services.

#### **Contributions/Contributions Receivable**

The Plan requires a payment of \$10.00 per month for eligibility (see note F for subsequent events).

A receivable is recorded for all unpaid contributions as of the Plan's year end. Plan management establishes an allowance for doubtful accounts for those receivables that are not considered fully collectible. As of December 31, 2024 and 2023, no allowance for doubtful accounts was considered necessary. The Plan does not believe that there is a material risk of loss with respect to this.

#### **Tax Status**

The Internal Revenue Service (“IRS”) has determined and informed the Plan by a letter dated January 13, 1997, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan, as amended, continues to qualify and operate in accordance with applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan's tax years of 2022 through 2024 remain subject to examination. There are currently no examinations for any tax periods in progress.

#### **Operational Expenses**

The Plan's expenses are paid for by the Plan, as provided by the Plan Document. Certain expenses incurred in connection with the general operations of the Plan are recorded as deductions in the accompanying Statements of Changes in Net Assets Available for Benefits.

### **NOTE A - DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

#### **Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

### **NOTE B - PLAN TERMINATION**

In the event that the Plan is terminated, the Board of Trustees shall use any remaining funds to satisfy existing and arising claims and to pay reasonable administrative expenses until such funds are exhausted.

### **NOTE C - PLAN ADMINISTRATION**

The Plan uses a third-party administrator to provide Plan administration and bookkeeping services. Until March 31, 2024, the Plan used Benefits Administration, LLC. Effective April 1, 2024, the Plan stopped services with Benefits Administration, LLC, and started services with BeneSys, Inc.

### **NOTE E - RELATED PARTY TRANSACTIONS**

Truck Drivers and Helpers Local Union No. 355 Health and Welfare Plan ("355 Health and Welfare") receives lockbox deposits on behalf of the Plan. The funds are then transferred to the Plan at the beginning of each subsequent month. As of December 31, 2024, 355 Health and Welfare owed \$2,310 to the Plan. The Plan received \$2,310 from 355 Health and Welfare in January 2025.

### **NOTE F - SUBSEQUENT EVENTS**

Effective July 1, 2025, the monthly participant contribution rate increased from \$10 to \$15.
