**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed audits of the financial statements of Star City Games 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Star City Games 401K Plan's 2024 and 2023 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion on the Financial Statements**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion on the Financial Statements**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Star City Games 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Star City Comics & Games, Inc. (the “Company”) who have one year of service and have attained age twenty-one. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of their annual compensation up to the maximum dollar amount set by the Internal Revenue Service, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers twenty-two mutual funds and one money market fund as investment options. The Company contributes 100% of each participant’s salary deferrals that do not exceed 3% of each participant’s compensation, plus 50% of each participant’s salary deferrals between 3% and 5% of each participant’s compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company’s board of directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the respective participant’s vested account.

Vesting

Participants are 100% vested immediately in their elective contributions of salary deferrals, including Roth 401(K) deferrals, “catch-up contributions,” and rollovers, plus earnings thereon. A participant is also 100% vested immediately in the employer matching contributions and employer profit sharing contributions, plus earnings thereon.

Loans to Participants

The Plan allows for participants to have only one loan outstanding at a time, with a maximum repayment term not to extend beyond five years from the date of the loan. The minimum loans to participants is \$1,000. The loan amount may not exceed the lesser of 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant’s account and bear interest at rates ranging from 7.75% to 8.50%, which are commensurate with the local prevailing rates as determined by the Plan administrator.

Payment of Benefits

Upon termination of service due to death or retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the total value of his or her account. An in-service distribution is permitted under certain situations and is limited to the vested amount of the participant’s account.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Date of Management’s Review

Subsequent events were evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

Basis of Presentation

The accounts of the plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting: investment income is recognized when received, and contributions income and benefits paid are recognized on the accrual basis of accounting. Accordingly, the financial statements are not intended to present the net assets available for benefits and the changes in net assets available for benefits of the Plan in conformity with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting may require the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities for the reported periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation or depreciation of investments consists of the realized gains or losses on investments bought and sold during the year and unrealized appreciation or depreciation on investments held during the year.

Notes Receivable - Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan that had not been paid as of December 31, 2024 or 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Certain additional expenses relating to specific participant transactions (such as distribution processing fees) are charged directly to the participant’s account.

**NOTE 3 – FAIR VALUE MEASUREMENT**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There were no plan assets requiring the use of level 2 or level 3 inputs for the periods presented.

Level 1 Fair Value Measurements:

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Net asset value per share:

Certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statement of financial position.

The following tables set forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. The carrying values of receivables, if any, included in the accompanying statement of net assets available for benefits approximated fair value at December 31, 2024, and 2023, respectively, and are thus not included in the following tables.

**NOTE 4 – INVESTMENTS**

Unaudited Information Certified by the Plan Trustee:

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosures under the Employee Retirement Income Security Act of 1974. Accordingly, the December 31, 2024 and 2023 Statements of Net Assets Available for Benefits (Modified Cash Basis), the investment activities included on the Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis) for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the plan trustee, Capital Bank and Trust Company.

As permitted, the investment information certified as complete and accurate by Capital Bank and Trust Company was not audited by the independent auditors except for comparing such information with the related information included in the accompanying financial statements and supplemental schedule. The Plan’s financial information that was certified by Capital Bank and Trust Company includes plan cash and investments as of December 31, 2024 and 2023 of \$4,679,724 and \$4,137,478, respectively, and net investment income for the year ended December 31, 2024 of \$622,513.

**NOTE 5 – RELATED PARTY TRANSACTIONS**

Substantially all plan investments are invested in mutual funds managed by Capital Bank and Trust Company, who is the trustee as defined by the Plan. Certain plan investments may also have internal expenses that compensate Capital Bank and Trust Company or its affiliates. Therefore, these transactions qualify as party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

**NOTE 6– PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 – TAX STATUS**

The Plan operates under a prototype non-standardized profit-sharing plan with a cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2014. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the plan's financial statements.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan's assets are invested in various investment securities. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
