## **Independent Auditors' Report**

To the Plan Administrator  
of Handel Architecture Design and Planning, Inc. Profit Sharing Plan:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

## Notes to Financial Statements

### NOTE 1: DESCRIPTION OF PLAN

The following description of the Handel Architecture Design and Planning, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of Handel Architecture Design and Planning Inc. (the "Company") who are age 21 or older and have achieved one full calendar month of employment, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### Contributions

Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled accounts comprised of mutual funds as investment options to participants. The Company contributes twenty-five percent of the first six percent of base compensation that a participant contributes to the Plan. On June 30, 2020, the Company suspended its discretionary matching contributions due to financial hardship and subsequently reinstated it on August 31, 2021. Additional profit-sharing amounts may be contributed at the option of the Company's management and are invested as directed by the Company. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in their portion of the Company's contribution is based on years of continuous service, which are counted as follows:

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant's account, and bear interest at 5.00% - 9.50% per annum, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Repayments are generally due in installments over periods ranging from one to five years, unless the note is used for the purchase of a primary residence, in which case the repayment period may be greater. Principal and interest are paid ratably through monthly payroll deductions. A note that is considered in default is reported as a deemed distribution, which may be a taxable event for the participant.

##### Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant or their designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

##### Forfeited Accounts

Account balances that were forfeited by participants during 2024 and 2023 totaled \$9,663 and \$7,506, respectively. Forfeitures may be used to pay administrative costs of the Plan or reduce future employer contributions. For the year ended December 31, 2024, there were no accumulated forfeitures used to pay administrative expenses. Forfeited account balances are included in total non-interest bearing cash on the statements of net assets available for benefits, which totaled \$23,226 and \$13,562 as of December 31, 2024 and 2023, respectively.

#### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor determines the valuation policies utilizing information provided by investment advisors, custodians and insurance companies. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees to administer the loans are charged to the participants' accounts and are recorded as administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Expenses**

Some expenses of maintaining the Plan are paid directly by the Plan from the cash account and are included in administrative expenses. Certain expenses of maintaining the Plan may be paid directly by the Company and excluded from these financial statements. The cash account is generally funded by participant account forfeitures. Investment-related expenses are included in net appreciation in fair value of investments. In addition, fees related to the administration of notes receivable from participants are charged directly to the participant's account.

#### **NOTE 3: INVESTMENTS - INFORMATION PREPARED AND CERTIFIED AS COMPLETE AND ACCURATE BY THE CUSTODIAN**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by John Hancock Life Insurance Company of New York ("John Hancock") (the custodian of the Plan).

For the year ended December 31, 2024, the appreciation of investments amounted to \$4,334,075. As of December 31, 2024 and 2023, the investments at fair value consist of pooled separate accounts totaling \$28,389,016 and \$23,814,276, respectively. The investments have been certified by John Hancock.

The custodian has also certified notes receivable from participants in the amount of \$124,667 and \$87,895 as of December 31, 2024 and 2023, respectively. Interest income on notes receivable from participants for the year ended December 31, 2024 totaled \$6,799.

#### **NOTE 4: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### **Pooled Separate Accounts:**

Pooled separate accounts are valued at net asset value ("NAV"), as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. The separate accounts are comprised of a variety of mutual funds. The pooled separate accounts have no unfunded commitments, redemption restrictions or redemption notice requirements.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31:

\* **Pooled Separate Account:** The objective of these accounts is to provide liquidity and meet short-term cash needs. Cash equivalent accounts are used to provide diversification and preserve principal. The underlying holdings in the cash accounts are investment grade money market instruments including commercial paper, certificates of deposit, U.S. Treasury bills and other types of investment grade short-term debt securities. The cash accounts are valued each business day and provide daily liquidity.

**NOTE 5: RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are units of pooled separate accounts managed by John Hancock. John Hancock is the custodian, as defined by the Plan, and therefore, transactions with these investments qualify as party-in-interest transactions. Fees incurred by the Plan for managing investments are included in investment income, as they are paid through revenue sharing, rather than as a direct payment.

In addition, John Hancock charged a total of \$91,697 to certain participants for transaction and loan fees for the year ended December 31, 2024.

Notes receivables are also considered party-in-interest transactions.

**NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time, and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7: TAX STATUS**

The IRS has determined and informed the Company by a letter dated July 19, 2002, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe that the Plan is designed and operated in compliance with the applicable requirements of the IRC, thereby confirming that the Plan is qualified, and the related trust is tax-exempt.

**NOTE 7: TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are generally exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9: SUBSEQUENT EVENTS**

Management has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.
