INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee and Plan Participants and Beneficiaries of
ContourGlobal Management, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ContourGlobal Management, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ContourGlobal Management, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ContourGlobal Management Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

DECEMBER 31, 2024 AND 2023

NOTE 1: DESCRIPTION OF THE PLAN

The following description of the ContourGlobal Management, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan provisions.

General

The ContourGlobal Management, Inc. 401(k) Plan, as amended and restated, was established August 1, 2008, as a defined contribution plan covering all eligible employees of ContourGlobal Management, Inc. (the "Plan Sponsor" or the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Participants are eligible to enroll in the Plan on the first day of employment. Employees must attain the age of 21 before participating in the plan.

Contributions

A participant of the plan may elect to make a Pre-Tax 401(k) deferral or a Roth 401(k) deferral. The plan does not automatically enroll employees.

Participants may elect to contribute up to 100% of their annual pre-tax compensation, as defined, to the Plan, subject to Internal Revenue Service limitations, and may direct their contributions to various investment alternatives. Participants may also designate some or all of their contributions as an after-tax Roth contribution, subject to limitations. The contribution limit applies to any calendar year and is adjusted annually by the Internal Revenue Service. Additionally, participants who attain age 50 during the plan year may make "catch up" contributions. The Plan allows rollover contributions from some other qualified retirement plans. The Plan is participant directed. Participants may change their contribution rates at the beginning of each payroll period and investment options at any time.

For each plan year, the Company shall contribute a matching contribution to each participant equal to 100% of employee deferrals up to a maximum of 6% of a participant's eligible annual compensation or \$12,000 in the current year. Participants must have attained the age of 21 during the plan year to be considered eligible for the matching contribution. The Company may also make a discretionary nonelective profit-sharing contribution to all eligible participants during the plan year. Participants must attain at least one year of service, as defined, during the plan year to qualify for the profit-sharing contribution. There were no nonelective profit-sharing contributions made to the Plan in 2024.

NOTE 1: DESCRIPTION OF THE PLAN (*Continued*)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative fees that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Benefits paid to participants under the Plan are limited to the vested balance in each participant's account.

Vesting and Payment of Benefits

For vesting purposes, a participant is always 100% vested for salary deferrals, and rollovers. Employer matching contributions are 100% vested after 1 year of service. Employer profit sharing vesting percentages are determined using the vesting schedule below:

Years of Service	Percentage Vested
0-1 Years	0%
1-2 Years	30%
2-3 Years	70%
3+ Years	100%

The normal retirement age under the Plan is 65. Participants who have attained the age of 59 ½ may receive distributions during employment. Hardship distributions are also available to employees in limited circumstances. Distributions are required for participants over 70 ½ to meet the minimum distribution requirements of Internal Revenue Code regulations. Except for minimum distribution requirements, payments to retirees, employees or separated employees are paid in either a lump sum or installment plan paid over a specified period. Separating participants may elect to rollover their account into another plan, as permitted by Internal Revenue Service regulations. Termination due to death, disability or retirement will allow a participant to elect to receive a lump sum amount equal to the value of the participant's vested account balance, in the form of a cash distribution, a direct rollover distribution, or a combination of both. For termination due to other reasons, a participant may receive the value of the account as a lump sum distribution.

Mandatory distributions greater than \$1,000 but not more than \$5,000 that are made in accordance with the provisions of the Plan providing for an automatic distribution to a participant without the participant's consent, if the participant does not elect to have such distribution paid directly to an "eligible retirement plan" specified by the participant in a direct rollover (in accordance with the direct rollover provisions of the Plan) or to receive the distribution directly, the Administrator shall pay the distribution in a direct rollover to an individual retirement plan designated by the Administrator. Participants with an account balance of greater than \$5,000 can elect to indefinitely maintain their account balance within the Plan.

NOTE 1: DESCRIPTION OF THE PLAN (*Continued*)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the Plan. Interest rates on loans are stated at a reasonable rate. Loans are repaid in level installments through payroll deductions for periods ranging up to five years, and in certain situations may exceed five years. Loans are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest.

Forfeitures

Forfeitures of non-vested profit-sharing or matching contributions due to termination of employment can reduce Company contributions to the Plan, pay certain administrative expenses, or allocated to eligible participants based on their compensation for the Plan year. In 2024, employer contributions were reduced by \$44,792. Unused forfeitures as of December 31, 2024 and 2023 were \$0 and \$1,279, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, each participant's account balance becomes 100% vested.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. At December 31, 2024 and 2023, no allowance was considered necessary by management.

Administrative fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to notes receivable from participants, withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative fees. Other investment-related expenses are included in net appreciation of investments.

Benefit Payments

Distributions to participants are recorded when paid.

NOTE 3: ADMINISTRATION AND INVESTMENTS

Administration

All the Plan's investments are administered by John Hancock Life Insurance Company ("John Hancock"). Among other duties, John Hancock receives contributions, invests and reinvests the Plan's assets, collects income and makes distributions from the Plan's assets as directed by the trustee for the Plan.

Investments

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, all investment information disclosed in the accompanying financial statements and supplementary schedules, including investments held at December 31, 2024 and 2023, and income information for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock, the custodian of the Plan. Accordingly, the Plan's independent auditors did not perform any procedures with respect to this information, except comparing and reconciling such information to the financial statements.

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan measures the fair value of Plan assets as the price that would be received to sell an asset in the principal market for that asset. These measurements are classified into a hierarchy framework by the inputs used to perform the fair value calculation. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

As required by FASB ASC 820-10, financial assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The Company's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2: Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts:

The fair value of these mutual funds is a publicly quoted pricing input used in determining the NAV of the pooled separate account, which is not publicly quoted. Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The funds are valued daily.

The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of the fair value of assets and liabilities and their placement within the fair value hierarchy levels.

NOTE 5: PARTY-IN-INTEREST TRANSACTIONS

Administrative fees paid out of the Plan to John Hancock New York, the Plan's recordkeeper, were \$73,782 in 2024. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provision.

NOTE 6: INCOME TAX STATUS

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan did not have unrecognized tax benefits as of December 31, 2024 and 2023 and does not expect this to change significantly over the next twelve months. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions.

NOTE 7: RISKS AND UNCERTAINTIES

Plan participants make choices regarding their investment securities, and are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that reduction in value can occur in the near term and that such changes could materially affect participant account balances reported in the statement of net assets available for benefits.

NOTE 8: SUBSEQUENT EVENTS

The Plan's management evaluated subsequent events through the date on which the financial statements were issued. There were no events or transactions discovered during this evaluation that require recognition in the financial statements.


