NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of Plan

The following description of the Reames Concrete Company, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a single employer defined contribution plan covering all full-time employees of the related companies of Reames Concrete Company, Inc., Reames and Son Construction Company, Inc., and Reames Leasing Company (collectively the "Plan Sponsors") who have six months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: The Plan provides that an employee shall become eligible to participate in the Plan on the first day of any month of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirements. Participation entitles the employee to an allocation of the Company's contributions and forfeitures.

Contributions: Participants may elect to contribute any percentage, not to exceed 100% of pretax annual compensation, subject to maximum contribution limitations established by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. During the year, the Plan Sponsors were required to make matching contributions to the individual account of each eligible participant equal to 100 percent of the amount of the employee's elective deferrals that do not exceed three percent of compensation. In addition, the Plan Sponsors may elect to make additional discretionary contributions to the Plan on an annual basis, but are not required to do so. Participants direct the investment of their account into various investment options offered by the Plan, which currently includes various mutual funds.

Participant Accounts: Each participant's account is credited with the participant's contribution, the sponsor's matching contribution, and allocations of (a) the sponsor's discretionary contribution; and (b) plan earnings; and charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions, the sponsor's matching contributions, plus actual earnings thereon. Vesting in the sponsor's discretionary contributions is based on years of continuous service under a six-year graded vesting schedule of 0% at less than two years, 20% at two years, 40% at three years, 60% at four years, 80% at five years, and 100% at six or more years of service.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, participant loans totaled \$184,468 and \$194,063, respectively. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. During the years ended December 31, 2024 and 2023, participant loans reclassified as distributions totaled \$0 and \$10,559, respectively.

Note 1 - Description of Plan (Continued)

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over the participant's life expectancy. For termination of service for any other reasons, distribution of a participant's vested interest is made in a lump-sum payment.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions: Discretionary employer contributions are recorded when they are approved by the Board of Directors. Participant and employer matching contributions are recorded as soon as amounts are determined.

Excess Contributions Payable: Amounts payable to participants totaling \$11,656 and \$9,134 for the years ended December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as contributions payable. Participant contributions are shown net of the payable, but are shown separate on Form 5500.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. See Note 7 for discussion of fair value measurements.

Related Party Transactions: Certain plan investments are shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock is the custodian of the plan's investments and, therefore, all investment transactions related to investments managed by John Hancock are considered to be party-in-interest transactions. The Plan Sponsors provide the Plan with certain accounting and administrative services for which no fees are charged. Fees paid during the year for accounting and other professional services provided by party-in-interest, Fowler, Holley, Rambo & Stalvey, P.C., were based on customary and reasonable rates for such services.

Administrative Expenses: Significant costs of plan administration are absorbed by the Company. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events: The plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

Note 3 - Investments

Some of the mutual funds held as investments by the Plan may invest in derivatives to achieve certain investment goals. Derivatives may involve risks different from, and possibly greater than, the risk associated with investing directly in securities and other traditional investments.

Note 4 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts.

Note 5 - Tax Status

The Internal Revenue Service issued its latest letter on March 31, 2014, which stated that the Plan qualified under the applicable provisions of the Internal Revenue Code and therefore is exempt from Federal Income tax. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan has operated within the terms of the Plan and should remain qualified under the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, Department of Labor, or Georgia Department of Revenue.

The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6 - Information Certified by the Custodian

The following information included in these financial statements was provided and certified as complete and accurate by John Hancock Life Insurance Company in their report for the years ended December 31, 2024 and 2023. No audit work was performed with respect to this information except for comparing such information with the related information included in the financial statements.

Note 7 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 8 – Related Party Transactions

John Hancock Life Insurance Company acts as trustee of the Plan. Certain investments of the Plan are in mutual funds managed directly by or by an affiliate of the trustee and represent party-in-interest investments. The Plan also incurred fees for investment management services for the years ended December 31, 2024 and 2023, which were paid by the plan sponsor.

Note 9 – Risks and Uncertainties

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
