Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nail Alliance-401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with Section 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1. PLAN DESCRIPTION

The following description of Nail Alliance-401k Plan (the Plan) for the employees of Nail Alliance North America (the Company or Employer) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan, which was established effective January 1, 2020, is a defined contribution plan covering all employees of the Company who are at least 21 years of age, except for union employees, non-resident aliens and leased employees. Plan entry date is the first day of the quarter coinciding with or next following the completion of the eligibility requirements. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts and Contributions: Participants may elect to contribute any combination of pre-tax deferrals or Roth deferrals from eligible earnings, as defined in the Plan. Participants may elect a different percentage or elect not to make deferral contributions to the Plan. The maximum participant deferral limit was \$23,000 for the year ended December 31, 2024. Catch-up contributions of \$7,500 were available to participants who have attained age 50 or older by December 31, 2024, and have not exceeded the contribution limit for the Plan year.

The Plan includes a Safe Harbor provision, under which the Company makes contributions equal to 100% of the participant salary deferrals up to 3% of the participant's compensation, plus 50% of the salary deferrals in excess of 3% but not exceeding 5% of the participant's compensation. The Plan also provides for an annual true up of matching contributions to ensure that each participant receives full safe harbor match to which they are entitled based on their total eligible compensation and elective deferral for the Plan year.

The Safe Harbor contribution amounted to \$149,832 for the year ended December 31, 2024. The Plan also assesses annual true up matching contributions. The total true up contributions amounted to \$30,900 for the year ended December 31, 2024.

The Company may make discretionary profit-sharing contributions to the Plan. There were no such contributions for the year ended December 31, 2024.

Each participant's account is credited or charged with the participant's contributions, Company contributions, allocations of investment earnings or losses and administrative expenses.

Vesting: Participants are immediately vested in their voluntary contributions, safe harbor contributions and rollover contributions, plus actual earnings thereon. A participant is vested 20% per year in discretionary profit sharing contribution and is fully vested after five years of service.

Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, the Company contributions amount becomes 100% vested without regard to years of service.

Forfeitures: Forfeitures of terminated participants' unvested amounts may be used to reduce future Company contributions to the Plan for the remaining employees or to pay administrative expenses. \$171 forfeitures were used during the year ended December 31, 2024. Forfeitures available for future use were \$5,341 and \$4,846 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants: Participants may borrow from their vested account balances up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The minimum loan is \$1000. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate as published in The Wall Street Journal, plus 1%. Principal and interest are paid ratably through payroll deductions or the participant's own personal funds over a term not to exceed five years, except for loans used to purchase or improve the participant's primary residence, which may have a repayment term not to exceed 30 years. Effective July 1, 2024, the Plan was amended to remove and/or not permit any participant loans.

Benefit Payments: Distributions of a participant's account, if elected by participant or beneficiary, are made upon termination of service, death, disability, or retirement. Distributions are made in a lump-sum payment. An in-service distribution can also be made to participants who have attained the age of 59-1/2, upon disability or when experiencing financial hardship.

Administrative Expenses: The Company incurs certain expenses in administering the Plan, which if not paid by the Company are passed on as expenses of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income (Loss) Recognition: The Plan's investments are stated at fair value. Investments in shares of registered investment companies (mutual funds) are valued at quoted market prices, which represent the net asset value of the shares held at year end. See Note 6 for discussion of fair value measurements.

Realized and unrealized appreciation (depreciation) is based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time of the asset purchase/exchange during the Plan year.

Valuation of Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid balance plus accrued but unpaid interest.

Contribution Receivables: Employee and related company contribution receivables are recorded in the period the employee contribution is withheld.

Benefit Payments: Benefits are recorded when paid.

NOTE 3. CERTIFIED FINANCIAL INFORMATION

The Plan Administrator has elected the method of compliance permitted by Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, notes receivable from participants, and the schedule of assets held at end of year has been derived from information certified as complete and accurate by Capital Bank and Trust Company, the trustee of the Plan, in accordance with Section 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. INCOME TAX STATUS

The Company has adopted a non-standardized profit-sharing plan that has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS), which stated that the plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 5. RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds, which are exposed to various risks such as interest rate, market performance and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6. FAIR VALUE MEASUREMENTS

Fair value is determined based on assumptions that a market participant would use in pricing an asset or liability. Measurements of fair value are classified within a hierarchy based upon valuation inputs that gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

- Level 1* Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in markets that are not active;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds: Valued using quoted market prices, which represent the net assets value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
