Independent Auditor's Report

To the Administrative Committee and Management of USAN, Inc. Employees' Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

Notes To Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following description of the USAN, Inc. Employees' Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement and Summary for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1995 as a defined contribution plan and is sponsored by United States Advanced Network, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation

Employees are eligible to enter the Plan as a participant and to make elective deferrals upon attainment of age 18.

Contributions

Contributions to the Plan may come from employee salary reduction contributions and rollover contributions from other qualified retirement plans.

The Plan provides for automatic deferral provisions to allow the employer to withhold 3% of compensation for each payroll period with an escalation feature unless the participant elects out. The escalation feature allows for a 1% annual increase up to a maximum of 6%. A participant may elect to contribute through salary deferrals between 1% and 90% of compensation in any Plan year, subject to certain limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participants may also rollover amounts from other qualified retirement plans into their accounts.

The Plan records participant contributions receivable when compensation is paid and deferrals are withheld. In accordance with ASC 326, *Financial Instruments - Credit Losses*, no allowance for credit losses has been recorded at December 31, 2024 and 2023, as participant contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses. Allocations are pro rata based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their own contributions and the investment earnings thereon.

NOTE 1.**DESCRIPTION OF PLAN (CONTINUED)****Allocation of Plan Income Earned**

Net income earned and unrealized gains or losses on investments are allocated to the participant accounts based on the ratio that the individual account bears to all participants in the same investment as of each valuation date. Accounts are valued on a daily basis.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balances with a minimum loan request of \$500 and a maximum of \$50,000 reduced by the excess (if any) of (i) the highest outstanding balance of loans from the Plan during the twelve (12) month period ending on the day before the loan is made, over (ii) the outstanding balance of loans from the Plan on the date the loan is made. Loan terms may not exceed five years except when used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear an annual interest rate of prime plus 1% (9.50% at December 31, 2024). The interest rate is fixed on the day the loan is processed and will remain constant during the term of the loan. Principal and interest are paid ratably through payroll deductions.

The initial loan application fee is \$125, which is deducted from the participant's account balance in the Plan and will not reduce the proceeds of the loan.

Hardship Withdrawals

A participant may elect to withdraw the balance of their account attributable to their salary reduction election provided such withdrawal is to meet their immediate and significant needs.

Payment of Benefits

Upon a participant's death, disability, normal retirement, or other termination of employment from the Company, a participant may elect to receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also allows in-service distributions to a participant who has not separated from service provided the participant has attained the age of 59 1/2.

NOTE 2.**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES****Basis of Accounting**

The accounting records of the Plan are maintained on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the investment in a group annuity contract which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. Shares of registered investment companies and mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. See Note 4 for discussion of fair value measurements and Note 9 for discussion on the group annuity contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments and notes receivable from participants is recorded on a cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as being held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses for maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses of the Plan are allocated to participant accounts.

NOTE 3. SUBSEQUENT EVENTS

The Plan sponsor has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued and has determined there are no subsequent events requiring disclosure.

NOTE 4. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement according to accounting literature establishes a fair value hierarchy that prioritizes the use of observable inputs in measuring fair value. The level of a fair value measurement is determined entirely by the lowest level input that is significant to the measurement.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

The three levels are:

Level 1 – Quoted prices in active markets for identical assets or liabilities, accessible to the entity at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Unobservable inputs that are not corroborated by market data.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Within the fair value hierarchy, the following table sets forth by level the Plan's investments at fair value as of December 31, 2024 and 2023:

There are no investments measured at Level 2 or 3 within the fair value hierarchy.

NOTE 5. TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. Certain Plan investments are managed by the Custodians as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions. Certain fees related to the administration of the Plan, including advisory services, were paid by the Plan which totaled \$79,336 in 2024.

NOTE 6. PLAN TERMINATION

While it is the Company's intention to continue the Plan indefinitely, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the Plan Agreement. In the event of Plan termination, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 7. FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS

The Plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan management instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, except for comparing such information certified by the custodians with information included in the Plan's financial statements and supplemental Schedule H, line 4i-Schedule of Assets (Held at End of Year):

NOTE 8. TAX STATUS

The Company adopted a prototype standardized profit sharing plan with a cash deferral arrangement that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020. The letter stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable provisions of the Internal Revenue Code.

Participants in the Plan are not subject to income taxes on their contributions, earnings, or appreciation on investments held in the Plan until withdrawn by the participant or distributed to the participant's named beneficiary in the event of death.

The Plan administrator believes that the Plan does not have any material uncertain tax positions at December 31, 2024.

NOTE 9. GROUP ANNUITY CONTRACT

In 2017, the Plan entered into a group annuity contract with Empower Annuity Insurance Company of America (EAICA) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product of EAICA. This account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE 9. GROUP ANNUITY CONTRACT (CONTINUED)

Because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fund credits interest to the contract holder on a portfolio basis. The crediting interest is based on a formula agreed upon with the issuer and may not be less than -%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include: (a) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact a contract value with participants are probable of occurring.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan's participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
