Independent Auditor's Report

To the Board of Directors and Plan Administrator of
Work, Inc. Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Work, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF PLAN

The following description of Work, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- a. **General** - The Plan is a defined contribution plan covering substantially all full-time employees of Work, Inc. (the Plan Sponsor). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Plan Sponsor's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **Eligibility** - Employees are eligible to participate in the Plan once they have completed six months of service with at least 1,000 hours and have attained age twenty and a half. The Plan excludes employees covered by a collective bargaining agreement, non-resident aliens, and individuals who are identified as the Plan Sponsor's clients.
- c. **Contributions** - Each year, the Board of Directors determines the amount, if any, the Plan Sponsor will contribute to the Plan. Plan Sponsor contributions are allocated to participant accounts based upon an age-weighted-average factor applied to each participant's salary as a percentage of the total of all participants' salaries. The Board of Directors did not approve a contribution to the Plan for the year ended December 31, 2024. Employees are not permitted to make contributions to the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.
- d. **Participant Accounts** - Each participant's account is credited with an allocation of (a) the Plan Sponsor's contribution, (b) plan earnings or losses, (c) forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. **Vesting** - A year of service is credited upon completion of 1,000 hours of service. Participants vest 20% per credited year after the first year of credited service and become fully vested after six years.
- f. **Investment Options** - Upon enrollment in the Plan, participant account balances are pooled together and invested in mutual and money market funds within the Balanced Model option provided by Rockland Trust, the qualified institution of the Plan. Participants may not direct contributions or investments.
- g. **Participant Loans** - Participant loans are not permitted under the Plan.
- h. **Payment of Benefits** - The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of sixty-five, with no option for early retirement. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their vested account, or rollover the balance into another retirement plan account. There are also retirement benefits available upon death or disability. In-service withdrawals and hardship distributions are not permitted within the Plan.

1. DESCRIPTION OF PLAN (Continued)

- i. **Forfeitures** - Upon incurring a one-year break in service for any reason other than retirement, death or disability, all amounts held in a participant's employer contribution account which are not vested shall be reallocated to the accounts of the other participants in the same manner as the Plan Sponsor's employer contribution, as permitted by the Plan's provisions. If such a participant is re-employed prior to incurring five consecutive one-year breaks in service, the amounts which were forfeited shall be restored to the participant's account. Forfeitures may also be used to reduce plan expenses. The Plan had \$954 of unallocated forfeitures as of December 31, 2023, which were reallocated to plan participants during 2024. The Plan did not have any unallocated forfeitures as of December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual and money market funds are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual and money market funds, at fair value, includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

The discretionary Plan Sponsor contribution is recorded when such contribution is authorized by the Plan Sponsor's Board of Directors.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include investment management fees and distribution processing fees paid by the Plan. Investment-related expenses are included in net appreciation of mutual and money market funds, at fair value.

Subsequent Events

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Rockland Trust has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedules, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and Form 5500, Schedule H, Part IV, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedules.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENT (Continued)

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual and money market funds: Valued at the daily closing price as reported by the funds. Mutual and money market funds held by the Plan are open-ended mutual funds and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested, and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTION

Sections 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Certain plan investment funds managed and held by the qualified institution are considered party-in-interest transactions. Furthermore, the Plan has a service agreement with Bright Rock Capital Management, LLC who is a wholly owned subsidiary of Rockland Trust that provides investment manager services for the Plan. Both Bright Rock Capital Management, LLC and Rockland Trust are considered parties-in-interest.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institution for its administrative services to the Plan. During 2024, the Plan paid the qualified institution for investment services, processing of distributions, and recordkeeping services totaling \$15,807, which is presented net of \$3,922 of revenue sharing credits in the accompanying statement of changes in net assets available for benefits.

8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in a number of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.

Independent Auditor's Report

To the Board of Directors and Plan Administrator of
Work, Inc. Profit Sharing Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Work, Inc. 1. DESCRIPTION OF PLAN

The following description of Work, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

- a. **General** - The Plan is a defined contribution plan covering substantially all full-time employees of Work, Inc. (the Plan Sponsor). The Plan Administrator is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, monitoring investment performance, and reporting to the Plan Sponsor's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b. **Eligibility** - Employees are eligible to participate in the Plan once they have completed six months of service with at least 1,000 hours and have attained age twenty and a half. The Plan excludes employees covered by a collective bargaining agreement, non-resident aliens, and individuals who are identified as the Plan Sponsor's clients.
- c. **Contributions** - Each year, the Board of Directors determines the amount, if any, the Plan Sponsor will contribute to the Plan. Plan Sponsor contributions are allocated to participant accounts based upon an age-weighted-average factor applied to each participant's salary as a percentage of the total of all participants' salaries. The Board of Directors did not approve a contribution to the Plan for the year ended December 31, 2024. Employees are not permitted to make contributions to the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations.
- d. **Participant Accounts** - Each participant's account is credited with an allocation of (a) the Plan Sponsor's contribution, (b) plan earnings or losses, (c) forfeitures of terminated participants' non-vested accounts, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- e. **Vesting** - A year of service is credited upon completion of 1,000 hours of service. Participants vest 20% per credited year after the first year of credited service and become fully vested after six years.
- f. **Investment Options** - Upon enrollment in the Plan, participant account balances are pooled together and invested in mutual and money market funds within the Balanced Model option provided by Rockland Trust, the qualified institution of the Plan. Participants may not direct contributions or investments.
- g. **Participant Loans** - Participant loans are not permitted under the Plan.
- h. **Payment of Benefits** - The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of sixty-five, with no option for early retirement. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their vested account, or rollover the balance into another retirement plan account. There are also retirement benefits available upon death or disability. In-service withdrawals and hardship distributions are not permitted within the Plan.

1. DESCRIPTION OF PLAN (Continued)

- i. **Forfeitures** - Upon incurring a one-year break in service for any reason other than retirement, death or disability, all amounts held in a participant's employer contribution account which are not vested shall be reallocated to the accounts of the other participants in the same manner as the Plan Sponsor's employer contribution, as permitted by the Plan's provisions. If such a participant is re-employed prior to incurring five consecutive one-year breaks in service, the amounts which were forfeited shall be restored to the participant's account. Forfeitures may also be used to reduce plan expenses. The Plan had \$954 of unallocated forfeitures as of December 31, 2023, which were reallocated to plan participants during 2024. The Plan did not have any unallocated forfeitures as of December 31, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual and money market funds are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of mutual and money market funds, at fair value, includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

The discretionary Plan Sponsor contribution is recorded when such contribution is authorized by the Plan Sponsor's Board of Directors.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include investment management fees and distribution processing fees paid by the Plan. Investment-related expenses are included in net appreciation of mutual and money market funds, at fair value.

Subsequent Events

Subsequent events have been evaluated through September 19, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Rockland Trust has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedules, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and Form 5500, Schedule H, Part IV, Line 4j - Schedule of Reportable Transactions for the year ended December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedules.

4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENT (Continued)

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual and money market funds: Valued at the daily closing price as reported by the funds. Mutual and money market funds held by the Plan are open-ended mutual funds and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used at December 31, 2024 and 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become fully vested, and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTION

Sections 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Certain plan investment funds managed and held by the qualified institution are considered party-in-interest transactions. Furthermore, the Plan has a service agreement with Bright Rock Capital Management, LLC who is a wholly owned subsidiary of Rockland Trust that provides investment manager services for the Plan. Both Bright Rock Capital Management, LLC and Rockland Trust are considered parties-in-interest.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institution for its administrative services to the Plan. During 2024, the Plan paid the qualified institution for investment services, processing of distributions, and recordkeeping services totaling \$15,807, which is presented net of \$3,922 of revenue sharing credits in the accompanying statement of changes in net assets available for benefits.

8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in a number of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances, and the amounts reported in the accompanying statements of net assets available for benefits.


