Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Champion, Incorporated 401(k) Safe Harbor Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Champion, Incorporated 401(k) Safe Harbor Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the Champion, Incorporated 401(k) Safe Harbor Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan which was established by Champion, Inc. (the Plan Sponsor), on January 1, 1977, under the provisions of Internal Revenue Code Section 401(k). The Plan was most recently restated effective October 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

In May 2023, July Business Services acquired the recordkeeping and administration business of Heartland Financial USA, subsidiary, Dubuque Bank and Trust Company, the trustee of the Plan, and its division HTLF Retirement Plan Services. July Business Services now serves as the Plan's recordkeeper and Mid-Atlantic Trust Company as the trustee and custodian of the Plan assets.

Eligibility

Generally, each employee of the Plan Sponsor and the participating employers Project Service, Inc.; Verrette Materials, Inc.; Gundlach Champion, Inc.; Champion Concrete, Inc.; and Champion Charter Sales and Service, Inc., who is not a member of a collective bargaining unit and has attained age 18 is eligible to be a participant in the Plan. As of April 1, 2019, the Plan was amended to include the General Teamsters Local Union Number 406 employees and Michigan Laborers Local 1329 Specialty Agreement with Gundlach Champion, Inc. employees. If a participant terminates employment and is later re-employed, that employee shall become a participant upon re-employment.

Contributions

Each year, participants may elect to contribute up to 100% of their annual compensation on either a pre-tax (traditional) or after-tax (Roth) basis, not to exceed Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as defined by the IRC. Employees may directly "roll over" their assets from a qualified plan at a previous employer and transfer the assets into the Plan account.

The Plan Sponsor makes a safe harbor matching contribution of 100% of employee contributions on the first 3% of compensation, plus 50% of deferrals between 3% and 5% of compensation.

The Plan Sponsor may also make discretionary contributions each year. No discretionary contributions were made in 2024 or 2023.

1. Description of Plan (continued)

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options and transfer between funds as desired.

Participant Accounts

Each participant is credited with the participant's contribution, the Plan Sponsor's safe harbor contribution, and discretionary contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participant loans are not permitted.

Vesting

Participants are immediately vested in their voluntary contributions, employer safe harbor matching contributions, and earnings thereon. Vesting in employer discretionary amounts is based on years of continuous service with 20% vesting after two years and an additional 20% vesting for each of the next four years of service. Participants also become 100% vested upon normal retirement, death, or disability.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant is entitled to receive a distribution of their vested account balance in either:

- a single lump-sum payment in cash,
- installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancies of the participant and their beneficiary), or
- partial distributions.

If the participant's vested account balance is less than \$5,000, a distribution will be made to the participant as soon as administratively feasible following termination of employment.

Participants may be allowed to withdraw balances prior to termination of their employment under certain conditions specified in the Plan. In-service distributions may be made to participants who have not separated from service once they have attained age 59½ or have incurred a financial hardship as specified in the Plan.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan for these services. Certain administrative costs of the Plan are paid by the Plan Sponsor and are not included in these financial statements.

Forfeited Accounts

Forfeited discretionary contributions may be used to reduce future employer contributions or pay administrative expenses of the Plan. Forfeited non-vested accounts totaled \$0 as of December 31, 2024 and \$1,271 as of December 31, 2023. In 2024, employer contributions were reduced by \$1,271 from forfeited non-vested accounts. No forfeitures were used to reduce contributions or pay administrative fees in 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded as deductions upon distribution.

Reclassifications

Certain prior year amounts have been reclassified to conform to the current year presentation.

3. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Income Tax Status

The Company adopted a volume submitter plan, which received a favorable opinion letter from the IRS dated June 30, 2020. The letter stated the plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is qualified for federal income tax-exempt status. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

5. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Parties-In-Interest Transactions

The Plan Sponsor, participants, July Business Services, and Mid-Atlantic Trust Company (MATC) have all been identified as parties-in-interest.

The Plan investment options include a money market fund managed by MATC, the trustee of the Plan.

Certain expenses, including salaries and services required for Internal Revenue Service reporting, related to the administration of the Plan were paid by the Plan Sponsor.

7. Financial Information Certified by the Trustee (unaudited)

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investment balances held as of December 31, 2024 and 2023, and net appreciation/depreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid-Atlantic Trust Company (the trustee of the Plan). This certified information has not been audited by independent auditors.

8. Fair Value Measurements

As defined in the current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The guidance is applicable to all financial instruments that are measured and reported on a fair value basis. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a company’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: The fair value of mutual funds is based on quoted net asset values (NAVs) of the shares, as reported by the fund. The mutual funds held by the Plan have quoted prices and are considered actively traded.

Money Market Fund: Valued at carrying value, which approximates fair value.
