INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Plan Management

Opinion

We have audited the accompanying financial statements of the Hendry Marine Industries, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (liquidation) as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits (liquidation) for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (liquidation) of Hendry Marine Industries, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023 and the changes in its net assets available for benefits (liquidation) for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Hendry Marine Industries, Inc. Employee Stock Ownership Plan approved a plan of liquidation on May 12, 2023, and management determined liquidation is imminent. As a result, the Plan used the liquidation basis of accounting in presenting the 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Hendry Marine Industries, Inc. (the “Company” or the “Sponsor”) Employee Stock Ownership Plan (the “Plan” or “ESOP”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Company established the Plan effective January 1, 2015. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by an ESOP Administrative Committee of the Company (the “Committee”). The Committee has authority to control and manage the operations and administration of the Plan and has all powers necessary to enable it to carry out its duties. The Committee is responsible for oversight of the Plan. James Urbach serves as the Plan’s independent trustee (the “Trustee”) under the terms of a trust agreement between James Urbach and the Company.

Effective January 1, 2023, the Board of Directors of the Company elected to freeze the Hendry Marine Industries, Inc. Employee Stock Ownership Plan and related Trust and provided that (i) no additional employees of the Company would be eligible for and enter the ESOP, (ii) no additional contributions would accrue to the benefit of the participants after the plan year ended December 31, 2022, and (iii) no further contributions or distributions would be made by the Company to the ESOP. Also effective January 1, 2023, the Company agreed that interest on the Promissory Note due to the Company from the ESOP would cease to accrue, and only the unpaid principal would remain payable.

Plan Termination

The Sponsor reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the Administrator should direct the Trustee to pay all liabilities and expenses of the trust and to sell shares of financed convertible preferred stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan.

Effective May 12, 2023, the Board of Directors of the Company elected to terminate the Plan. Upon termination of the Plan, all participants became 100% vested in their account balances. Immediately thereafter, the Company (i) redeemed 336,643 allocated shares of common stock of the Company owned by the Plan for \$2,181,447 and (ii) forgave and cancelled the remaining outstanding balance of the ESOP Note. Upon receipt of a favorable determination letter from the IRS, the ESOP funds will be distributed to the participants.

Subsequent to year-end, the Plan received a favorable determination letter from the IRS dated February 18, 2025.

Eligibility

Prior to termination of the Plan, participation in the Plan was available to all eligible employees of the Sponsor who had attained 18 years of age and completed 90 days of employment, as defined by the Plan (excluding independent contractors, nonresident aliens, and employees covered by a collective bargaining agreement as defined by the Plan), and any employee who had entered the Hendry Marine Industries, LLC Profit Sharing Plan (the "Profit Sharing Plan") on or before January 1, 2015. A participant would share in the allocation of contributions and forfeitures if they were still employed on the last day of the Plan year and had accumulated 1,000 or more hours of service during the Plan year.

Employer Contributions

Prior to termination of the Plan, the Sponsor was obligated to make contributions in cash to the Plan, which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Prior to termination of the Plan, each participant's account was credited as of the last day of each Plan year with an allocation of shares of the Sponsor's convertible preferred stock released from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who were eligible employees of the Sponsor as of the last day of the Plan year would receive an allocation. Allocations were based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings/losses are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

Vesting

Prior to termination of the Plan, if a participant's employment with the Sponsor ended for any reason other than disability or death, he or she would vest in the balances in his or her account based on total years of service with the Sponsor. Participants vested 20% per year of service after completion of two years of service and were 100% vested after six years of creditable service. For those participants with at least three years of service as of December 31, 2014, those participants vested 20% per year of service after completion of one year of service and were 100% vested after five years of creditable service. As a result of the Plan termination, all participants with an account balance in the Plan as of May 12, 2023 became 100% vested on such date.

Payment of Benefits

All distributions are to be made in cash. Prior to termination of the Plan, no distribution from the Plan would be made until a participant separated from service with the Sponsor or reached normal retirement age, as defined as 65 years of age. Distributions due to separation because of death (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), disability, or after attaining normal retirement age, would commence during the Plan year which followed the Plan year in which a participant separated from service. Vested account balances with a minimum value of \$5,000 or less were distributed in a lump sum during the Plan year following the Plan year of separation. Vested accounts greater than \$5,000 were distributed in annual installment payments not to exceed five years. Distributions of benefits for separation from service

with the Sponsor for reasons other than death, disability, or retirement were made as follows: for vested accounts greater than \$5,000, if the participant was not reemployed before the end of the 5th Plan year following the Plan year in which separation from service occurred, distribution of benefits would commence during the 6th Plan year following the Plan year of separation. Distribution of benefits would be made in substantially equal annual installments over a period of five years. For vested accounts less than or equal to \$5,000, distribution would be made after the close of the Plan year in which employment terminates.

Prior to termination of the Plan, as of the end of any Plan year in which a participant who had terminated employment with the Sponsor had shares of Sponsor stock in his account, after all allocation of Sponsor contributions, forfeitures, dividends, and earnings had been made, the Administrator exchanged any cash or other liquid assets held in the accounts of active participants for shares of the Sponsor stock held in the terminated participants' accounts at an exchange rate determined based on the appraised fair market value of the Sponsor stock. In the event that there is not sufficient cash or other liquid assets in the active participants' accounts to exchange for all of the shares of Sponsor stock in the terminated participants' accounts, the exchange would be pro rata based upon the terminated participants' accounts.

Prior to termination of the Plan, under the provisions of the Plan, the Plan was obligated to repurchase participant shares which had been distributed under the terms of the Plan as long as the shares were not publicly traded or if the shares were subject to trading limitations.

Voting Rights

Prior to termination of the Plan, all Sponsor common shares held by the trust should be voted by the Trustee in accordance with instructions from the Committee. Notwithstanding the foregoing, participants and/or beneficiaries should be entitled to direct the voting of any voting shares allocated to their Sponsor stock accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation. In accordance with instructions from the Committee, the Trustee should vote any unallocated shares held by the trust, as well as any allocated shares for which a participant has failed to give timely voting direction.

Diversification

Prior to termination of the Plan, diversification was offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Sponsor convertible preferred stock into investments which are more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification was offered to each eligible participant over a five-year period. In each of the first four years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the fifth year, the percentage changed to 50%. Participants who elected to diversify can elect to receive a cash distribution or transfer such amount to the Sponsor's 401(k) Plan.

Forfeitures

Prior to termination of the Plan, a terminated participant's nonvested account balance was deemed to be forfeited on the last day of the Plan year in which such participant has incurred five consecutive one year breaks in service. Upon forfeiture, employer contributions and Plan forfeitures would be allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. As of December 31, 2024 and 2023, the Plan had a forfeiture balance of \$0 and \$2,965, respectively.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Sponsor. The Trustee has historically paid substantially all operating expenses of the Plan. Fees relative to custodial, recordkeeping, and valuation services are paid by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the termination of the Plan, the accompanying financial statements have been prepared in accordance with the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of income and expenses during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefit payments to participants are recorded when paid.

4. ADMINISTRATION OF PLAN ASSETS

The Plan's assets are held by the Trustee. Sponsor contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

5. SPONSOR DIVIDENDS

The Sponsor owed dividends to the Plan totaling \$651,701 during the year ended December 31, 2021. Of this total as of December 31, 2021, \$352,723 of the dividends on allocated shares and \$298,978 of the dividends on unallocated shares were used to fund debt service. At December 31, 2022, \$207,901 of this amount was included as a receivable on the accompanying statements of net assets available for benefits (liquidation). In 2023, lost earnings of approximately \$30,900 were

calculated on these dividends that were reported in dividends in the statement of changes in net assets available for benefits (liquidation) and included in the dividend receivable of \$238,753 at December 31, 2023. During 2024, these funds were remitted into the Plan.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Prior to termination of the Plan, the Plan invested in Sponsor convertible preferred stock and had indebtedness guaranteed by the Sponsor. These were related party and party-in-interest transactions. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

Apex Pensions provides record keeping services for the Plan and, therefore, qualifies as a party-in-interest.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan.

During the years ended December 31, 2024 and 2023, the Plan paid fees for fiduciary services and/or valuation services that amounted to \$42,360 and \$60,139, respectively.

7. TAX STATUS

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated July 19, 2016 stating that the Plan is qualified under the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the date of the financial statements. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

The Plan was terminated as of May 12, 2023, subject to the provisions of ERISA. Account balances in the Plan were not yet distributed as of December 31, 2024.

9. SUBSEQUENT EVENTS

The Company has evaluated subsequent events and transactions through September 17, 2025, the date on which the financial statements were available to be issued.
