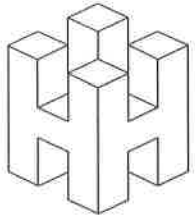

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of KEANE THUMMEL TRUCKING, INC. 401(K) PROFIT SHARING PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The following description of the Keane Thummel Trucking, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of Keane Thummel Trucking, Inc. (the Employer), who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Each year, participants may contribute up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of all contributions into various investment options offered by the Plan. The employer contribution to the Plan is determined by the Employer each pay period and is discretionary.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Employer's discretionary contributions, as well as an allocation of the Plan's earnings and participant forfeitures, and charged with withdrawals and an allocation of Plan losses and investment expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus any actual earnings accrued thereon. Vesting in the Employer's contribution portion of their accounts is based on continuous years of service. A participant is 100 percent vested after six years of service.

Notes Receivable from Participants - Participants may borrow from their participant account balance, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant will become fully vested automatically. A participant with a vested balance less than \$7,000 may elect to receive a lump sum distribution. A participant with a vested balance in excess of \$7,000 may elect to receive their distribution in any form allowed by the Plan.

Recent Legislative Update - On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms introduced with the 2019 SECURE Act, focusing on increasing participation in the retirement system and facilitating the accumulation of more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan follows accounting standards set by the Financial Accounting Standards Board, commonly referred to as the FASB. The FASB sets generally accepted accounting principles (GAAP) that the Plan follows to ensure the Plan consistently reports its net assets and changes in net assets available for benefits. References to GAAP issued by the FASB in these footnotes are to the FASB *Accounting Standards Codification*, sometimes referred to as the Codification or ASC.

The following are the significant accounting policies followed by the Plan:

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan utilizes various investment instruments, including mutual funds and money markets. Investment securities are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition - The Plan's investments in mutual funds and money markets are stated at fair value based on quoted market prices. Net appreciation in the fair value of investments is based on the fair value of investments at the beginning of the year, or cost, if purchased during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

Excess Deferrals Due to Participants - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed any 2024 excess contributions to the applicable participants prior to March 15, 2025.

Voluntary Withdrawals - Participants may apply for a hardship withdrawal for reasons stipulated in the Plan document. While an employee is employed by the employer, they may withdraw the amount of elective deferrals and vested employer discretionary contributions credited to their account with written consent from the plan administrator.

Payment of Benefits - Benefit payments are recorded when paid.

Administrative Expenses - Administrative expenses of the Plan are paid by Plan assets. Investment related expenses are included in net appreciation of fair value of investments. The Plan paid recordkeeping and administrative service expenses totaling \$57,688 for the year ended December 31, 2024.

Note 3 - INVESTMENTS (UNAUDITED)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from The Security National Bank of Sioux City, Iowa and Charles Schwab Trust Bank, the trustees of the Plan that all of the information is complete and accurate. Information included in the accompanying financial statements as to investments, investment income, and all information in the supplemental schedule is presented in reliance solely upon those certifications.

Fair Value Measurement - FASB Accounting Standards Codification 820 defines fair value, establishes a framework for measuring fair value in generally accepted accounting principles and establishes a hierarchy that categorizes and prioritizes the factors to be used to estimate fair value. The factors are prioritized as follows:

- * Level 1 - Quoted prices in active markets for identical assets or liabilities.
- * Level 2 - Factors other than Level 1 that are observable, either directly or indirectly, such as outside comparable sales.
- * Level 3 - Unobservable factors that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The assets or liabilities fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money Market: Valued at the daily unadjusted quoted price.

Mutual Funds: Valued at the daily closing price as reported by the fund.

Self-Directed: Valued at the closing price reported on the active market on which the individual securities are traded.

Note 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 5 - TRANSACTIONS WITH PARTIES IN INTEREST

The Plan pays several vendors for record keeping, administrative services, claims processing, custodianship of its investments, benefit consulting services, legal services, and audit services. Transactions with the providers of these services would be considered to be transactions with parties in interest. Furthermore, the Plan receives contributions from the participants' employers, and these contributions would also constitute transactions with parties in interest.

Note 6 - FEDERAL INCOME TAX STATUS

The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The administrator has concluded that any uncertain tax positions would be immaterial to the financial statements taken as a whole. Accordingly, the accompanying financial statements do not include any provision for uncertain tax positions, and no related interest or penalties have been recorded in the statement of changes in net assets available for benefits or accrued in the statement of net assets available for benefits.

Note 7 - TERMINATED PARTICIPANTS

Account balances allocated to terminated participants that had not been paid as of December 31, 2024 and 2023 totaled \$898,831 and \$528,310, respectively. These amounts represent the vested account balances of terminated participants that had not been paid by year end. For financial statement purposes, these amounts are included in net assets available for benefits.

Note 8 - SUBSEQUENT EVENTS

In preparing the financial statements, the Plan has evaluated all subsequent events, for potential recognition or disclosure, through October 8, 2025, the date the financial statements were available to be issued.
