

Changes in non-prescribed assumptions

For the calculation of 2024 minimum funding requirement, the following assumption changes were made to better reflect anticipated experience:

The assumed projected interest crediting rate was changed from 4.94% (the interest crediting rate for the 2024 plan year) to 3.04% (the average of the interest crediting rates for the immediate continuous 5-year span prior to the valuation date).
