Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Twin City Fan Retirement Savings Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTE 1 - PLAN DESCRIPTION

The following description of Twin City Fan Retirement Savings Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, effective January 1, 1976, covering all full-time employees of Twin City Fan Companies, Ltd. (the "Company") who have completed two consecutive months of employment, beginning on the date the first hour of service is performed, and are age 18 or older. Employees may enter the Plan on the first of the month after satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 75% of their annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 75% of their annual eligible compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make matching contributions at a rate determined by the administrative committee prior to the beginning of the plan year. For both of the years ended December 31, 2024 and 2023, 50% of the first 6% of compensation deferred by the participant was matched by the Company. Employees are eligible for matching contributions upon entry into the Plan. Matching employer contributions were \$1,786,648 and \$1,478,736 for the years ended December 31, 2024 and 2023, respectively.

The Company may make annual discretionary contributions. Participants who have completed 12 months of service and 1,000 hours of eligible service will be eligible to receive an allocation of the company discretionary contribution. During the years ended December 31, 2024 and 2023, the Company made no annual discretionary contributions.

Newly eligible employees who do not affirmatively elect to have a specific deferral percentage contributed or opt out of deferring into the Plan will automatically have 3% of their eligible compensation deferred into the Plan, increasing 1% annually to a maximum of 10%. Effective January 1, 2024, the Plan was amended to change the maximum automatic deferral percentage from 10% to 15%.

On January 1 of each year, employees who previously opted out of deferring into the Plan or elected to defer less than 3% of their annual eligible compensation will automatically reenroll at 3% of their annual eligible compensation and be subject to the automatic contribution increases. Employees may request to increase, decrease, or discontinue elective contributions at any time following reenrollment.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with plan losses and an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan and may transfer assets in their accounts between funds on a daily basis.

Vesting

Participants are immediately 100% vested in employee salary and rollover contributions and any income or loss thereon.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. The notes receivable are secured by the balance in the participant's account and interest will be fixed at inception at the prevailing prime rate on the first day of the month at the time the loan is made. Principal and interest are paid ratably through monthly payroll deductions. Upon termination of a participant from employment, the note will be due in full.

Benefit Payments

On termination of service due to death, disability, retirement, or termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited accounted balances totaled \$1,374 and \$1,766,

respectively. The Plan used \$112,664 and \$70,632 for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions.

Related Party and Party-in-interest Transactions

Certain plan assets are in investment funds managed by Empower or its affiliates. Empower is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

During 2022, a certain nonexempt transaction with a party-in-interest occurred when the Company erroneously contributed funds to the Plan for a participant who no longer participated in the Plan. The Company requested the funds be returned to the Company instead of forfeiting the excess employer contribution. The Company reimbursed the Plan for the reported amount and related lost earnings during the year ended December 31, 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100% vested in their account balances, including any discretionary employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 4, Fair Value Measurements, for details on inputs, valuation techniques, and fair value measurement level within the fair value hierarchy. Purchases and sales of securities on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation (depreciation) in fair value of investments included in the accompanying statements of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation (depreciation) in fair value of investments. Net unrealized appreciation (depreciation) in fair value of investments represents the net change in the fair value of the investments

held during the year. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the year, or the cost of the investment if purchased during the year.

Risks or Uncertainties

The Plan provides for investment in a variety of investment funds. Investments are subject to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. There was no allowance for credit losses recorded as of December 31, 2024 and 2023.

Benefits to Participants

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan Sponsor, except for contract administration fees, which are paid by the Plan.

NOTE 3 - CERTIFIED INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee or Custodian, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4(i) - schedules of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan follows U.S. GAAP for measuring, reporting, and disclosing fair value. These standards apply to all assets and liabilities that are measured, reported, and/or disclosed on a fair value basis. As defined in the accounting standards, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Assets and liabilities measured, reported and/or disclosed at fair value will be classified and disclosed in one of the following three categories:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds – Shares of interest in the collective trust funds are valued at fair value as reported by the investment manager at year end, using NAV as a practical expedient.

Guaranteed interest account - The guaranteed interest account provides a guaranteed interest rate for a specified period of time as determined, or allowed, by the Plan. The underlying assets of the accounts consist principally of group annuity contracts invested in fixed income securities, intermediate term bonds, and commercial mortgages.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The tables below present the balances of assets measured at fair value on a recurring basis by level within the hierarchy:

NOTE 5 - TAX STATUS

The Plan adopted the Empower Retirement, LLC prototype plan. The prototype plan obtained its latest opinion letter on September 16, 2022, in which the Internal Revenue Service (“IRS”) stated that the underlying prototype plan document was designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
