To the Participants and Plan Administrator of the

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements
December 31, 2024 and 2023

1. Description of Plan

The following description of the Continental Micronesia, Inc. 401(k) Savings Plan (the Plan) provides general information about the Plan's provisions. More complete information about the Plan Document, vesting, and benefit provisions is contained in the Summary Plan Description, a copy of which is available from United Airlines, Inc. (United or the Company).

General

The Plan is a defined contribution plan covering all employees of the Company other than pilots based in Guam and the Commonwealth of the Northern Mariana Islands. Employees are eligible to become participants on their date of hire (and upon completing flight attendant training, if applicable). Continental Micronesia, Inc. merged into United Airlines, Inc. as of 11:59 p.m. EST on March 31, 2017, with the surviving entity renamed United Airlines, Inc. As such, United Airlines, Inc. is now the Plan Sponsor. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Trustee and Record Keeper

ASC Trust, LLC (ASC or Trustee) is the Plan's trustee and record keeper.

Employee Contributions

Participants may elect to make voluntary pre-tax, Roth 401(k) and/or post-tax contributions to the Plan. A participant may elect to contribute 1% to 100% - in increments of 1% - of eligible earnings for a Plan year subject to limitations under the Internal Revenue Code (the Code). A one-time post-tax contribution during an open window at the end of the year may also be made. Participants who are or will attain the age 50 or older before the close of the calendar year are eligible to make catch-up contributions in accordance with Section 414(v) of the Code.

Participants may elect to roll over amounts into the Plan from certain other qualified employer plans or a qualified Individual Retirement Account (IRA).

Employer Contributions

United makes matching and/or direct contributions by employee category, as follows:

- *Fleet Service Employees, Passenger Service Employees and Storekeepers (IAM)* - Subject to the limitations and conditions of the Plan and collective bargaining agreement, United will make Employer Matching Contributions equal to the greater of 100% of the participant's pre-tax and Roth 401(k) contributions up to a maximum of \$300 or the amount determined based on the participant's employee contributions and years of service. For participants with more than five years of service, the contribution percentage ranges from a maximum match of 1% to 3% of eligible earnings.

1. Description of Plan, continued

Employer Contributions, continued

- *Flight Attendants (AFA)* - Subject to the limitations and conditions of the Plan and collective bargaining agreement, United will make Employer Matching Contributions equal to 100% of the participant's pre-tax and Roth 401(k) contributions up to 3% of eligible earnings for all pre-merger United Flight Attendants and newly hired or rehired flight attendants. In addition, United will make Employer Direct Contributions equal to 5% of eligible earnings. For pre-merger Continental and CMI Flight Attendants, United will make Employer Matching Contributions equal to the greater of 100% of the participant's pre-tax and Roth 401(k) contributions up to a maximum of \$300 or the amount determined based on the participant's employee contributions and years of service. The contribution percentage ranges from a maximum match of 0.75% to 3.00% of eligible earnings.
- *Management & Administrative Employees* - Subject to the limitations and conditions of the Plan, United will make Employer Matching Contributions equal to 100% of the participant's pre-tax and Roth 401(k) contributions up to a maximum of \$300 (\$750 if their original date of hire is before January 1, 2004) for participant's with less than five years of service. For participants with more than five years of service, United will make Employer Matching Contributions equal to the greater of 100% of their pre-tax and Roth 401(k) contributions up to a maximum of \$300, or the amount determined based on the participant's employee contributions and years of service. The contribution percentage ranges from a maximum match of 1% to 3% of eligible earnings. In addition, United will make a CMI Fixed Employer Contributions equal to 3% of a participant's eligible earnings.
- *Technician and Related Participants (IBT)* - Subject to the limitations and conditions of the Plan and collective bargaining agreement, United will make Employer Matching Contributions equal to the greater of 100% of the participant's pre-tax and Roth 401(k) contributions up to a maximum of \$300, or the amount determined based on the participant's employee contributions and years of service. The contribution percentage ranges from a maximum match of 0.75% to 3.00% of eligible earnings.
- Effective May 22, 2023, Maintenance Planners are covered by a collective bargaining agreement with the IBT. Subject to the limitations and conditions of the Plan and collective bargaining agreement, United will make Employer Matching Contributions equal to 100% of the participant's pre-tax and Roth 401(k) contributions up to 4% of eligible earnings. In addition, United will make Employer Direct Contributions equal to 4% of eligible earnings. Participants are always 100% vested in their Employer Matching Contributions. Employer Direct Contributions will be on a three-year vesting schedule beginning with 33% vested after the first year of service and increasing in 33% increments thereafter. Participants will be 100% vested after their third year of service, upon death, attainment of age 65 while employed by United or an Affiliate.

Vesting

Participants are 100% vested in the value of their pre-tax, Roth 401(k), post-tax and rollover contributions to the Plan. The vesting schedule for employer contributions by employment category is as follows:

- *Fleet Service Employees, Passenger Service Employees and Storekeepers (IAM)* - Participants are always 100% vested in their Employer Matching Contributions.

1. Description of Plan, continued

Vesting, continued

- *Flight Attendants (AFA)* - Pre-merger United flight attendants employed as of January 1, 2006 are 100% vested in their Employer Matching Contributions and Employer Direct Contributions. Pre-merger United flight attendants hired after January 1, 2006, as well as Flight Attendants hired or rehired on or after August 12, 2016, will be on a three-year vesting schedule beginning with 33% vested after the first year of service and increasing in 33% increments thereafter.. Participants will be 100% vested after their third year of service, upon death, or attainment of age 65 while employed by United or an Affiliate. Pre-merger Continental and CMI Flight Attendants are 100% vested in their Employer Matching Contributions.
- *Management & Administrative Employees* - Participants are always 100% vested in their Employer Matching Contributions. In addition, participants will be 100% vested in their CMI Fixed Employer Contributions subsequent to their third year of service, upon death or disability, attainment of age 65 while employed by the Company or an Affiliate, or if they participated in an eligible voluntary separation program with a separation date of November 30, 2020.
- *Technician and Related Participants (IBT)*- Participants are always 100% vested in their Employer Matching Contributions.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are first applied to pay Plan expenses and then applied to restore forfeited amounts of participants who terminated employment and later resumed employment in accordance with the "Restoration of Forfeited Amounts Section" of the Plan, with the remaining balance if any, applied to reduce employer contributions, and any further remaining balance reallocated to participants in proportion to their compensation. Unallocated forfeited balance As of December 31, 2024 and 2023 was \$9,883 and \$188, respectively.

Investment Funds

Upon enrollment in the Plan, participants may direct their contributions and any employer contributions to any of the Plan's designated investment options. If a participant fails to make an investment election, his or her accounts shall be invested in the default fund designated by the Investment Committee.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with contributions and Plan earnings, and charged with withdrawals, an allocation of Plan losses and administrative fees. Allocations are based on account balances, as defined by the Plan. Each participant is entitled to the benefit that can be provided from the participant's vested account.

Participant Loans

Generally, participants may borrow up to 50% of their account balance (excluding certain sub-accounts) and subject to a minimum amount of \$1,000 and a maximum amount of \$50,000. While the repayment period for a general-purpose loan is usually 12 to 60 months, the maximum repayment period maybe up to 120 months if the loan is for

the purchase of a principal residence. The Plan allows a participant to have up to two loans outstanding at any one time, but only one of such loans may be a principal residence loan.

Payment of Benefits

Participants who have separated from service may elect payment in the form receive an amount equal to the vested value of his or her account in a lump-sum, installments or annuity. In-service withdrawals for participants who are employed by United depend on the types of contributions withdrawn, the reason for the withdrawal, and age at time of withdrawal. The Plan allows in-service withdrawals of post-tax contributions (and the earnings thereon), complete or partial withdrawals by participants who have attained age 59½ (62 for certain sources), qualified reservist withdrawals, and financial hardship withdrawals subject to restrictions described in Plan agreements.

A participant who received a coronavirus-related distribution is permitted, at any time during the three-year period beginning the day after the date of the coronavirus-related distribution, to recontribute any portion of that distribution, but not an amount in excess of the distribution, to the Plan. Any such recontribution shall be treated as rollover contributions.

Subsequent Events

Management evaluated subsequent events for the Plan through October 1, 2025 the date the financial statements were available to be issued.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosure related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies, continued

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

3. Information Certified by the Trustee

The Plan administrator has elected the method of reporting permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from ASC Trust, LLC, the trustee, that the following data included in the accompanying financial statements and schedules is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held at end of year as of December 31, 2024 and 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and schedules.

4. Fair Value Measurements

U.S. GAAP includes a fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). This hierarchy requires entities to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan. There have been no changes in valuation methodologies at December 31, 2024:

Mutual Funds: The mutual fund investments are valued at the NAV of shares held by the Plan at year end which are quoted in an active market, and are classified within level 1 of the valuation hierarchy.

Stable Value Trust Funds: The stable value fund investments are valued at their NAV as calculated at year end by the fund's manager. The stable value funds provide investment management expertise with the objective of maximizing current income consistent with the maintenance of principal and providing withdrawals for certain participant initiated transactions without penalty or adjustment. The price of and income generated by securities held directly and indirectly by the various collective trusts may decline in response to certain events, including those directly involving the issuers whose securities are owned by the trusts; general economic and market conditions; regional or global economic instability; and currency and interest rate fluctuations. This fund is primarily invested in

guaranteed investment contracts and synthetic investment contracts. Participant-directed redemptions have no restrictions; however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to several risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated April 30, 2014, stating that the Plan is qualified under Section 401(a) of the Code, and the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination of the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Administrative Fees and Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

8. Plan Termination

Although it has not expressed any such intent, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.
